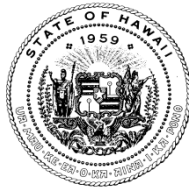

**H.B. 480, H.D. 1**  
**RELATING TO HIGHWAY SAFETY**

Senate Committee on Transportation and Culture and the Arts

The Department of Transportation (DOT) would like to **provide comments** regarding H.B. 480, H.D. 1 which defines special interest vehicles as vehicles that are at least 35 years old, or vehicles modified to resemble vehicles that are at least 35 years old.

The DOT recommends the definition of special interest vehicle be better defined. The DOT also recommends a committee be formed with the four counties comprised of representatives from Motor Vehicle Registration and the Periodic Motor Vehicle Inspection Program to better define special interest vehicles and its requirements.
