SENATE BILL NO. 1585 RELATING TO ANIMAL AGRICULTURE

Chairpersons Gabbard and Members of the Committee:

Thank you for the opportunity to testify on Senate Bill1585. The bill prohibits new operations and renewal of existing licenses or permits to operate large, concentrated animal feeding operations in the State, under certain conditions and by an unspecified date. Phases out all existing large, concentrated animal feeding operations (CAFO) by 7/1/2028. The department offers comments.

Senate Bill1585 uses title 40 CFR section 122.23(b)(4) definition of large, concentrated animal feeding operations. The department is not sure if that definition would affect current animal agriculture operations. Although the total number of various species of animals is listed to define a CAFO, there are provisions in 40 CFR 122.23 that include situations where any water passing over or through a property with animals may render an operation a CAFO.

My name is Scott Enright, on behalf of Villa Rose and "Waialua Fresh" I strongly oppose SB1585. Villa Rose owns and operates an active chicken egg farm in Waialua, Hawaii. Its egg producing chickens are housed in a state of the art solar powered egg farm where they are packed and sold locally under the "Waialua Fresh" brand name. Villa Rose is one of the largest new agricultural projects in the state of Hawaii and has made a substantial local investment to bring locally grown, fresh eggs to the local market. The demand for fresh Waialua eggs has been so great that it has caused an acceleration in growth thus increasing local food production and decreasing the dependance on imported mainland eggs. On behalf of the Hawaiian Humane Society, thank you for considering our support for Senate Bill 1585, which prohibits new operations and renewal of existing licenses or permits to operate large concentrated animal feeding operations (CAFOs) in the State, under certain conditions and by an unspecified date. It phases out all existing large concentrated animal feeding operations by 7/1/2028.

The Hawaiian Humane Society supports the enforcement and strengthening of laws and the implementation of humane standards for animals in every phase of animal-based food production. We oppose "factory farming" and any other practice that does not treat the welfare of animals as a priority.

My name is Micah Munekata, and I am the Director of Government Affairs at Ulupono Initiative. We are a Hawai'i-focused impact investing firm that strives to improve the quality of life throughout the islands by helping our communities become more resilient and self-sufficient through locally produced food, renewable energy and clean transportation choices, and better management of freshwater resources.

Ulupono opposes SB 1585, which prohibits new operations and renewal of existing licenses or permits to operate large concentrated animal feeding operations (CAFO) in the State, under certain conditions and by an unspecified date, and phases out all existing large concentrated animal feeding operations by 7/1/2028.

Ulupono supports the State's efforts to increase food import replacements while building towards the goal to double local food production. This bill seeks to prohibit any new CAFO, or renewal of existing CAFOs, from operating in Hawai'i. It is important to note that there are extensive environmental regulations that exist in order to operate at a CAFO level, including Environmental Assessments (EA) and Environmental Impact Statements (EIS). We believe that animal agriculture operations should each be judged on their own merits rather than effectively outlawing an entire class of operations that could help feed Hawai'i. Furthermore, it is strikingly inconsistent to outlaw CAFOs in Hawai'i at the same time our state imports nearly all its meat, dairy, and eggs from CAFOs on the mainland.

In addition, we are aware of at least one CAFO, as per the definition within this measure, that has invested tens of millions of dollars into state-of-the-art infrastructure to support local production efforts in our state. A bill such as this would essentially shut down this business and undoubtedly lead to a lengthy legal process over a legislative taking.

Our state continues to import nearly 90% of our food. We must consider the ramifications to our food production and self-sufficiency goals, when prohibiting any food production operation that abides by our current laws.

My name is Joseph Realdine. I am a retired USDA-FSIS CSO/FLS/RIFS with the Office of Field Operations and the Office of International Affairs.

Several months ago, I was asked to consult a local food producer who was interested in the culled hens from the Villa Rose CAFO operations in Wahiawa.

During my visit to Villa Rose, I was greeted by Mr. Michael Sencer, the Senior Vice President for Villa Rose. Having been around farms my entire career, I am aware of the waste generated by Concentrated Animal Feeding Operations. Having read the brochure that Villa Rose marketed, I was originally optimistic about how they said they were handling their manure and other waste streams in Hawaii's environment. I was hopeful that Villa Rose was different than the mainland CAFOs that I am familiar with.

When I arrived for the walk through, I asked about the bio-char and was informed by Mr. Sencer, that Villa Rose didn't use the biochar because the manure was too wet and too plentiful to use bio-char. I asked Mr. Sencer if there were EPA regulations for the use of the biochar and was informed that the EPA has no oversight since the biochar unit is a "mobile" unit. When I asked Mr. Sencer about what happens with the wastewater, Mr. Sencer informed me that the wastewater from operations along with the human waste from the toilets across the operations are sent to a tank and pumped on to a 14-acre field on the property. Overall, Mr. Sencer seemed to treat these issues waste stream issues as unimportant. I was shocked to learn that there was no state or county oversight or monitoring of the waste that was being generated by their CAFO operations.

Having lived and worked in Hawaii for many years, I know how the importance of taking care of our Aina and our ocean. It is hard to believe that a Concentrated Animal Feeding Operation can open up in our fragile environment without any overview or environmental impact study.

I would also like to bring to the attention of this committee a dangerous risk posed by bio-char.

Bio-char in itself is not the cure for the waste products produced by this CAFO. The fine ash associated with Bio-char is the perfect source for dust, posing a risk for respiratory diseases.

Everything that I have done in my 30 plus years in food safety and working with ranchers must be based on supporting documentation.

I was trained by the Federal Government to always review supporting documentation in order to form an agency supportable position. In this case, while retired from Federal service, I have not come across any supporting documentation provided by this CAFO with respect to their operation. I would like to submit the document written by Danielle L. Gelardi, Chongyang Li, Sanjai J. Parikh * University of California Davis, Land, Air and Water Resources, One Shields Ave., Davis, CA 95616, United States of America, to the committee. In part it states the following:

"PM10 exposure is a public safety concern as it can bypass the body's particulate interception mechanisms and penetrate deep into the airways. PM10 inhalation has been associated with increased chronic respiratory symptoms and the worsening of lung and heart disease (United States Environmental Protection Agency. 2017). Exposure to both the organic and inorganic components from agricultural PM10 have been linked with these adverse health effects in farmworkers (Schenker, 2000; Schenker et al. 2009, 2005). While there are chemical, physical, and end-use distinctions between biochar and other carbonaceous materials such as coal, there are many chemical and physical similarities (Lehmann and Joseph 2015). These similarities, and what is well known about the linkages between coal inhalation and chronic heart, kidney, and respiratory disease (Castranova and Vallyathan 2000; Graber et al. 2014; Hendryx 2009; Hendryx and Zullig 2009; Santo Tomas 2011), call for further investigation into airborne emissions from biochar-amended soils. With the growing interest in biochar as a soil amendment comes an imperative to better understand potential consequences for air quality, and how these might affect agricultural workers and neighboring farm communities. While the physical size of biochar-related PM10 is itself a serious concern, the organic and inorganic chemical constituents of biochar may also present a human health risk. The primary aim of this review is to highlight the emerging environmental concern of biocharinduced dust emissions by evaluating the limited literature currently available. In addition, solutions to minimize potential harm during biochar production and application are synthesized, and areas for future investigation are suggested".

As someone who suffers from Kidney disease as mentioned in the above article, is this what I expect to have here in Hawaii? Having a CAFO producing PM 10 unnecessary risks to not only the human population, but to the environment as well.

If you remove Bio-char from the solution to the waste, you are left with what? Basically, a big mess.

The public must be protected at all times.

I live on the North Shore and am also aware of how runoff from this CAFO could impact our North Shore and the communities that call this side of the island home.

Hawaii we can do better here. With the above in mind, I am in full support of SB1585 to ensure that our communities and environment are protected at all times.

Some common concerns around CAFO's include, but are not limited to: 1 2 3

CAFOs produce huge amounts of animal sewage and other pollutants:

- The amount of urine and feces produced by the smallest CAFO is equivalent to the quantity of urine and feces produced by 16,000 humans.
- CAFO waste is usually not treated to reduce disease-causing pathogens, nor to remove chemicals, pharmaceuticals, heavy metals, or other pollutants.
- Over 168 gases are emitted from CAFO waste, including hazardous chemicals such as ammonia, hydrogen sulfide, and methane.
- Airborne particulate matter is found near CAFOs and can carry disease-causing bacteria, fungus, or other pathogens.
- Animals frequently die in CAFOs. Their carcasses, often in large numbers, must be dealt with
- Infestations of flies, rats, and other vermin are commonplace around CAFOs and therefore around CAFO neighbors.

Water pollution is possible at virtually any point in a CAFO's operation:

- In the production area, spills, overflows, and tracking of wastes on tractor and truck tires can cause surface runoff of contaminants.
- <u>Stormwater</u> that mixes with manure wastes, silage leachate, or milkhouse wastes can flow into drains.
- Pipes or hoses carrying wastes can break or become unattached. Waste storage structures can overflow or burst.

Villa Rose LLC submits the following comments in opposition to SB 1585. Villa Rose LLC owns and operates an active chicken egg farm in Waialua, HI. Its egg producing chickens are housed at a solar powered egg farm where they are packed and sold locally under the "Waialua Fresh" brand name. The company currently employs 56 people locally and has invested over 70 million to date.

- 1. As proposed, phasing out existing CAFOs could constitute a regulatory taking under the United States Constitution. The state of Hawaii would need to potentially set aside hundreds of millions of dollars to compensate the owners of existing CAFOs and agricultural land owners fair market value for their loss.
- 2. As one of the largest new agricultural projects in the state, we have made a substantial local investment to bring locally grown, fresh eggs to market. We have found the demand for our local product has expedited our plans for growth, increasing local food production, and decreasing the dependence on mainland for the residents of the state. We are currently working with local farmers regarding the production of row crops for animal feed. This bill is a major step backward to that growth and a major boost to the state's dependency on mainland for its food supply. The cost of imported food is more expensive than locally produced food. The management of CAFOs can provide significant benefits to the agricultural community and further reduce the dependency on mainland products, like fertilizer for our crops. Banning CAFOs would result in a loss of jobs for local residents.
- 3. Villa Rose is working closely with the Hawaii Department of Health to safely manage the wastewater and manure produced by the egg laying birds at its ranch. The state already has laws in place to manage the handling of wastewater and fertilizer. Working with farmers to ensure the waste products are cared for properly is beneficial to the general community and to the agricultural community as well, by lowering their cost and increasing their effectiveness in increasing food production for the state. Big Island Dairy mishandled their waste management system. Big Island



Dairy had to close their operation because they failed to comply with local, state, and federal regulations. They should not become the standard for which all animal care facilities are judged.

4. The primary beneficiaries from this bill are producers and distributors of food items from the mainland.

This testimony is in opposition and we ask that you defer this bill.

The Hawaii Cattlemen's Council supports all types of agriculture when done in a manner that is safe for the animals, the community, and the environment. BACKGROUND

HFA is Hawaii's largest handler of highly perishable products from farm or manufacturer to every grocer, club, and retailer across the state of Hawaii. In addition, HFA provides the cold-chain logistics for over 38 LOCAL FARMS and PRODUCERS to move their products from source to grocers, clubs, and retailers across the state and export to the continental US. I employ over 540 staff members dedicated to keeping Hawaii fed.

I recently purchased all of the assets of the former Big Island Dairy (BID) in O'okala. Big Island Dairy was a mainland owned, concentrated animal feeding operation (CAFO) that showed our state how dangerous and destructive concentrated animal feeding operations are to Hawaii's environment and residents when BID repeatedly sent toxic waste down the sacred slopes of Mauna Kea into the town and homes of the residents of O'okala. After repeatedly damaging the O'okala ecosystem and homes, the rivers of toxic waste entered the ocean where our families surf, fish, and recreate as a way of life. Having witnessed the catastrophe in O'okala first hand, I purchased the assets to help ensure that a large dairy CAFO would never operate in this location again. We are currently working to diversify this operation to produce local food, value-added services for other farmers and meaningful jobs to those in the surrounding communities - all in a manner that honors this special place and in harmony with Hawaii's fragile environment.

THREAT TO AQUIFERS AND OCEAN

The potential harm that large dairy and egg laying CAFO's are capable of far outweigh any limited benefit when considering Hawaii's fragile environment and delicate eco-systems. The topography and volcanic soil, of our islands, virtually guarantee that the concentrated pollutants generated by large dairy and egg laying operations end up in our aquifers or flowing to our coastlines and surrounding waters.

HEALTH RISKS & VOLUME OF POLLUTANTS

These pollutants can contain pathogenic microorganisms including bacteria, fungi, viruses and parasitic protozoa, and helminthes; antibiotics and pathogenic microbes with antibiotic-resistant genes and heavy metals. Among the bacteria detected in these waste streams, and sometimes its compost, are E. coli, Salmonella, Staphyloccocus, Campylobacter, Clostridium, Listeria, Bordetalla, Corynebacterium, Globicatella, Mycobacterium, Streptococcus, and Actinobacillus, all of which can severely impact human health and the environment.

With the above considered, it should cause great concern that Villa Rose, another large mainland owned CAFO is actively working to expand their current egg laying operations to house <u>one million laying hens</u> in Wahiawa.

An egg laying CAFO of this magnitude produces the following approximated waste streams:

- ◆ 250,000 pounds of manure per DAY
- ◆ 20,000 hens culled per WEEK to replace with new hens
- ♦ 6,000 pounds of broken egg production (in-edibles) per WEEK
- ♦ And several million gallons of wastewater used to clean operations

The waste streams listed above are equivalent to a town of 200,000 people. If a developer wanted to build a complex to hold 200,000 people in this same location, the developer would typically be required to conduct a full Environmental Impact Study (EIS) and obtain a series of permits, conduct public hearings, and clear multiple other hurdles to ensure that everything, especially the sewage, and waste streams, were in order and in harmony with the environment and communities that could potentially be impacted by the development. It seems Villa Rose CAFO never underwent any of this process - including NOT having to perform a full Environmental Impact Study. They were simply able to do this because Hawaii does not have laws requiring the controls necessary to address CAFO operations.

THREAT TO NORTH SHORE

To make this situation and potential waste streams of even greater concern - this mainland owned CAFO is located next to the gulch system that feeds into the streams that flow to the town of Waialua and directly into the waters of Oahu's legendary North Shore.

LETTER TO FORMER SENATOR GIL RIVIERE

In a letter dated May 27, 2022, from the *Honolulu County DPP* to former Senator Gil Riviere, DPP wrote that Villa Rose received permitting as a minor composting operation. *The Department of Planning and Permitting also confirmed that Villa Rose did not have to conduct an EIS or provide any evidence that their method of handling chicken waste was effective. (Letter attached)*

EYE WITNESS REPORT OF CONCERN FROM FORMER USDA OFFICER

Former Senator Riviere wrote the above mentioned letter to DPP, after Joseph Realdine, a retired *USDA-FSIS CSO/FLS/RIFS* with the Office of Field Operations/Office of International Affairs wrote to Senator Riviere regarding his recent tour of the Wahiawa, Villa Rose CAFO. Mr. Realdine toured the Villa Rose site as a consultant to a party that was interested in seeing if there was a commercial application for the culled hens. Mr. Realdine reported that he was **shocked to find out that there was literally no oversight to the waste stream effluent.** While the marketing brochures for Hidden Villa state that their manure is processed utilizing

biochar and as a result, was carbon neutral, according to Mr. Realdine, the Hidden Villa guide, SVP Michael Sencer, stated that Villa Rose does not use the biochar and that Villa Rose fired their biochar consultants. According to Mr. Realdine, Mr. Sencer informed him that the manure from the chickens is too wet to run through the biochar. When Mr. Realdine asked what regulations the EPA requires on the biochar aspect, Mr. Sencer stated that the **EPA has no oversight** since the biochar unit is a "mobile" unit. Lastly, when Mr. Realdine asked Mr. Sencer about what happens with the wastewater, Mr. Sencer stated that the wastewater from operations along with the human waste from the toilets across the operations are sent to a tank and pumped on to a 14-acre field on the property. To make matters even worse, according to Mr. Realdine, Mr. Sencer seemed to treat these issues as trivial. Mr. Sencer even stated that he was surprised that Villa Rose's well water was permitted for use for the egg laying and processing operations. (See testimony submitted by Joseph Realdine)

PERSONAL VISIT

Based on my own visit to Villa Rose, *I witnessed massive stockpiles of wet manure stored in multiple barns at the facility.* I was told by the guide that the humidity, heat, and live fire from Schofield Army Base is contributing to a mortality rate in the laying hens that is a multiple of the industry average. All of these issues should be of great concern to the community and state agencies.

NO KNOWN GOVERNMENT AGENCIES MONITORING

I am unaware of any government agency auditing or monitoring any waste streams produced by this CAFO, making this a growing potential threat to the immediate environment, nearby communities and the environment and communities located at lower elevations below.

NOT SUSTAINABLE WITHOUT MASSIVE MAINLAND SUPPORT

It is important to note that an egg laying operation of this size does not move Hawaii toward a sustainable future. Laying hens need to be fed a heavy dose of minerals and amendments to allow them to produce the amount of eggs required for CAFO production. These additives need to be imported in to Hawaii for the laying operation. If the ships stop coming with the feed and additives - the eggs stop.

CLARIFICATION ON SUPPORT

To further clarify - I support SB1585, based on my very real experience with the O'okala Dairy tragedy and what I have recently discovered in Wahiawa at the Villa Rose CAFO, and *only as SB1585 relates to dairy farms, and egg laying operations over 150,000 laying hens*, assuming they have an acceptable waste stream plan that protects Hawaii's fragile environment and their surrounding communities.

With the above and attached in mind, I strongly support SB1585 as a necessary step to protect Hawaii's fragile environment and help move Hawaii toward a more sustainable and food secure future - in an eco-friendly way.

Dear Senator Riviere:

Thank you for your email on May 11, 2022, regarding to the Villa Rose Waialua Egg Farm (the "Facility") located at 65-1001 Kaukonahua Road in Waialua. The Mayor has asked the Department of Planning and Permitting (DPP) reply directly to you.

Specifically, you inquired as to whether the Facility was required to submit any scientific evidence in support of their method of chicken waste disposal, which you refer to as "Bio-Char technology," and whether the Facility was exempt from any requirements to prepare an environmental assessment (EA) or environmental impact statement (EIS) by the DPP. The subject property is located within the State Land Use Agricultural District (SLUAD) and the City and County of Honolulu AG-1 Restricted Agricultural District.

In a letter dated November 18, 2016, the DPP concurred that the use of the Facility as an egg farm is considered a major livestock production, which is a permitted use in the AG-1 Restricted Agricultural District, subject to additional specific development standards established in the Land Use Ordinance (LUO), Chapter 21, Revised Ordinances of Honolulu, Section 21-5.410. Further, the egg packing building is considered a "centralized bulk collection, storage, and distribution of agricultural products" use, which is also permitted in the AG-1 Restricted Agricultural District, subject to the additional provisions provided in LUO Section 21-5.110.

Our research indicates that "Bio-char technology" involves the processing of biomass material, with the end result being a charcoal-like material that has applications in improving soil fertility, sequestration of atmospheric carbon, and contaminate absorption, among other uses. "Bio-char technology," therefore, appears to meet the definition of "Minor Composting Operations," as defined in Article 10 of the LUO. Minor

Composting Operations "involve relatively simple management and engineering solutions to control odors, vectors, and surface water contamination. Minor composting includes, but is not necessarily limited to, the composting of clean, source-separated organic materials, including, but not necessarily limited to, green waste, animal manure, crop residues, and waste from vegetable food processing operations [emphasis added]."

A Minor Composting Operation utilizing chicken manure from an egg farm (permitted use) on the same site in the SLUAD is allowed as an accessory use to the farm, pursuant to Hawaii Revised Statutes (HRS) Chapter 205. And, a Minor Composting Operation is a permitted use within the AG-1 Restricted Agricultural District, subject to the following development standards provided in LUO Section 21-5.140:

- Outgoing and incoming materials shall be received and delivered only between the hours of 7 a.m. and 5 p.m.;
- All incoming and outgoing material loads shall be covered or otherwise managed to prevent material from falling onto the ground while in transport and to mitigate odors;
- Areas on site where composting takes place shall be located at least 50 feet away from all surface water sources;
- No minor composting facility shall be located within 100 feet of any zoning lot in a country, residential, apartment, apartment mixed-use, or resort zoning district;
- Accessory uses may include, but are not necessarily limited to, packaging and the incidental retailing of finished compost material;
- Compost material shall be covered in such a way that no fugitive material shall leave the site; and
- Controls shall be required to manage odors, vectors, and surface and groundwater contamination.

As described above, the three operations (major livestock production, centralized bulk collection, storage, and distribution of agricultural products, and minor composting) on the site are all permitted uses within the AG-1 Restricted Agricultural District, therefore, a discretionary approval from the DPP was not required (i.e., a Conditional Use Permit or other land use approval was not necessary). Under the provisions of Hawaii Administrative Rules (HAR) Section 11-200-1.9 for "Applicant Actions," the Facility did not require an environmental review (pursuant to HRS Chapter 343). Therefore, an exemption by the DPP was not applicable, and the Facility could proceed directly to building permit review.

Since an EA, EIS or land use approval was not required, the Facility did not have to submit scientific evidence to the DPP in support of their method of chicken waste disposal. The State Department of Health may have regulations relating to the

management and disposal of animal waste, in accordance with HAR Chapters 11-58.1 (Solid Waste Management Control), 11-104.1 (Management and Disposal of Infectious Waste), or others.

Dear Committee Members,

My name is Joseph Realdine. I am a retired USDA-FSIS CSO/FLS/RIFS with the Office of Field Operations and the Office of International Affairs.

Several months ago, I was asked to consult a local food producer who was interested in the culled hens from the Villa Rose CAFO operations in Wahiawa.

During my visit to Villa Rose, I was greeted by Mr. Michael Sencer, the Senior Vice President for Villa Rose. Having been around farms my entire career, I am aware of the waste generated by Concentrated Animal Feeding Operations. Having read the brochure that Villa Rose marketed, I was originally optimistic about how they said they were handling their manure and other waste streams in Hawaii's environment. I was hopeful that Villa Rose was different than the mainland CAFOs that I am familiar with.

When I arrived for the walk through, I asked about the bio-char and was informed by Mr. Sencer, that Villa Rose didn't use the biochar because the manure was too wet and too plentiful to use bio-char. I asked Mr. Sencer if there were EPA regulations for the use of the biochar and was informed that the EPA has no oversight since the biochar unit is a "mobile" unit. When I asked Mr. Sencer about what happens with the wastewater, Mr. Sencer informed me that the wastewater from operations along with the human waste from the toilets across the operations are sent to a tank and pumped on to a 14-acre field on the property. Overall, Mr. Sencer seemed to treat these issues waste stream issues as unimportant. I was shocked to learn that there was no state or county oversight or monitoring of the waste that was being generated by their CAFO operations.

Having lived and worked in Hawaii for many years, I know how the importance of taking care of our Aina and our ocean. It is hard to believe that a Concentrated Animal Feeding Operation can open up in our fragile environment without any overview or environmental impact study.

I would also like to bring to the attention of this committee a dangerous risk posed by bio-char.

Bio-char in itself is not the cure for the waste products produced by this CAFO. The fine ash associated with Bio-char is the perfect source for dust, posing a risk for respiratory diseases.

Everything that I have done in my 30 plus years in food safety and working with ranchers must be based on supporting documentation.

I was trained by the Federal Government to always review supporting documentation in order to form an agency supportable position. In this case, while retired from Federal service, I have not come across any supporting documentation provided by this CAFO with respect to their operation. I would like to submit the document written by Danielle L. Gelardi, Chongyang Li, Sanjai J. Parikh * University of California Davis, Land, Air and Water Resources, One Shields Ave., Davis, CA 95616, United States of America, to the committee. In part it states the following:

"PM10 exposure is a public safety concern as it can bypass the body's particulate interception mechanisms and penetrate deep into the airways. PM10 inhalation has been associated with increased chronic respiratory symptoms and the worsening of lung and heart disease (United States Environmental Protection Agency. 2017). Exposure to both the organic and inorganic components from agricultural PM10 have been linked with these adverse health effects in farmworkers (Schenker, 2000; Schenker et al. 2009, 2005). While there are chemical, physical, and end-use distinctions between biochar and other carbonaceous materials such as coal, there are many chemical and physical similarities (Lehmann and Joseph 2015). These similarities, and what is well known about the linkages between coal inhalation and chronic heart, kidney, and respiratory disease (Castranova and Vallyathan 2000; Graber et al. 2014; Hendryx 2009; Hendryx and Zullig 2009; Santo Tomas 2011), call for further investigation into airborne emissions from biochar-amended soils. With the growing interest in biochar as a soil amendment comes an imperative to better understand potential consequences for air quality, and how these might affect agricultural workers and neighboring farm communities. While the physical size of biochar-related PM10 is itself a serious concern, the organic and inorganic chemical constituents of biochar may also present a human health risk. The primary aim of this review is to highlight the emerging environmental concern of biocharinduced dust emissions by evaluating the limited literature currently available. In addition, solutions to minimize potential harm during biochar production and application are synthesized, and areas for future investigation are suggested".

As someone who suffers from Kidney disease as mentioned in the above article, is this what I expect to have here in Hawaii? Having a CAFO producing PM 10 unnecessary risks to not only the human population, but to the environment as well.

If you remove Bio-char from the solution to the waste, you are left with what? Basically, a big mess.

The public must be protected at all times.

I live on the North Shore and am also aware of how runoff from this CAFO could impact our North Shore and the communities that call this side of the island home.

Hawaii we can do better here. With the above in mind, I am in full support of SB1585 to ensure that our communities and environment are protected at all times.

Mainland companies plan to develop egg farm in Central Oahu

Apr 22, 2015, 6:50am HST

A partnership involving two of the largest egg distributors and producers in the U.S. plans to develop an egg farm on Oahu.

The new facility would help Hawaii reduce its reliance on importing fresh eggs from the Mainland and increase the sustainability of the food supply in the Islands, an executive for one of the companies confirmed to PBN.

The partnership involves California's Hidden Villa Ranch, one of the largest egg distributors in the U.S., and Indiana's Rose Acre Farms, one of the nation's biggest egg producers.

Michael Sencer, an executive vice president with Hidden Villa Ranch, told PBN that his company has been working on the project with Scott Enright, chairman of the Hawaii Department of Agriculture.

"While the size of the project has not yet been determined, we believe a project that increases employment and produces fresher food to the marketplace helps advance the goals of the Department of Agriculture," Sencer told PBN in an email. "With the guidance of the Department of Agriculture, we continue to believe this project has a high probability of success."

Enright told PBN this week that the project is tentatively planned for **Dole Food Co.-owned** lands in Wahiawa in Central Oahu and could involve 1 million hens housed in a state-of-the-art facility.

A development timeline has not been set yet, although Sencer said it could happen as quickly as the permitting process allows.

"We will start very small and see where the market will take it," he said. "Our hope is for a very 'green' facility, powered by our own solar panels. We would like to make it visitor-friendly so the public can

see how their local eggs are produced and how we take care of our birds."

The plan is to develop a cage-free operation where the birds can roam freely in the barn.

"Hawaii has not had a modern layer barn built there for many years and we felt it was time to try," Sencer said.

Hawaii ranks 45th in the U.S. in sales in the poultry and eggs commodity group, according to the most recently available statistics from the U.S. Department of Agriculture.

Aloha Chair Gabbard, Vice-Chair Richards, and Members of the Committee:

I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate and advance the social, economic, and educational interests of our diverse agricultural community.

The Hawai'i Farm Bureau respectfully opposes SB 1585 which would prohibit large concentrated animal feeding operations in Hawai'i.

HFB opposes the bill for the following reasons:

- Food sustainability and resiliency is a priority in Hawai i. A properly sited, operated
 and maintained large CAFO could provide Hawai i consumers with local,
 affordable sources of protein. These types of farms are efficient and have doubled
 and in some cases quadrupled milk, meat, and egg production and significantly
 cut down on the amount of time and resources, including capital and labor, it takes
 to produce food.
- Large concentrated animal feeding operations (CAFOs) are strictly regulated under the Clean Water Act National Pollutant Discharge Elimination System (NPDES) and our State DOH administrative rules permitting program that regulates the discharge of pollutants from point sources to inland, marine, and groundwater in Hawai'i. CAFO regulations are periodically updated to reflect new information, technologies, and public comments.
- There may be a time in the future of the islands in which large CAFOs are necessary to adequately feed Hawai'i's people. HFB does not believe it is in the public interest to outright ban these facilities on a wholesale basis.

Intensive farming methods such as large CAFOs can help us to achieve our food goals if we prioritize public health and animal welfare, prevent waste products from overwhelming the environment, and make sure we do it in a way that doesn't negatively impact the community.

Aloha Chair Gabbard, Vice Chair Richards, and Members of the Committee on Agriculture and Environment:

The Hawai'i Reef and Ocean Coalition (HIROC) is a group of scientists, educators, filmmakers and environmental advocates who have been working since 2017 to protect Hawaii's coral reefs and ocean. HIROC is deeply concerned about polluted runoff, particularly nutrients, running into the ocean from large concentrated feeding operations and harming reefs and other marine life.

The Climate Protectors Hawai'i seek to educate and engage the local community in climate change action, to help Hawai'i show the world the way back to a safe and stable climate. The Climate Protectors Hawai'i are concerned that large concentrated feeding operations contribute to climate warming by producing greenhouse gases, particularly methane, a potent greenhouse gas that is about 80 times worse for the climate than carbon dioxide.

Hawai'i Reef and Ocean Coalition and Climate Protectors Hawai'i STRONGLY SUPPORT this bill.

Concentrated animal feeding operations or "CAFOs" present significant risks to public health and the environment. These facilities house hundreds or thousands of animals at a time, creating a concentration of massive amounts of animal waste that contains chemicals, pharmaceuticals, heavy metals, and pathogens. These pollutants can contaminate the environment and harm human and animal health.

Even when adhering to state and federal permits, CAFOs harm people and wildlife through air and water pollution and threaten surface water and groundwater due to runoff and seepage of animal waste. Those who live in proximity to these facilities and breathe their pollution suffer increased rates of asthma and other diseases, significantly lowering their quality of life. CAFOs put small, independent farms using ecologically sensitive methods to raise livestock at a disadvantage.

I served as a Deputy Attorney General and represented the Department of Health in litigation involving the Big Island Dairy, a large dairy CAFO that generated millions of gallons of animal urine and feces. The Oʻokala community was significantly polluted by the wastewater that was allowed to flow through several gulches and into Oʻokala. This experience showed the harms that could be caused by a CAFO in Hawaiʻi, especially given our sloping topography and volcanic soils. A CAFO such as Big Island Dairy should not be allowed to operate in Hawaiʻi.

Local food production is crucial for Hawai'i, but the harms and impacts of large CAFOs outweigh any benefits and, in fact, make it harder for small, midsize, and independent farms to operate.

This bill would protect the State's residents and environment by preventing further large concentrated animal feeding operations from being operated in Hawai'i and phasing out existing large concentrated animal feeding operations.

The animal manure and wastewater generated on AFOs and CAFOs are the primary cause of water quality issues, as they lead to a host of pollutants, including nutrients, pathogens, hormones, antibiotics and more. Some consequences of this pollution include drinking water contamination and fish kills, along with habitat loss and groundwater depletion.

Animal waste is typically stored in open or covered pits or liquid lagoons and later spread or sprayed on nearby cropland contaminating the air, or creating runoff. - CAFO waste is usually not treated to reduce disease-causing pathogens, nor to remove chemicals, pharmaceuticals, heavy metals, or other pollutants.
- Over 168 gases are emitted from CAFO waste, including hazardous chemicals such as ammonia, hydrogen sulfide, and methane.
- Airborne particulate matter is found near CAFOs and can carry disease-causing bacteria, fungus, or other pathogens.
- Animals frequently die in CAFOs. Their carcasses, often in large numbers, must be dealt with.
- Infestations of flies, rats, and other vermin are commonplace around CAFOs and therefore around CAFO neighbors.

My name is Carol Janezic and I live in Temple Valley on Oahu. I am writing in strong support of SB1585, which places a moratorium on large CAFOs in Hawai'i.

CAFOs are bad for animals -- you bet they are, but they are bad for people, too.

The National Association of Realtors report multiple studies conducted since the 1980's show construction of a CAFO lowers home and land value around it. Properties within three miles of a CAFO lose up to 26% of their value. Properties within .25 miles of a CAFO lose up to 88% of their value. It has been estimated that CAFOs around the U.S. have reduced property values by Twenty-Six Billion dollars as of 2008 -- 15 years ago, and there are many more CAFOs today. Homes and properties near CAFOs become unlivable. Why would that be?

Because CAFOs house massive numbers of animals, and those animals produce massive amounts of waste. There is no comprehensive system in place to regulate and track the waste produced by CAFOs. The waste from so many animals is concentrated in areas too small to absorb the waste.

If CAFO waste is not properly stored, transported, and applied to land that can absorb it, the pollutants get into the air (small droplets can travel for miles,) seep into ground water and run off into surface waters. They can contaminate our pristine aquifers.

These pollutants make people sick, make the air putrid, and contaminate plants grown for food within the community. These pollutants are very often the reason plants are infected with Salmonella and E coli.

Research shows that the disease-causing E. coli interacts directly with plant cells allowing it to anchor to the surface of a plant where it can multiply. E coli bacteria is a toxic poison that can damage the lining of the small intestine, and can cause bad stomach cramps, vomiting, and bloody diarrhea.

When salmonella is present in the soil it can get on the surface of the produce and also enter plants through their root system to colonize the plant. Fruits and vegetables grown on the colonized plant can have salmonella cells too. People who eat the infected produce are at risk of

Salmonella infection. Salmonella can cause permanent life-altering diseases such as irritable bowel syndrome, Crohn's disease, reactive arthritis, and Guillain-Barre syndrome.

SB1585 Testimony | In Strong Support

Aloha Chair Gabbard, Vice Chair Richards, and Members of the AEN Committee,

My name is Doorae Shin, a longtime resident of Oahu, currently living in Kaimuki and writing in strong support of SB1585. This bill would prohibit new large CAFOs (commonly referred to as factory farms) in Hawai'i and give the existing one 5 years to scale down or phase out their operations. This bill would have an immensely positive impact on our community and our environment, while also having no negative impact on locally-owned farms.

The only farm in the State which qualifies as a large CAFO is a factory egg farm in Waialua called Villa Rose, and it is not locally-owned, rather owned by 2 large corporations from the continent, including Hidden Valley Ranch and Rose Acre Farms. Under the guise of "sustainable" operations, they sell Waialua Fresh brand eggs at popular retail locations. But their operations are large, with 200,000 laying hens in small spaces and plans to grow to 1 million hens, and a goal to export to Asian markets.

What are CAFOs?

CAFOs are Concentrated Animal Feeding Operations, where animals are kept and raised in confined situations for agricultural operations. Animals in CAFOs are confined and fed or maintained for 45 days or more in a 12-month period and crops or vegetation are not present on the facility.

CAFOs are defined by three categories: Small CAFOs, Medium CAFOs, and Large CAFOs. This is based on the number of and type of animals confined in the operation.

Environmental Impacts

In 1998, following President Clinton's release of the Clean Water Action Plan to clean up our rivers, lakes, and coastal waters, the USDA & EPA created a Unified National Strategy to minimize water quality and public health impacts of AFOs. This document found that the vast majority of farms with livestock are small, with approximately 85% of those farms having fewer than 250 "animal units" (one animal unit is equal to roughly one beef cow). In 1992, there were 6,600 AFOs that were considered large operations.

While USDA supports sustainable agricultural practices, the forces of domestic and export markets, technological changes and industry priorities, have led to an expansion in CAFOs. The animal manure and wastewater generated on AFOs and CAFOs are the primary cause of water quality issues, as they lead to a host of pollutants, including nutrients, pathogens, hormones, antibiotics and more. Some consequences of this pollution include drinking water contamination and fish kills, along with habitat loss and groundwater depletion.

Past failures of CAFOs in Hawai'i

Two clear examples of CAFOs being incompatible with our island watersheds and environment are Big Island Dairy and Hawai'i Dairy Farm on Kaua'i.

 Big Island Dairy for years was polluting millions of gallons of animal waste into the local streams and causing significant harm on the environment and community downstream of the farm.

Liquid and solid animal waste from large CAFOS such as Big Island Dairy contain numerous pathogens, nitrogen, phosphorus, and dangerous bacteria. Water quality testing confirmed high levels of fecal coliform, E.coli, and enterococcus bacteria which are "toxic to human, animal, plant, or aquatic life."

Big Island Dairy violated the Federal Clean Water Act and subsequently lost a lawsuit brought by the Center for Food Safety and the community, forcing them to shut down operations in early 2019.

• The proposed Hawai'i Dairy Farm on Kaua'i was also shut down in 2019 after the community successfully challenged the company's false claims of sustainable agriculture. This protected the culturally and environmentally significant shoreline of Māha'ulepu on Kaua'i island along with the surrounding areas where the proposed dairy would have operated.

An Important Solution

Again and again, we see across Hawai'i that large CAFOs, a.k.a. factory farms, are simply incompatible with our island ecosystem, wreaking havoc on our interconnected systems of water, land, and soil. This is why only one exists across the State today and why preventing new ones from coming in is a clear way to protect our communities and environment for our current and future generations in Hawai'i. A local, resilient, and sustainable food system should help our environment and communities, not hurt them.

Mahalo for your consideration of SB1585. We urge you to pass this bill and we thank you for the opportunity to testify.

Aloha Chair, Vice Chair, and Members of the Senate AEN Committee,

My name is Jennifer Meleana Hee. I was born and raised in Hawai'i Kai, where I also currently live. I am writing in strong support of SB1585.

As someone who has worked in the food service industry in Hawai'i for over a decade, I recognize the importance of sourcing local in order to reduce our reliance on imported food. However, we must also protect our islands from the irreversible environmental harm associated with high-intensity animal agriculture. While I do not know how local agriculture may resolve the problem of feeding so many people on such limited land, I am certain CAFOs are not the answer.

First, CAFOs generate massive amounts of animal waste daily. How will large CAFOs keep feces and urine out of our streams and oceans? As an island chain, high volumes of animal waste will devastate our fragile marine ecosystems.

Additionally, as climate change increases the occurrence of natural disasters, we need to take precautions, prohibiting structures which could exponentially increase environmental harm during a hurricane, for example. The massive overflow of hog waste lagoons during Hurricane Florence in North Carolina should serve as a haunting warning of what could occur here. The thousands of animal carcasses surrounding submerged neighborhoods, the sickened communities—is this the future we want to open ourselves up to?

Third, CAFOs are hardly a sustainable solution to our food insecurity, as the feed for thousands of animals will still need to be shipped in. (If we somehow are ever able to grow the amount of food necessary to support a CAFO, wouldn't it be more efficient to feed our human population directly?)

I stopped eating beef after reading about slaughterhouses in the seventh grade. Learning more about animal agriculture over the decades has only reinforced my initial impression as a 12 year-old-- that our treatment of nonhuman animals is unfathomably cruel. Individually, we should not support such inhumane conditions anywhere. As a state, we should shut CAFOs out before their harms to our land and people cannot be undone.

As a chef, customers supported our business because we sourced ingredients from small farms using organic growing methods. A CAFO is the antithesis of environmentally-friendly and sustainable farming, and has no place here.

As a student at the University of Hawai'i at Mānoa William S. Richardson School of Law, I endeavor to continue to protect animals, small farms, and our entire community from the immense environmental harms caused by CAFOs.

Aloha mai kākou Chair Gabbard, Vice Chair Richards, and members of the committee,

My name is Anna Camacho, I live in Kaimukī and I'm testifying in favor of SB1585.

In 2019, the American Public Health Association released a policy statement calling for a precautionary moratorium "on the establishment of new CAFOs and expansion of existing CAFOs until regulation and enforcement conditions are in place to adequately protect the public's health."

This is because raising animals in large, high-density operations leads to the routine accumulation of massive volumes of animal waste, often at rates far exceeding the capacity of nearby land to absorb it. CAFO-generated manure has hazardous constituents like antibiotic drug residues, potentially harmful pathogens, heavy metals, hormones, and antibiotic resistant bacteria — many of which are transferable into neighboring communities.

As someone who grew up on the Hāmākua Coast, I was devastated and angered to learn about the disaster with Big Island Dairy in 'Ō'ōkala, a large CAFO with Idaho-based owners. Because of improper handling and treatment, millions of gallons of animal waste created runoff, polluting water resources downstream and ultimately into the Pacific Ocean. The environmental, health, aesthetic, economic, and recreational interests of the community were negatively impacted by the CAFO's inability to manage the massive amounts of manure they produced.

Their story is not an isolated incident. Close proximity to CAFOs is frequently associated with declines in local economic and social indicators which undermine the socioeconomic and social foundations of community health. These indicators include business purchases, infrastructure, property values, population, and social cohesion.

As there is only one large CAFO in the State of Hawai'i, owned by two large corporations on the continent (that might also be failing to manage their waste properly) SB1585 is legislation with low impact in the short-term and high impact in the long-term. I urge you to support locally owned farms and local farmers, while protecting our 'āina and kama'āina for generations to come.

My name is Zoë Malia Ozoa Loos, and I live in Kaimuki. I am writing in strong support of SB1585, which places a moratorium on large CAFOs in Hawai'i.

Look no further than North Carolina and that state's so-called pig farms. Farms that are nothing more than horrendous money-making machines run by Smithfield, a multi-million dollar organization that does not care about people, the planet, or animals.

After watching the Documentary *The Smell of Money*, which exposed the cruelty of these "farms," it's even clearer to me that CAFOs have no place on this island or anywhere in the world for that matter. While this bill focuses on protecting local farmers and the environment, I would like to note that CAFOs are also a violation of animal rights.

TESTIMONY OF MARY CHARLENE NISHIDA AND KUPALE O'OKALA IN SUPPORT OF SB 1585- THE LARGE CAFO BAN – 02/14/2023

Kupale O`okala is a not-for-profit corporation dedicated to preserving and protecting the people and environment of the Hamakua Coast and community of O`okala on the Big Island of Hawaii. Members of the community of O`okala primarily comprise its membership. The story of Big Island Dairy (BID) is one that caused great trauma to the community and should never be allowed to occur again, on Hawaii Island or anywhere else in the State. That is why Kupale O`okala urges you to support SB 1585 with a very minor amendment, which will be discussed at the end of this testimony.

Here is the background: Big Island Dairy's operations included up to 3,000 cows. They released their manure on a regular basis, if not hundreds of times, to the gulches that run through the site and the community of O'okala. The smells coming from the operation were often overpowering, enough to drive you out of your home. Those residents who had no other option to leaving were forced to keep their windows closed even during the suffocating heat of the summer. The dairy was located on the lower slopes of Mauna Kea where precipitation runs between 120-170 inches annually. Three gulches that drain different parts of the property, Kaohahoa, Alaialoha, and Kaula, run through the community of O'okala and into the Pacific Ocean. The manure discharges from the dairy egregiously violated the Federal Clean Water Act and the Hawaii equivalent laws and put our community at great risk. Video of the discharge is provided for the record. [attach below]

Unfortunately, for many years the Hawaii Department of Health (HDOH) provided minimal intervention to prevent the discharges and lacked enforcement after the discharges occurred until the community took action. Kupale O'okala, along with its partner, Center for Food Safety, filed a complaint in federal district court on June 28, 2017 in a Federal Clean Water lawsuit.

BID took over a much smaller, existing dairy in late 2011 and began expanding the facility and adding cows almost immediately upon takeover. As of 2018, it quadrupled in size from the prior ownership. According to EPA information about dairies, each mature milking cow produces between 120-150 pounds of excrement per day. Kupale O'okala's experts estimated that some seven billion gallons of precipitation-related stormwater crossed the site each year. The amount of manure produced combined with the stormwater movement led to disastrous consequences for the community and the environment. During a significant, but not unusual, rain event in May 2018, BID admitted discharging 2.3 million gallons of manure water over three days to one gulch in order to avoid overtopping of one if its manure storage pits (known as "open lagoons"). Another event during Hurricane Lane resulted in an intentional discharge of nearly 6 million gallons over 2-3 days. Discharges have been occurring since BID took over the facility and began operating in 2012. Hawaii Department of Health, supposedly in charge of regulating the facility and protecting human health and the environment, fined BID for only one discharge event that occurred in March 2017 before our involvement.

Federal and state law requires ZERO discharge from large CAFOs. But in fact, every time it rained an inch or more, which happens regularly in this area of the Hamakua Coast, BID released manure water to one or more of the three gulches that run through our community. During one particular event in 2016, many homes in the community were flooded with manure water. People had to be evacuated from their homes, the main highway was shut down and people's health was put at great risk.

During a site visit with our attorneys and experts in November 2017, it rained approximately six inches in four hours. Manure water was spewing from fields and operational areas all over the site. In 2019, our attorneys had convinced the owner-operators, the Whiteside family from Idaho, that they could not operate the facility safely and in compliance with the Clean Water Act, so all parties agreed that they would cease operations. No new Concentrated Animal Feeding Operation (CAFO) should ever be allowed to take its place. It would be an affront to our Island and generations to come.

We ask that you amend one section of the bill and substitute the language below in order to avoid a potential problem down the road and make HDOH's obligation clear and specific. The present section and proposed change are here:

PRESENT LANGUAGE

§ -3 Phasing out of existing large concentrated animal feeding operations. Beginning July 1, 2028, all existing large concentrated animal feeding operations shall cease operations in the State; provided that the director of health, in cooperation with existing large concentrated animal feeding operations, shall develop proposed rules for the closure of all large concentrated animal feeding operations in the State."

AMENDED LANGUAGE

§ -3 Phasing out of existing large concentrated animal feeding operations. Beginning July 1, 2028, all existing large concentrated animal feeding operations shall cease operations in the State; in addition, the director of health, by no later than December 31, 2025, shall develop proposed rules for the closure of all large concentrated animal feeding operations in the State."


Thank you for considering our comments and protecting our community. We urge passage of SB 1585 without delay.

My name is Olivia Marohnic and I live in Hilo. I am writing to express my strong support for bill SB1585, which prohibits new, and phases out existing, CAFOs (Concentrated Animal Feeding Operations) in Hawaii.

As a surfer and having been born and raised in Hawai'i, I have always enjoyed our beautiful natural water resources, playing in gulches, and surfing on our coasts. There is nothing more disconcerting as a surfer than finding your favorite surf spot tarnished by polluted water after heavy rains or a sewage spill. The natural beauty and ecology in Hawai'i is our number one most valuable resource, and we need to protect it accordingly.

CAFOs in Hawai'i have a continual history of polluting waterways and violating environmental laws, demonstrating that they cannot operate here without causing great environmental harm. We have seen this with Big Island Dairy and the earlier Kaua'i Meadow Gold Dairy. The Big Island Dairy plagued the downstream town of O'okala in the 2010s with many numerous (at least 30 recorded) incidents of spills and runoff of manure and urine into the waterways and even into the town itself after a storm, even after the Dairy claimed to be changing their practices to mitigate impacts. With the likely increase in hurricane and heavy rainfall event frequency associated with rising sea surface temperatures, we cannot allow the risk to our precious waterways that CAFOs present.

This bill would protect Hawai'i's precious natural resources and communities, and preserve space for locally-owned farms. The only existing large CAFO in the State is owned by large mainland companies. It is imperative now to support locally-owned and sustainable agriculture that has Hawai'i's best interests at heart.

Dear Chair Gabbard, Vice Chair Richards, and members of the Committee,

I am testifying **in support of** S.B. 1585. Hawai'i should phase out concentrated animal feeding operations (CAFOs) because they are harmful to the environment, humans, and animals.

By their very nature, CAFOs produce large amounts of fecal waste that pollute the air and groundwater. CAFOs commonly keep their waste in "lagoons" or spray it into the air as "fertilizer". Because of these practices, communities surrounding North Carolina CAFOs have developed respiratory illnesses and samples taken from surfaces inside their homes revealed contamination from hog manure. In 2017, the Center for Food Safety reported that Big Island Dairy sprayed waste into the air, which spread to communities downhill by wind and water runoff. Our communities should not be exposed to the same risks and conditions. Scientists also warn that the unnatural practices of confining hundreds of animals in small spaces make CAFOs a breeding ground for zoonotic diseases. These infectious diseases, like swine flu and avian flu, harm humans. Finally, this legislature should not support a policy of animal mistreatment. The practice of confining hundreds of thousands of animals in one location, primarily indoors, is cruel and inhumane.

I have submitted testimony to this committee in support of local food production, but CAFOs located in Hawai'i are not truly local. Big Island Dairy, for example, is owned by mainland residents. Mainland corporations and individuals benefit from CAFOs, while rural Hawaiian communities bear their many costs.

I respectfully request that the Committee supports this measure and a policy of sustainable food production. Thank you for this opportunity to testify.
