

North end of property already secured with fencing that was funded by Joshua and Yarden, the remaining South, West, and East ends of property in need of fencing

Annual Liability Insurance: \$2,000.00

Justification: Liability insurance for activities and participants while on property ensuring project compliance and stakeholder protection.

Automated Entrance Gate: \$15,000.00

Justification: A quality automated rolling gate is an efficient and effective security feature necessary for 'Āina 'Ōiwi. To be located at the North West end of 'Āina 'Ōiwi

Emergency Exit Gate: \$5,000.00

Justification: A quality manual rolling gate shall suffice as an emergency exit. To be located at the North East end of 'Āina 'Ōiwi

• Farm Animal Housing and Fencing: \$23,000.00

Justification: Chicken/poultry animals and livestock housing would allow staff to tend to animals safely and securely. Fencing would be used to create sections for animals to graze and roam freely. Staff would alternate sections where animals shall roam freely to ensure proper management of food source for grazing

Canine Facility: \$30,000.00

Justification: This facility is essential for the Youth canine obedience and herding training program. Complete with covered 12 stalls with runners, concrete foundation, bathing sinks, grooming table, water, off grid electrical, storage room, cameras.

• Purchase Canine Puppies: \$15,000.00

Justification: Ethically bred Shepard working dogs. These puppies shall frontier this project beginning with obedience training in 'Ōlelo Hawai'i. At first heat, canine shall be bred to create the first litter to serve the Youth Canine Obedience and Herding Training program. Includes healthcare and food for 1st year.

V. Experience and Capability

1. Necessary Skills and Experience

Operations Director, Joshua, has 20 years experience in the event planning, production, and coordination industry with corporate clientele and mass crowd control experience. In 2017, using their skills in events, construction, production, and sales, Joshua and his wife Yarden have established a successful full service events business here in Hawai'i that caters to weddings, private events, and corporate gatherings. The success of this business motivated Joshua and Yarden to acquire the knowledge necessary for managing large amounts of financial income.

Farming has been Joshua's passion since elementary school. With food farming being an important facet of self-sustainability, 25 Ulu trees, Banana, and Kalo have been planted at 'Āina 'Ōiwi. Mango, Soursop, Orange, and more are in pots and will be planted in ground very soon. A large portion of 'Āina 'Ōiwi is dedicated to Native Hawaiian forestry where many of these natives have already been planted in ground. With Uncle Bobby 'Momona" from Moloka'i as a mentor for Native Hawaiian Forestry, I am certain that this part of 'Āina 'Ōiwi shall flourish into the "Living Library" it is intended to be.

Joshua's personal experience in the construction industry instilled skills; hands on and leadership skills that allow him to lead projects and "swing a hammer". Joshua and his father have erected two 1000sq/ft farm structures, fencing at property front, and a few other projects on 'Āina 'Ōiwi that require heavy equipment operations. These are projects we can look back and say "we did this together".

'Āina 'Ōiwi has appointed Elijah McShane to be the Director of Hawaiian Culture whom oversees all programs involving Hawaiian Culture. With his cultural knowledge, network, and impact upon the community and people afar, Elijah shall spearhead his department by working with professionals/Kumu to create the curriculum of which 'Āina 'Ōiwi shall operate, thus establishing a cultural center that impacts lives in an safe, immersive, experiential, and influential way.

Herding dog training shall be led by trainer Abe Gonzales. Canine trainers of 'Āina 'Ōiwi shall attend courses led by Abe to ensure program beneficiaries receive proper guidance in this program. Experienced animal caregivers of the 'Āina 'Ōiwi shall maintain all animal facilities and the wellbeing of the animals.

Francis Sinenci, lead Hale kumu, and his team, shall lead the construction of the Hawaiian hale project. Francis wrote the State codes for approved Hawaiian Hale and is recognized for his cultural work for Hawai'i.
