We seek funding to purchase a new commercial generator to replace our current unit, which is over 25 years old. The existing generator fails to function consistently, compromising our ability to maintain essential operations during power outages. Its deteriorating condition has also led to escalating repair costs, making replacement a more cost-effective and reliable solution. Additionally, we urgently need to replace our 20-plus-year-old front gate motor. The motor requires frequent repairs and maintenance, jeopardizing the safety and security of our facility, staff, and clients. A functioning gate is vital for maintaining a secure environment for the vulnerable youth we serve, and delays in replacement pose a significant risk to their well-being. These upgrades are critical to ensuring uninterrupted operations and safeguarding our clients and staff, making them an immediate priority for our facility

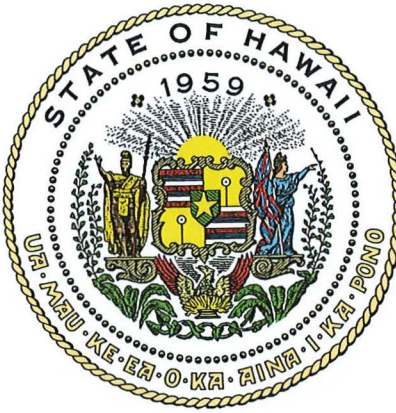

## **II. Background and Summary**

The Bobby Benson Center (BBC) has been a trusted provider of residential treatment services for Hawaii's youth since 1990. Licensed by the State of Hawaii Department of Health (DOH) as a 30-bed Special Treatment Facility, BBC specializes in serving at-risk youth aged 13-17 who face substance use challenges, co-occurring mental health disorders, and trauma. With over three decades of experience, BBC is committed to delivering high-quality, evidence-based care to improve the lives of Hawaii's most vulnerable adolescents.

### **Goals and Objectives:**

The primary goal of this request is to enhance the safety, security, and operational reliability of BBC's facility through the replacement of critical infrastructure. Specifically, we seek funding for:

- A new commercial generator to ensure uninterrupted power during outages, critical for sustaining essential operations and client care.
- A replacement motor for the front gate to maintain a secure and controlled environment for our residents, staff, and visitors.

### **Public Purpose and Need:**

The requested upgrades are vital to ensuring the continuity of services and safeguarding the well-being of the youth in our care. An operational generator is essential for emergency preparedness, while a reliable front gate is critical to the safety and security of the facility. These improvements directly support our mission to provide a stable and therapeutic environment for at-risk youth.

### **Target Population:**

The target population consists of adolescents aged 13-17 from across the state of Hawaii, with a focus on those from low-income families or homes affected by substance use and mental health challenges. Approximately 85-90% of our residents are from Oahu, and many come from high-risk environments that necessitate specialized care and support.

### **Geographic Coverage:**

BBC serves youth from all islands within the state of Hawaii, providing a central and accessible location for families statewide. Our facility in Kahuku on the North Shore of Oahu acts as a critical resource for addressing the unique needs of Hawaii's adolescents facing behavioral health challenges.

By addressing these urgent infrastructure needs, BBC will be better equipped to continue providing safe, secure, and effective care to Hawaii's vulnerable youth.

## **III. Service Summary and Outcomes**

The Bobby Benson Center (BBC) proposes a proactive approach to address critical infrastructure deficiencies that threaten the safety, security, and operational integrity of our facility. This request includes two primary components:

### **Replacement of Commercial Generator:**

- The current generator is over 25 years old, fails to operate reliably, and is increasingly costly to maintain.



- The new generator will ensure uninterrupted power during emergencies, enabling BBC to continue providing essential services to youth, including medical care, security, and therapeutic activities.
- Installation will include a thorough review of electrical systems to optimize performance and reliability.

#### **Replacement of Front Gate Motor:**

- The existing motor is over 20 years old and requires frequent repairs, compromising the security of our residents and staff.
- The new gate motor will restore reliable access control, enhancing the safety of the facility while reducing maintenance costs.
- Implementation will include a security audit to ensure the gate system meets current standards.

#### **Results and Outcomes:**

##### **Enhanced Facility Operations:**

- Uninterrupted power during outages will ensure continuity of care and operations, minimizing risks to clients and staff.
- A secure and functional gate system will reinforce the safety and controlled access to the facility.

**Improved Safety and Security:** Residents will benefit from a safer, more stable environment, reducing potential risks associated with power outages and unauthorized access.

**Cost-Effectiveness:** Reduced maintenance and repair costs will allow funds to be redirected toward enhancing programs and services for the youth.

##### **Measures of Effectiveness:**

##### **Operational Reliability:**

- Zero instances of power outages disrupting services or compromising safety within one year of generator installation.
- A fully functional and secure gate system with no major repairs required within the first two years of replacement.

##### **Client Safety and Satisfaction:**

- Increased client and staff satisfaction, measured through surveys post-implementation.
- No reported incidents related to power failures or security breaches after upgrades.

**Cost Savings:** Documented reductions in maintenance costs compared to previous years, with funds reinvested into client programs and facility improvements.

Through these targeted infrastructure improvements, BBC will ensure that our facility remains a secure and reliable environment for the vulnerable youth we serve, aligning with our mission to provide effective and compassionate care.

**Scope of Work:**

The Bobby Benson Center (BBC) will undertake infrastructure upgrades to enhance safety, security, and operational reliability through:

1. Replacement of the aging commercial generator.
2. Replacement of the front gate motor to improve facility security.

**Tasks and Responsibilities:**

**Planning and Procurement:**

- Bobby Benson Center has already identified and will procure a commercial-grade generator and gate motor that meet facility requirements.
- Obtain necessary permits and approvals for installation.

**Installation and Implementation:**

- Coordinate with licensed contractors for the safe removal of old equipment and installation of new systems.
- Ensure installation aligns with state safety and operational standards.

**Training and Transition:**

- Train staff on the operation and maintenance of the new equipment.
- Develop a maintenance schedule to ensure long-term reliability.

**Monitoring and Reporting:**

- Conduct regular evaluations of the new systems to ensure they meet performance expectations.
- Provide updates and final reports to the State agency on the outcomes of the upgrades.

**Projected Annual Timeline**

**Quarter 1:**

- Finalize planning and design specifications.
- Obtain necessary permits.
- Initiate procurement process for generator and gate motor.

**Quarter 2:**

- Contract licensed vendors for installation.
- Remove existing equipment and begin installation of new systems.

**Quarter 3:**

- Complete installation of generator and gate motor.
- Train staff on operation and maintenance.

**Quarter 4:**

- Conduct post-installation evaluations.
- Submit a final report to the State agency detailing project outcomes.

## V. Experience and Capability

### Necessary Skills and Experience

The Bobby Benson Center (BBC) has over three decades of experience operating as a licensed residential treatment facility, providing critical services to at-risk youth in Hawaii. BBC's staff and leadership have extensive expertise in facility operations, safety, and compliance with state and federal standards. This expertise ensures we are well-equipped to manage the proposed infrastructure upgrades.

Key areas of demonstrated capability include:

**Facility Management Expertise:** BBC maintains a 30-bed facility licensed by the Department of Health (DOH) as a Special Treatment Facility, demonstrating our ability to manage and maintain complex infrastructure.

**Operational Reliability:** BBC has consistently passed audits with scores of 95% or higher from regulatory bodies such as the Commission on Accreditation of Rehabilitation Facilities (CARF), CAMHD, and OHCA.



**Emergency Preparedness:** BBC has a history of implementing effective operational protocols during power outages and security incidents, underscoring the importance of reliable infrastructure.

### **Relevant Experience (Most Recent Three Years)**

1. **CARF Accreditation (2022-2025):**
  - BBC earned a three-year accreditation from CARF, recognizing our adherence to high operational standards. This process required demonstrating facility readiness, safety protocols, and operational effectiveness.
2. **Child and Adolescent Mental Health Division (CAMHD) Contract (Ongoing):**
  - BBC has maintained a long-standing contract with CAMHD to provide residential treatment services. This partnership requires ongoing compliance with state standards, including facility safety and emergency readiness.
3. **Coordinated Access Resource Entry System (CARES) Contract with ADAD (Ongoing):**
  - BBC provides care coordination under this contract, assisting clients in accessing the appropriate level of care. Managing this contract necessitates efficient operations and infrastructure to ensure continuity of services.
4. **Successful Renovation of Client Dining Facilities (State GIA, 2019):**
  - BBC successfully completed a comprehensive renovation of its client dining facilities using funds from a State Grant-in-Aid in 2019. This project involved planning, procurement, and coordination with contractors to ensure high-quality results while minimizing disruption to client services.
5. **Facility Maintenance and Renovation (2021-2023):**
  - BBC has undertaken multiple facility upgrades, including renovations to client living areas and installation of updated safety systems, ensuring compliance with DOH and OHCA requirements.

### **Appropriateness for Providing the Proposed Service**

BBC's track record of maintaining a safe, operational, and compliant facility directly aligns with the proposed infrastructure improvements. Our skilled team, which includes licensed maintenance staff and administrators with experience managing large-scale projects, ensures that we can effectively oversee the generator and gate motor replacements.

Through years of experience, BBC has proven its commitment to fostering a safe, secure, and therapeutic environment for Hawaii's at-risk youth. This request aligns with our ongoing mission and operational capacity, and we are fully prepared to execute the proposed upgrades efficiently and effectively.

### **Facilities**

The Bobby Benson Center (BBC) operates a licensed 30-bed residential treatment facility located in Kahuku, Hawaii. The facility provides a safe, structured environment for at-risk youth aged 13-17. Our campus is specifically designed to meet the needs of this population, offering therapeutic and recreational spaces that promote healing and growth.

Key components of our facilities include:

1. **Residential Units:** Dormitory-style accommodations that provide a comfortable and secure living environment.
2. **Therapeutic Spaces:** Designated areas for individual and group therapy sessions, including private offices and group meeting rooms.
3. **Recreational Facilities:** Outdoor spaces for physical activities and structured recreational programs, including sports courts and open play areas.
4. **Dining and Kitchen Areas:** A newly renovated client dining facility (State GIA, 2019) that enhances the dining experience and supports the nutritional needs of our youth.
5. **Administrative and Support Areas:** Office spaces for staff, as well as dedicated areas for educational and vocational training.

### **Demonstration of Adequacy in Relation to the Request**

The facilities are well-maintained and meet the operational standards required for residential treatment. However, two critical infrastructure components—the commercial generator and the front gate motor—require immediate replacement to ensure the safety, security, and reliability of the facility:

**Commercial Generator:** the existing generator, over 25 years old, has become unreliable, failing to provide consistent backup power during outages. A new generator is essential to maintaining critical systems, including lighting, HVAC, and security systems, during emergencies.

**Front Gate Motor:** The motor controlling the facility's entrance gate is over 20 years old and requires frequent repairs. This gate is vital for controlling access to the property, ensuring the safety and security of residents and staff.

### **Plans for Securing and Upgrading Facilities**

BBC has a detailed plan to replace both the generator and gate motor:

1. **Planning and Procurement:**
  - Work with licensed vendors to identify and procure appropriate equipment that meets the facility's operational needs.
2. **Installation:**
  - Contract with certified contractors to safely install the new generator and gate motor, ensuring compliance with state and local regulations.
3. **Ongoing Maintenance:**
  - Implement a proactive maintenance schedule to ensure long-term reliability of the new systems.

By addressing these critical infrastructure needs, the Bobby Benson Center will continue to provide a safe, secure, and supportive environment for the youth we serve.

## **VI. Personnel: Project Organization and Staffing**



### **Proposed Staffing, Staff Qualifications, Supervision and Training**

The Bobby Benson Center (BBC) has an established and effective staffing structure to oversee and manage the proposed infrastructure upgrades. The current staffing pattern ensures appropriate expertise is allocated to support the replacement of the generator and gate motor while maintaining the center's day-to-day operations.

#### **Staffing for the Infrastructure Project:**

**Executive Oversight:** The Executive Director will provide high-level oversight to ensure the project aligns with organizational goals and funding requirements.

**Facilities Coordinator:** Responsible for coordinating with vendors, supervising the installation process, and ensuring compliance with safety and regulatory standards.

**Maintenance Team:** Trained staff members will support routine inspections, assist contractors, and maintain the new equipment post-installation. (Currently the team includes Executive Director, Facilities Coordinator and Per Diem Maintenance Staff)

**Service Capacity:** Upgrading critical infrastructure ensures uninterrupted services for all residents and supports the safety and security of the facility, particularly during emergencies.

### **Qualifications and Experience of Personnel**

**Executive Leadership:** The Executive Director has extensive experience in managing state-funded projects, overseeing facility operations, and ensuring compliance with grant and regulatory requirements.

**Facilities Coordinator:** The Facilities Coordinator is experienced in coordinating large-scale projects, with certifications in safety compliance and equipment maintenance. They have successfully overseen prior upgrades, including the renovation of the client dining facility funded by the State GIA in 2019.

**Maintenance Team:** Team members are certified in HVAC, electrical systems, and general maintenance, ensuring they are qualified to support the installation and upkeep of the new generator and gate motor.

**Administrative Staff:** The Grants Coordinator has a proven track record of managing funding requests and ensuring compliance with reporting requirements, providing administrative support throughout the project.

### **Supervision, Training, and Administrative Direction**

BBC is a licensed 30-bed Special Treatment Facility, certified by the Hawaii Department of Health. This licensure is crucial for ensuring that we meet the state's standards for operating a residential treatment facility.

**Accreditation: Commission on Accreditation of Rehabilitation Facilities (CARF):** BBC is fully accredited by CARF for the period 2022-2025. This accreditation acknowledges our commitment to maintaining high standards in facility operations, quality of care, and safety.

**Alcohol and Drug Abuse Division (ADAD):** BBC maintains accreditation with ADAD, ensuring compliance with their standards for youth residential treatment services. **Child and**



**Adolescent Mental Health Division (CAMHD):** BBC has long-term agreements with CAMHD to provide services to youth with mental health challenges, highlighting our qualifications in specialized care for youth.

**Experience with State Grants and Funding:** BBC has successfully managed state grants, including the **State GIA (2019)** for the renovation of client dining facilities, demonstrating our ability to comply with state funding requirements and effectively manage large projects.

These qualifications and accreditations ensure that BBC is well-equipped to handle the proposed infrastructure improvements and continue providing safe, high-quality services for at-risk youth.

### **Private Educational Institutions**

The Bobby Benson Center (BBC) is a **non-sectarian** organization and does not operate as a private educational institution. The requested grant will not be used to support or benefit any sectarian or private educational institution. BBC is a residential treatment facility focused on providing services to at-risk youth, and the proposed infrastructure upgrades (commercial generator and gate motor replacement) will directly enhance the safety, security, and operational capacity of the facility. These improvements are solely for the benefit of our treatment programs and the youth we serve.

### **Future Sustainability Plan**

In the event that the grant is received for fiscal year 2026 but not continued thereafter, the Bobby Benson Center (BBC) is committed to sustaining the benefits of the proposed infrastructure upgrades (commercial generator and gate motor replacement). To ensure continued operational stability and the long-term effectiveness of these improvements, BBC has developed a sustainability plan:

#### **1. Internal Funding and Budgeting:**

- BBC will allocate resources from its annual operational budget to support ongoing maintenance and repairs for the new generator and gate motor. This will include reserving a portion of funds specifically for infrastructure-related expenses.
- The Facilities Coordinator will prioritize maintenance tasks and budget for routine inspections and repairs to ensure the longevity of the systems installed.

#### **2. Leveraging Other Funding Sources:**

- BBC will actively pursue alternative funding opportunities, including applying for additional grants through state, federal, and private sources. **4. Cost Optimization and Efficiency Improvements:**

- BBC will continue to implement operational efficiency measures to reduce costs across other areas, ensuring that funds are available for the maintenance and operation of the new infrastructure. This may include streamlining administrative processes, reducing energy consumption, and exploring cost-effective solutions for ongoing facility needs.

- BBC will negotiate long-term service contracts with vendors for the new generator and gate motor to lock in favorable terms for maintenance and repairs. These contracts will help to minimize unexpected costs and ensure reliable support after the initial grant funding period.

By following this sustainability plan, BBC will ensure the continued functionality of the upgraded systems and maintain a safe, secure, and operational environment for our residents, even in the absence of future grant funding.
