DreamHouse, Inc is a local 501c3 solely dedicated to the support and progress of DreamHouse 'Ewa Beach Public Charter School. Founded in 2014 after years of community discussions and partnerships, we support the collaborative-built charter school innovatively educating traditionally underserved students in the Ewa Beach and Kapolei region. Our mission is to co-empower children to be affirmed in their individual identities, grounded in and committed to our island culture and community, and equipped with a 21st century skill set to be leaders within our community and state. DreamHouse is partnering with innovative non-profits on Oahu as we reimagine public education in the state of Hawai'i. Lastly, DreamHouse's mission continues to be community and parent involvement in planning and executing of the charter school. With a focus on traditional Hawaiian knowledge, parents know that their knowledge is valued and required. With this dynamic,

parents are an essential component of the school and including parents in our partnership actively confronts historic power inequities that exist within school systems. Over 90% of DreamHouse students identify as Native Hawaiian, Filipino, Hispanic, Asian-American, or 2 or more races. This year DreamHouse was able to open our new school building and are now actively working to outfit every room of our beautiful space. As DreamHouse's education leader often says, "This isn't just about bricks and mortar. It's about a commitment to our students, their futures, and our community."

A prominent project that defines DreamHouse is our *Environmental Technology for Future Ancestors Project*. This project is a culture and place-based education project designed to be an agent of change in the Hawaiian educational landscape. The ETech program engages students in the Rights of Nature on O'ahu by establishing robust connections in academic work based on lived experiences. Our goal centers on fostering an authentic educational environment that is embedded in the authentic fabric of its local environment. Led by Dr. Ryan Mandado, DreamHouse pedagogy is founded in a Two-Eyed place-based approach where students engage in Ancient Hawaiian technology while developing their emergent STEM skills. Two-Eyed approach recognizes simultaneous identities that DreamHouse students embody. With learning focusing on lived experiences, this project will show that strong social emotional learning leads to powerful and successful STEM education. Indigeneity is recognized as modern and acknowledge as innovative (Mandano, 2023). Through this project, DreamHouse students travel to *Honouliuli* and locations in the watershed to engage in meaningful environmental revitalization work.

For 5 years, DreamHouse has embarked on initial iterations of this ETech project with our collaborative non-profit partners *Purple Mai'a*, *Hui o Ho'ohonua* and Ule 'A Learning Center. This collaboration centers on the shared mission of empowering students in Hawai'i to learn and implement traditional Hawaiian knowledge in a way that values their identity and deepens their STEM learning and STEM educational experience. Pilots of our ETech project have flourished with active 'slippers on the ground' educational work in our neighborhood watershed.

Facilitating our students through culture and place-based work is reinforced when the classrooms they return to are equipped with the 21st century technology needed to make their education relevant and of benefit to the public. The purchase of these smart interactive boards for the classrooms will make learning inside and outside of the classroom dynamic and student centered.

The goals of this request are to:

- **Equitable Access:** Educational research advocates for a collaborative class environment to advance access. Students from diverse backgrounds demonstrate elevated academic performance in a collaborative environment where their voices are heard and their contributions can be front and center. Smart Technology, the multi-touch CreateBoards in the classroom allows equitable access and promotes a

sense of belonging and an elevated view of personal identity and personal responsibility.

- LEAD courses: One of the most unique aspects of DreamHouse's educational model is its Leadership Empowerment Agency and Development (LEAD) courses which encourage students to take ownership of their education and connect directly with local organizations and groups. Our new building and class design with our collaborative Touch CreateBoard will greatly enhance our technology learning with interaction among students, faculty and technology.
- Collaborative Learning: Collaborative Touch CreateBoard design promotes an active and affirmative learning environment. Students are more engaged, focused, and the collaborative work increases overall academic performance. For DreamHouse's community partnerships and the fundamental component of student collaboration, this type of interactive technology design underpins the very method and mission of our work.
- With our new school building that opened October 2024, the outfitting of classrooms with interactive CreateBoards is of utmost importance. In addition to our classrooms, we will also create a community gathering area in the Atrium with a large space Projector.
- Teamwork: All of the student field work centers on teamwork and communication with each other and with our non-profit partners. Having a collaborative classroom that continues the teamwork model is essential for student growth. With this, DreamHouse students are experiencing, practicing and learning teamwork, communication skills, technological sharing techniques and the 21st Century skills needed for their post high school education and careers.
- Student centered Teaching Methodology: Designed to promote active engagement, our student centered and group work oriented technology design allows students and teachers to engage in innovative and collaborative teaching strategies. This type of Touch CreateBoard arrangement provides students with the environment to feel empowered and teachers with the environment to support and elevate educational outcomes.
- Technology Use and Innovation: This place/project based collaborative Touch CreateBoard encourages the combination of digital tools and resources into our education. This type of interactive technology compels collaboration within groups of students and technology. Students are working with each other and with technology at the same time- only possible with the Smartboard technology.

- **Community Involvement:** Touch CreateBoard configuration allows for a welcoming and interactive 'Ohana meeting room while our non-profits and community come together. Our 20+ times a year family workshops, portfolio presentations, and community gatherings will become more professional and substantive with a supportive and community driven Touch CreateBoard environment.
- **Flexibility:** This Touch CreateBoard will allow for movement of student configurations and elasticity in rooms and within groups. Having these options allow the Touch CreateBoard purchases to meet new and perhaps unknown educational opportunities that arise in the future.
- **Student Health:** Touch CreateBoard promotes student safety, health and overall happiness as students work with and among each other and with their educators. With the proper support, these educational opportunities promote successful students.

The objectives of this request are to:

- **Secure New Touch CreateBoard for our New School Building:** Purchase and place a broad assortment of Touch CreateBoard pieces appropriate for daily collaborative education and for our community gatherings and planning.
- **Inaugurate Community Spaces:** DreamHouse has designated specific areas in our new building for parental and community collaboration. This Touch CreateBoard arrangement will encourage teamwork, group discussions, and project-based learning initiatives.
- **Public Benefit:** One of our collaborative non-profit partners has already requested assistance in using our space for their community work after school hours. With the installation of CreateBoards, we will enhance our public benefit and expand our reach into the community.
- **STEM Instruction and Learning:** Secure Touch CreateBoard that encourages collaborative hands-on STEM. Touch CreateBoard provides the space for students to engage with each other, with technology, and with all other STEM implements. DreamHouse students will be able to directly participate in these innovative learning opportunities.
- **Diversity and Inclusivity:** Creating a more integrate classroom that recognizes and celebrates our student diversity. With no one student culture/racial group representing more than 35% of the total student population, the active inclusive of all student voices is essential in our curriculum and class time.

- Environmentally Sustainable Classrooms to match our Environmental Restoration work: For students to see that environmentally substantiable Touch CreateBoard can provide students with the connection to an all-encompassing environmental approach to education.
- Durability: Select functional and durable Touch CreateBoard to maximize investment and reduce replacement
- Involve and engage our 'Ewa Beach and Kapolei Community: Involve local non-profits parents, teachers, and students to collect input. As with the foundation of our charter school, we will continue the community involvement in the present and future of our learning spaces.

The public service facilitated by the Smart Multi-Touch CreateBoard and supplies request is grounded in the overarching commitment to fostering community well-being and educational advancement. The interactive CreateBoards are designed to serve the diverse needs of our student population, transcending the confines of traditional academic settings. The facility's capacity and flexibility are strategically leveraged to benefit various community groups and organizations.

The Touch CreateBoard request is tailor-made to meet the challenges which DreamHouse Charter school faces. With over 90% of our students coming from a variety of ethnic, racial and economic backgrounds the utilization of technology to elevate their learning is paramount. While DreamHouse students have elected to attend our charter school to enhance their academic opportunities, we are doing our utmost to meet their academic needs. The Touch CreateBoard is a stimulus for inclusive learning environments, while catering to the diverse needs of students from different socioeconomic backgrounds. Our interactive technology enhanced classrooms provide educational opportunities that enhances Hawai'i public need for educational opportunities. While DreamHouse is rooted in our community with parental and extensive non-profit collaboration, the CreateBoard technology will benefit our students and position them to be innovators on Oahu.

Furthermore, the Touch CreateBoard request exemplifies a student centered educational model. We, at DreamHouse recognize that 21st Century skills are essential to the long-term success of our students and our community. These interactive wifi connected platforms provide personalized learning, access to rich online resources, and enhanced lessons. The interactive nature of our educational pedagogy in both technology and civic responsibility helps foster our sense of public purpose.

4. Describe the target population to be served; and

Of our current 600-student population, 95% of our students come from the underserved west side of Oahu. In 2025 we will reach full capacity and serve 700 students in grades 6-12th. We have 30-35% of the students qualify for Free/Reduced Lunch with another 35% of student families struggling to make ends meet. Over 90% of DreamHouse students identify as Native Hawaiian, Filipino, Hispanic, Asian-American, or 2 or more races. Representing the community's diversity is a top priority in the collaborative building of our charter school. 90% of our employees identify as either Native Hawaiian, Filipino, Asian, African American, or Hispanic. Employees who are from the community enable DreamHouse to better understand community issues and formulate solutions.

In addition to our racial/ethnic diversity and financial needs, 'Ewa Beach community has educational opportunity needs as only 20% of the population graduated college according to US census statistics. While census data might be unclear, the majority of our students will be the first in their family to attend university.

DreamHouse 'Ewa Beach Public Charter School is located in our new building in Kapolei, and students travel from around the island to attend. Most students come from the historically underserved west side of Oahu.

- Budget and finance team consult with smart board and CreateBoard companies to develop a detailed budget for purchase.
- Request updated quotes from 2-3 specific smart board companies, including Epson, LG, Optoma, BenQ, et al. Assess quality and cost-effectiveness.
- Establish Contract(s) with selected Company
- Secure contracts with selected vendors- clearly establish pricing, delivery, installation, schedules, and warranty terms.

- Keep project updates communicated to all stakeholders
 - Coordinate logistics for the delivery and installation of the new projectors, aiming for weekend or evening delivery and installation.

Quality Assurance and Evaluation Plan includes:

Quality Assurance:

- Inventory Check and Delivery Inspection: Ensure that all items are in stock and meet the quality standards before dispatch. This involves inspecting each piece of Touch CreateBoard for defects, damage, or imperfections.
- Order Confirmation: Confirm the delivery address, the correct items ordered, and the requested delivery date with the customer to prevent miscommunication.
- Vendor Accountability: Vendors accountable for delivering Touch CreateBoard that adheres to agreed-upon specifications. Ensure that all personnel involved in handling and transporting the Touch CreateBoard are trained on best practices for handling delicate/heavy items.

Evaluation Plan:

- Surveys and Question Evaluations: Through in person and online forms, regular feedback sessions with teachers and students to evaluate the functionality, comfort and satisfaction with the new Touch CreateBoard.
- Questionnaires and Reviews: Create, distribute and collect questionnaires to stakeholders to assess and review their experiences with the Touch CreateBoard and identify any areas for improvement.
- Usage Analysis: Assess usage of each category of Touch CreateBoard and create usage analysis chart.
- Maintenance Reports: Create online maintenance reports to gather information on recurring issues. Collate reports for Touch CreateBoard in of need adjustments or repairs. Evaluate recurring patterns of Touch CreateBoard usage in different spaces, including classrooms, collaborative areas, and common spaces, to ensure they are meeting intended purposes.
- Actuality vs Preliminary Goals: Equate evaluation and survey outcomes with preliminary goals and objectives. Assess implementation of new Touch CreateBoard success in enhance learning environments based on usage, surveys, questionnaires of teachers, students, administration, and community members.

Continuous Improvement Loop:

- Continuous Feedback: Establish and assess feedback loop, incorporating suggestions and concerns from stakeholder to make ongoing improvements to Touch CreateBoard and its usage.
- Open Changes: Be prepared and supportive of changing needs for educational Touch CreateBoard and incorporate additions or changes into potential additional purchases.
- Reviews: Maintenance will conduct regular reviews of the Touch CreateBoard's performance and administration and facilities team will assess the comments from our continuous feedback loop.

Through quality assurance, monitoring, and evaluation measures, DreamHouse, Inc will proactively monitor the quality of the ordered Touch CreateBoard and the delivery. We will promptly address any challenges or inaccuracies or damages in the process. Through our evaluation plan, all stakeholders will contribute to the long- and short-term evaluation. The continuous improvement loop will allow for reinforcements and changes as needed.

We have a 4-year history of securing external funding to continue our culture place-based work. The additional funding has become part of our yearly work, and we have secured assistance in locating and developing grants for our collaborative partnerships. In our early years, DreamHouse secured \$1 million of additional federal dollars for the growth and expansion, as well as securing Hawaii's first municipal bond to support the growth of a charter school. Our new school building opened just a few weeks ago, and our community is thriving with these educational successes.

We are currently funded by the Healy Foundation, The Yass Education Foundation, MIT Gender STEM Equity Grant, the Kosasa Foundation, and the James and Abigail Campbell Family Foundation. We have grant applications outstanding to NSF, Spencer Foundation, Building Hope Foundation, Honolulu GIA, and NOAA B-Wet. This is our first grant attempt for supporting the request for school Touch CreateBoard. If we are successful in securing this grant, it will bring great opportunities for expansion to our community.

One of our collaborative non-profit partners has already requested assistance in using our space for their community work after school hours.

We will seek additional funding for the technology purchases for the Makerspace, but no additional funding is anticipated for the Touch CreateBoard in future years.

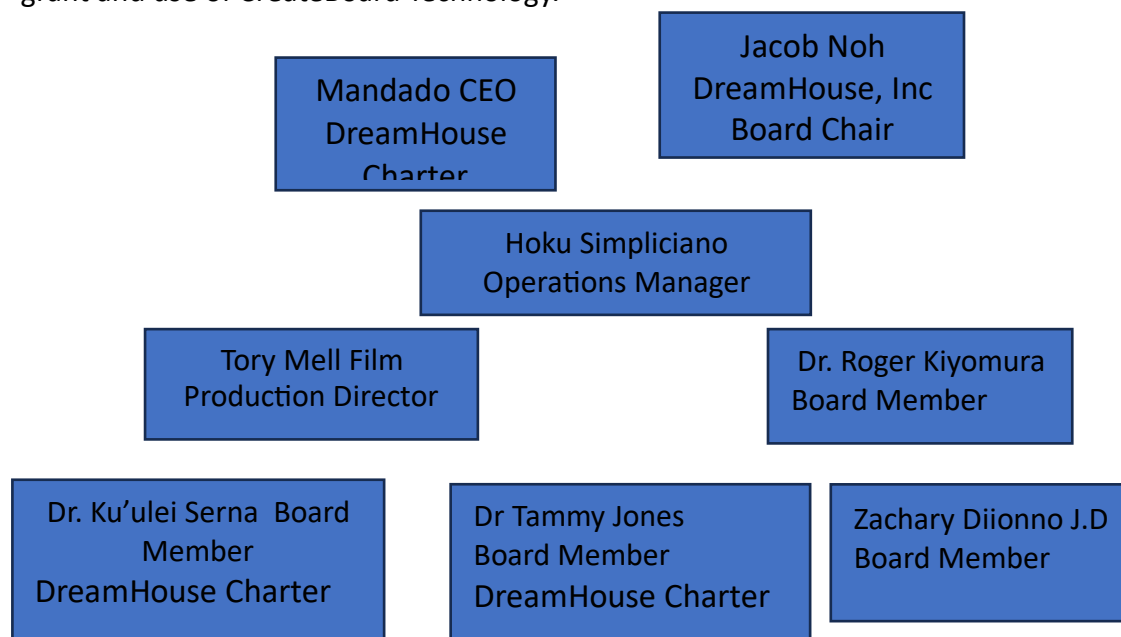
