Epilepsy Foundation of Hawaii

(2) The public purpose for the grant:

The public purpose for this grant is to enhance statewide epilepsy education, awareness, and support by increasing capacity through the addition of an outreach coordinator. This role will enable the Epilepsy Foundation of Hawaii to expand its reach, deliver seizure detection and first aid training, and provide critical services to individuals living with epilepsy and their communities across the state. By investing in this position, the grant will empower us to address the growing need for accessible resources,

education, and advocacy, ensuring safer, more inclusive environments for all Hawaii residents.

(3) The services to be supported by the grant:

The grant will support the continued expansion of public outreach and seizure recognition and first aid training across Hawaii. These efforts will target school personnel at public, private, and charter schools, as well as businesses, families, caregivers, and the broader community.

Additionally, the Epilepsy Foundation of Hawaii (EFH) will update and distribute seizure education materials to schools, neurology offices, community health centers, and hospitals statewide. These materials will ensure that individuals and organizations are equipped with accurate, accessible, and up-to-date information to foster safer, more informed environments for individuals living with epilepsy.

(4) The target group:

All ages.

(5) The cost of the grant and the budget: \$50,000 to help support a \$200,000 operating budget.

II. Background and Summary

1. A brief description of the applicants background:

Our mission: EFH leads the fight to overcome the challenges of living with epilepsy, accelerate therapies to stop seizures, and save lives.

Established in 1972, the Epilepsy Foundation of Hawaii (EFH) is a 501(c)(3) nonprofit organization dedicated to improving the lives of individuals affected by epilepsy across the state. EFH is the only organization in Hawaii exclusively focused on providing education, advocacy, and support for individuals with epilepsy, their families, and the communities in which they live. Importantly, EFH operates independently and is **not financially supported by the Epilepsy Foundation's national office**, ensuring that all programs and services are locally developed and tailored to meet Hawaii's unique needs.

According to <u>Charity Navigator</u>, EFH serves approximately **14,000 residents living** with active epilepsy—including **2,000 children**. EFH offers programs such as seizure recognition and first aid training, public awareness campaigns, and support services to foster a more inclusive and informed community.

Services Provided by EFH

EFH provides a wide range of impactful programs and services designed to educate, support, and empower those affected by epilepsy:

- Seizure Recognition and First Aid Certification Training
- Annual Hawaii Consumer Education Conference
- Talk Story Educational Seminars
- Monthly Support Groups
- Teens Speak Up, National Epilepsy Advocacy (Local Teen Sophia Owen has been selected out of 90 candidates to fly to Washington DC in March 2025)
- Linkage to Specialized Epilepsy Care
- Employment Advocacy
- School Advocacy
- School Personnel Training
- Curriculum-Based School Training
- Therapeutic Arts Program

Through these programs, EFH continues to address the critical needs of individuals living with epilepsy while promoting awareness, reducing stigma, and creating a safer and more inclusive Hawaii.

2. The goals and objectives related to the request:

The overall goal of this request is to increase targeted community seizure education and outreach. With only an executive director currently managing all operations and schools now requiring stricter eligibility guidelines for interns, this funding will enable the Epilepsy Foundation of Hawaii (EFH) to hire a contractor to expand outreach and program delivery.

Goal 1: Expand Seizure Education and First Aid Certification

Target: Formally educate and certify 300 individuals in FY 2025 through the Epilepsy Foundation's instructor-led Seizure Recognition and First Aid Certification course. **Objective:**

- Participants will be able to:
 - Define seizures and epilepsy.

- Identify correct and incorrect steps for helping a person experiencing a seizure.
- Determine when it is necessary to call emergency personnel (911).
 Purpose: Increase knowledge, skills, and confidence in applying seizure first aid across Hawaii's communities.

Goal 2: Strengthen Workforce Development Through Leadership Training

Target: Facilitate EFH staff and board participation in the annual Epilepsy Foundation Leadership Conference.

Objective:

- Create opportunities for staff and board members to:
 - Enhance connections with national partners.
 - Share tools and strategies for implementing community-based programs.
 - Strengthen EFH's ability to deliver essential services to people living with epilepsy.

Goal 3: Develop and Distribute Epilepsy Education Materials

Target: Create and disseminate epilepsy education support and resource packages to key healthcare providers, including:

- Kapi'olani Medical Center for Women and Children (Pediatric Neurology Offices).
- Comprehensive Epilepsy Centers at Queen's Medical Center and Hawaii Pacific Neuroscience.

Objective:

- Provide recipients with:
 - Accurate educational information.
 - Local resources to better support individuals with epilepsy.
 - A sense of hope and connection for patients and their families.

Goal 4: Increase Participation in the Hawaii Epilepsy Education Conference

Target: Sustain a 20% increase in participation in the Hawaii Epilepsy Education (Consumer) Conference.

Objective:

- Enhance accessibility and engagement by:
 - Expanding outreach efforts to underserved communities.
 - Incorporating hybrid (in-person and virtual) platforms to reach a broader audience.

3. The public purpose and need to be served:

Epilepsy is a neurological disorder characterized by recurrent seizures, which are caused by sudden surges of electrical activity in the brain. While 1 in 10 people will experience a seizure during their lifetime, epilepsy is diagnosed when an individual has two or more unprovoked seizures. Nationally, 1 in 26 people will develop epilepsy at some point in their lives.

Epilepsy in Hawaii

In Hawaii, approximately **14,000 residents** live with active epilepsy, including **2,000 children**, with approximately **700 new cases** diagnosed annually. Despite the prevalence of epilepsy, Hawaii faces significant challenges:

- Hawaii received a "C" grade among all states for the ratio of new Anti-Epilepsy Drug (AED) use and an "F" grade for access to neurology specialists.
- Many individuals with epilepsy experience delays in diagnosis and treatment due to limited access to specialists and long wait times.

Improving access to newer AEDs, increasing the availability of neurology specialists, and ensuring insurance coverage for epilepsy-related treatments are critical steps to improving care and outcomes for epilepsy patients in Hawaii.

National Data and Barriers to Care

The Centers for Disease Control and Prevention (CDC) reports that epilepsy patients often face significant barriers to care, such as unaffordable medications, limited access to specialists, and transportation challenges. These barriers contribute to higher rates of uncontrolled seizures and negative health outcomes.

In its report, "Suicide Among People with Epilepsy: A Population-Based Analysis of Data from the U.S. National Violent Death Reporting System, 17 States, 2003–2011," the CDC highlighted alarming statistics:

- The suicide rate among individuals with epilepsy aged 10 years and older is **22% higher** than the general population.
- Public health interventions are urgently needed to address the mental health challenges associated with epilepsy.

The **CDC's Healthy People 2020 objectives** further emphasize the importance of increasing the proportion of individuals with epilepsy and uncontrolled seizures who receive timely and appropriate medical care.

Collaboration for Improved Seizure Control

The Epilepsy Foundation's national center, in collaboration with UCB, conducted a study published in *Epilepsy & Behavior* examining factors related to improved seizure control and reduced hospitalizations. Key findings included:

- The use of newer AEDs was associated with better outcomes.
- Access to specialized epilepsy care significantly reduced emergency visits and hospital stays.

The Role of the Epilepsy Foundation of Hawaii (EFH)

As the only organization in Hawaii exclusively dedicated to supporting individuals with epilepsy, EFH provides critical education, advocacy, and support services. These include:

- Seizure Recognition and First Aid Certification Training.
- Annual Hawaii Consumer Education Conference.
- Monthly Support Groups for individuals and families.
- School Advocacy and Training to equip educators with the tools needed to support students with epilepsy.
- **Distribution of Educational Materials** to neurology offices, schools, and hospitals to ensure patients and caregivers have access to accurate and up-to-date resources.

EFH currently operates with just one executive director, underscoring the need for funding to hire an outreach coordinator to expand its reach and impact across the state.

Conclusion

Epilepsy is the fourth most common neurological disorder in the United States, yet it remains among the least understood and most stigmatized. In Hawaii, significant gaps in care and access to resources further exacerbate the challenges faced by individuals and families living with epilepsy.

By supporting the Epilepsy Foundation of Hawaii through the State Grant-In-Aid (GIA) program, the state will help ensure that individuals with epilepsy receive the education, resources, and specialized care they need. Expanding access to newer AEDs, improving outreach, and enhancing public awareness will create a safer, more inclusive, and supportive environment for all Hawaii residents.

4. Describe the target population to be served:

Target Population

1. Teachers and School Personnel

Young people spend approximately six hours a day in school for 180 days a year, making schools uniquely positioned to support the health and safety of children with epilepsy. This grant will enable the Epilepsy Foundation of Hawaii (EFH) to provide professional development and training to teachers and school personnel. These sessions equip educators with the knowledge and tools necessary to create safe and inclusive environments for students living with epilepsy and seizure disorders, ensuring they can thrive academically and socially.

2. Community Members

Seizures can happen to anyone, at any time, and it is essential for the broader community to know how to recognize seizures and respond safely and appropriately. This grant will support EFH's efforts to educate community members, including businesses, caregivers, and the general public, through seizure recognition and first aid training, fostering a safer and more inclusive society.

3. Adults Living with Epilepsy

Adults living with epilepsy face unique challenges, and EFH's longstanding education, outreach, and support services are designed to address their needs. This includes access to:

- Monthly support groups to find connection and comfort with others navigating similar experiences.
- Talk Story webinars and the Annual Consumer Conference, which
 provide opportunities to increase knowledge of epilepsy, stay informed
 about current treatments and trends, and access resources for managing
 their condition.

By targeting these key populations, EFH aims to create a safer, more inclusive, and better-informed community across Hawaii, ensuring that individuals living with epilepsy and those who interact with them are equipped to handle challenges with confidence and compassion.

5. Describe the geographic coverage:

Geographical Coverage

The Epilepsy Foundation of Hawaii (EFH) serves the entire state, providing education, advocacy, and support services to individuals and communities on all islands. While our physical office is located at the Aloha United Way Building at 200 N. Vineyard Blvd., Suite B-259, in Honolulu, the need for in-person outreach across the islands is critical.

To achieve this, EFH plans to hire an outreach coordinator who will visit communities on all islands, ensuring equitable access to our programs and services. This requires funding to cover travel costs, including airfare, accommodations, and car rentals. By having a dedicated outreach coordinator, EFH can expand its reach and deliver vital seizure recognition training, education, and resources to underserved and remote areas across Hawaii.

For communities in hard-to-reach locations, EFH will also utilize virtual connectivity to ensure that no one is left without access to epilepsy education and support. This hybrid approach allows us to maximize the impact of our services while addressing the unique geographical challenges of our state.

III. Service Summary and Outcomes

1. Describe the scope of work, tasks and responsibilities:

The Epilepsy Foundation of Hawaii (EFH) aims to expand its capacity to serve individuals with epilepsy and their communities statewide. This request seeks funding to hire an outreach coordinator who will strengthen EFH's ability to deliver critical education, advocacy, and support services across all islands. The outreach coordinator will be instrumental in increasing accessibility to EFH's programs by conducting in-person visits, facilitating training, and distributing educational resources to underserved and remote areas. Virtual platforms will complement in-person efforts to ensure outreach to even the hardest-to-reach locations.

Scope of Work, Tasks, and Responsibilities

1. Outreach Coordinator

- Conduct in-person visits to all islands, including schools, healthcare facilities, businesses, and community centers.
- Facilitate Seizure Recognition and First Aid Certification Training and other educational workshops.
- Distribute updated educational materials to neurology offices, schools, and hospitals statewide.
- Build partnerships with local organizations to expand EFH's presence and services.

2. Program Delivery

- Host monthly support groups for individuals and families affected by epilepsy.
- Conduct virtual and in-person educational seminars on topics such as new treatments, advocacy, and mental wellness.
- Organize the Hawaii Epilepsy Education Conference, transitioning it to a hybrid model for greater accessibility.

3. Data Collection and Reporting

- Track participation and geographic reach of all programs and events.
- Evaluate program effectiveness through surveys and feedback.
- Provide comprehensive reports to stakeholders and funders detailing outcomes and progress.

Conclusion

This funding will empower EFH to strengthen its statewide impact by addressing the critical need for epilepsy education, support, and advocacy. Through the addition of an outreach coordinator and a hybrid delivery model, EFH will reach more individuals, reduce stigma, and improve the quality of life for people living with epilepsy across Hawaii.

Q1: July – September

Planning and Setup

- Hire and onboard the outreach coordinator.
- Develop an outreach schedule for in-person visits to all islands.

- Update and print educational materials for distribution to schools, healthcare facilities, and community centers.
- Begin planning for the hybrid Hawaii Epilepsy Education Conference, including securing speakers and venues.

Program Delivery

- Conduct 2–3 Seizure Recognition and First Aid Certification Training sessions.
- Host 1 Talk Story webinar and 3 monthly support groups.
- Initiate outreach to underserved communities, focusing on rural and neighbor islands.

Evaluation

 Collect feedback from initial training sessions and support groups to refine delivery methods.

Q2: October – December

Outreach Expansion

- Begin in-person outreach visits to neighbor islands, including schools, businesses, and community organizations.
- Distribute updated educational materials to 20+ facilities, including neurology offices and hospitals.

Program Delivery

- Host the **Hawaii Epilepsy Education Conference** in November with hybrid in-person and virtual options.
- Conduct 4–5 Seizure Recognition and First Aid Certification Training sessions.
- Host 1–2 Talk Story webinars and 3 monthly support groups.

Evaluation

- Measure conference participation, including geographic and demographic data.
- Conduct post-conference surveys to assess satisfaction and knowledge gains.

- 3. **Develop and distribute updated epilepsy education packages** to 50+ healthcare facilities, schools, and community centers, fostering awareness and improving resources for individuals with epilepsy.
- 4. **Enhance statewide participation** in the Hawaii Epilepsy Education Conference, with a goal of increasing attendance by 20%.

Measures of Effectiveness

EFH will evaluate the effectiveness of its programs and services through the following metrics:

- **Training Evaluation Surveys**: Assess participant knowledge gain and confidence improvement after attending seizure recognition and first aid courses.
- **Participation Data**: Track demographic and geographic data for all events, ensuring diverse representation across the islands.
- **Feedback Mechanisms**: Collect testimonials and evaluations from healthcare providers, teachers, and community members receiving educational materials.
- **Conference Attendance**: Measure year-over-year growth in conference participation, with a focus on engagement from rural and underserved areas.

Additionally, they will provide essential IT services, including the setup and maintenance of computer systems, ensuring that our technological infrastructure remains robust and efficient. Their services costar listed in the proposed budget #7 IT equipment/service.

This collaboration not only equips our Outreach Coordinator with the necessary tools to perform effectively but also strengthens our community ties, fostering a supportive network among local nonprofits. By leveraging Hawaiian Hope's expertise in technology and resource provision, EFH can focus more on its core mission of serving individuals with epilepsy across Hawaii.

Furthermore, as part of our outreach strategy, EFH plans to partner with other nonprofits on neighboring islands to share space. These collaborations will provide the Outreach Coordinator with designated locations to operate from during island visits, facilitating the storage and distribution of printed educational materials and serving as a base for local engagements.

Through these strategic partnerships, EFH ensures that its facilities and resources are utilized effectively, supporting the successful implementation of the proposed services and extending our reach to communities throughout the state.
