II. BACKGROUND AND SUMMARY

1. A brief description of the applicant's background;

Founded in 2020 during the height of the COVID-19 pandemic, Hānai Kaiāulu emerged as a beacon of resilience, cultural revival, and environmental stewardship for the Wai`anae Coast. Led by Kumu Mikala Pieper, a respected cultural advisor and Hawaiian Language teacher at Nanakuli High and Intermediate school, this organization is rooted in the values of mālama `āina and mālama kaiāulu.

During a time of great uncertainty and disconnection, Kumu Pieper saw and urgent need to reconnect her community to the land and each other through `ike Hawai`i. Hānai Kaiāulu, meaning to "sustain the community", was born out of her deep commitment to perpetuating Hawaiian culture and fostering a sense of kuleana among the youth and families of West O`ahu.

Through hands-on learning, storytelling, and cultural practices, Hānai Kaiāulu empowers individuals to their ancestral knowledge and strengthen their bond with the `āina. From teaching students the art of haku mele to leading restoration projects that breathe life back into native ecosystems, Kumu Pieper ensures that every initiative reflects the interconnectedness of culture, environment, and identity.

As a Hawaiian language educator at one of the state's most underserved schools, Kumu Pieper has dedicated her career to uplifting her students and their families through cultural education and empowerment. Her work through Hānai Kaiāulu extends this mission, creating spaces where youth and community members learns to mālama the `āina and, in turn themselves.

Today, Hānai Kaiāulu stands as a transformative force in Wa`ianae, bridging the gap between tradition and innovation, culture and conservation. With the establishment of a native plant nursery, since there is none at all on the West side, we can reclaim our future of a thriving, resilient community grounded in aloha `āina.

2. GOALS AND OBJECTIVES RELATED TO THE PROJECT:

GOAL 1: Establish the First Native Plant Nursey on the West Side of Oahu on our farm at 87-828 Hakimo Road

To create sustainable, culturally grounded nursery that serves as a hub for propagating native Hawaiian plants and restoring the ecological balance of the region, while addressing the unique environmental and cultural needs of the Waianae moku.

- Objective 1.1: Construct a state-of-the-art native plant nursery equipped with propagation facilities, shade houses, irrigation systems, and restore existing infrastructure by the end of 2025.
- Objective 1.2: Propagate and distribute 5,000 native plants annually, including ohia lehua, kukui, ulu, a'ali'l and naupaka, to support reforestation, erosion control, and urban forestry projects.

GOAL 2: Strengthen the Connection Between People and `Āina Through Cultural Education

To honor the Hawaiian values of malama aina and kuleana by integrating cultural knowledge and practices into every aspect of the nursery's operation.

- Objective 2.1: Design educational workshops and volunteer programs focused on traditional Hawaiian approaches to cultivating and caring for native plants (through our partnership with Tipu Tipu Sustainability)
- Objective 2.2: Host quarterly community events, including workshops and planting days to engage 500+ community members annually in hands-on cultural and environmental stewardship.

GOAL 3: Empower the Wai'anae Coast Through Green Workforce Development

To provide expertise training and job opportunities in sustainable agriculture, horticulture, and conservation for the underserved communities od West O`ahu, creating pathways to self-sufficiency and environmental resilience.

- Objective 3.1: Develop a green workforce training program that teaches propagation techniques, including aquaponic systems, nursery management, and sustainable practices to youth, houseless individuals, and others in need of employment and reintegration opportunities.
- Objective 3.2: Employ 5 full-time staff and train 20+ volunteers annually in nursery operations and green job skills, fostering a future generation of environmental stewards.

GOAL 4: Restore Native Ecosystems and Combat Climate Change

To address the critical need for native reforestation and urban forestry on the west side of our island, improving biodiversity, reducing heat islands, and mitigating the impacts of climate change.

- Objective 4.1: Provide native plants for 10+ restoration projects annually across Nanakuli, Waianae, and surrounding areas focusing on degraded landscapes and areas vulnerable to erosion.
- Objective 4.2: Collaborate with other schools, nonprofits, and cultural practitioners to ensure that at least 50% of the landscape footprint consists of native plants grown specific to the area they are planted in.

GOAL 5: Perpetuate a Legacy of Environmental and Cultural Stewardship

To create space where future generations learn to malama aina, ensuring the `ike kupuna is preserved and perpetuated.

- Objective 5.1: Develop a Native Hawaiian cultural curriculum centered on the pilina between people and aina, incorporating oli, mo`olelo, and `ike kupuna.
- Objective 5.2: Engage 1000+ students annually through hands-on field trips, cultural field trips, cultural workshops, and service learning opportunities tied to the nursery.

This project will be a kipuka for West O` ahu, a space to restore native ecosystems, revive cultural practices, and inspire a sense of kuleana to care for the aina for generations to come. Together we will grow not just plants, but a thriving, interconnected, resilient community rooted in aloha aina and able to reclaim a sustainable future.

3. PUBLIC PURPOSE AND NEED TO BE SERVED

Our farm in Nanakuli serves as a vital gathering place and a safe space for the community; a sanctuary where people can come together, connect with one another, and heal through the land. In a region marked by socio-economic challenges, environmental degradation, and a lack of accessible resources, our vision is to restore and transform this space into a hub for cultural, ecological, and community resilience.

The farm's current infrastructure, while rich in potential, requires restoration and renovation to fully accommodate the growing needs of our kaiaulu. By establishing a native plant nursery, we will create dedicated workspaces and gathering areas where residents can actively engage in meaningful activities such as propagating native plants, learning sustainable practices, grow their own food in our aquaponic systems, and participate in

cultural workshops. These efforts will foster a deeper connection to the aina and each other, in a safe, inclusive space for individuals and families to unite in shared purpose.

West O` ahu currently lacks a native nursery leaving a significant gap in resources for rapid reforestation, wild fire mitigation, erosion control, urban forestry and cultural and public landscaping projects. By filling this void, we will not only combat climate and environmental challenges but also address the need for community-centered solutions. The nursery will provide economic opportunities for workforce development, environmental education, and cultural preservation, empowering residents with the tools to malama aina and uplift lahui.

In a time when safe spaces are more essential than ever, this project represents the power of transformation, that progress can be made when the seed is planted and nurtured...that growth is inevitable.

4. DESCRIBE THE TARGET POPULATION TO BE SERVED, AND

The native plant nursery will directly serve the residents of West O` ahu, a region home to the highest concentration of Native Hawaiians in the state and some of the most underserved communities on the island. This area faces significant socioeconomic challenges, including a poverty rate of over 20%, limited access to educational and financial opportunities, and environmental threats such as heat islands and massive erosion. The nursery will serve as a vital resource for addressing these issues while uplifting the community.

- 1. NATIVE HAWAIIAN AND LOCAL RESIDENTS:
- Over 70% of Nanakuli and Waianae's population identifies as Native Hawaiian or part-Hawaiian.
- The nursery will provide cultural and environmental resources that empower residents to reconnect with their cultural identity through malama aina and malama kupuna.
- 2. YOUTH AND SCHOOLS:
- With over 5,000 students enrolled in schools within the Nanakuli and Waianae districts, the nursery will create hands-on learning opportunities through school partnerships, field trips, and educational outreach programs.
- At least 1,000 students annually will participate in nursery-related activities, learning green job skills and gaining a deeper understanding of the importance of native ecosystems.
- 3. UNDERSERVED AND AT-RISK POPULATIONS:

- West O`ahu's houseless population is disproportionately high, with nearly 30% of O`ahu's unsheltered individuals living in this area.
- The nursery will serve as a safe, inclusive space where houseless individuals and those in transitional programs can gain workforce training in sustainable agriculture, propagation, and conservation, creating pathways to self sufficiency.
- 4. Local Farmers and Land Stewards:
- The Waianae coast is home to numerous small farmers and agricultural operations, many of whom struggle with access to affordable native plants for reforestation, erosion control, and soil improvement.
- The nursery will provide 5000+ native plants annually to support these efforts benefitting the land and those who cultivate it.
- 5. Broader Community Engagement
- The farm serves as a gathering place for the approximately 55,000 residents of the Waianae Coast. Community members will participate in workshops, tree planting events, lei making contests, Holiday celebrations, and many volunteer opportunies, fostering a collective sense of kuleeana for the land.

The nursery will not only provide direct resources to these populations but also offer a safe welcoming space where the community can gather, grow, and heal. By addressing the specific needs of these groups, we are creating long-lasting change for our mo`opuna.

DESCRIBE THE GEOGRAPHIC COVERAGE

This initiative will serve as a cornerstone for rapid reforestation, cultural revitalization, and draw visitors from across the islands, with its primary focus on the Waianae coast residents. There are approximately 55,000 individuals living here, including the largest concentration of Native Hawaiians in the State. This region is defined by it's unique challenges; extreme heat, eroding landscapes, urban sprawl, and access to critical environmental resources like native plants for reforestation and urban forestry.

While the nursery will be physically located at our farm in Nanakuli, its impact will extend far beyond:

- 1. Primary Service Area:
- The Waianae moku will benefit directly with the nursery supporting local restoration projects, community gardens, urban forestry, and landscaping needs. These efforts will provide solutions to address the extreme heat islands and degraded land conditions that disproportionately affect this region.

- All schools in this area, including public, private and charter, will participate in educational programs and hands-on activities.
- 2. Regional Reach:
- The nursery will contribute to reforestation efforts across West O` ahu addressing over 20% of O` ahu's land area that is ecologically degraded. Projects such as coastal sand erosion control, planting along roadways and highways will benefit from nursery stock.
- 3. Island-Wide Impact:
- The nursery will serve as a critical resource for native propagation and distribution for conservation efforts across O`ahu. By producing 5,000+ plants annually, the nursery will help meet the growing demand for native species needed to combat invasive plants, support biodiversity, and restore our natural landscapes.
- Partnerships with organizations on other parts of the island, such as urban forestry groups and state agencies, will amplify the nursery's reach and impact.

The scope of work for establishing the native plant nursery encompasses the planning, construction, operation, and ongoing community engagement necessary to make this nursery a thriving hub for environmental restoration and cultural preservation. Each task will be carried out with a commitment to excellence, sustainability, and inclusivity.

Phase 1: PLANNING AND DESIGN

 Task 1: Ekahi Enterprises to clear and haul debris to prep and clean areas for renovations to begin.

- Task 2: Collaborate with our partners at HAHOKO to develop a culturally grounded vision and operational framework for the nursery incorporating the values of malama aina and ike kupuna. To be overseen by Kumu Pieper, Neil Iida, and Harvey Tomaselli.
- Task 3: Restore greenhouse infrastructure, get screen shades replaced at 55%, 70%, 85% on 3 greenhouses specific to each growth stage of propagation. Restore/replace irrigation drip systems. Overseen by Tipu Tipu Restoration and Sustainability.

Phase 2: SPECIALIZED CONSTRUCTION AND INFRASTRUCTURE DEVELOPMENT

- Task 1: Build infrastructure, including:
- Propagation Areas: Equipped for germination and seedling care.
- Shade houses: Protect young plants from environmental stress while allowing for natural growth
- Irrigations Systems: Repair and replace existing dry fit drip irrigation
- Workspaces: Create safe accessible areas for staff, volunteers, and community workshops.
- Task 2: Install educational signage and interactive displays to highlight native species, their ecological importance, and cultural significance.
- To be overseen by Patino Graphics, Mana Graphics and Tipu Tipu

Phase 3: PROPAGATION AND NURSERY OPERATIONS

- Task 1: Begin propagation of native plants under direction of Tipu Tipu experts.
- Task 2: Train a team of 5 full-time staff members and 20+ volunteers annually in nursery management, propagation techniques, and sustainable practices.
- Task 3: Develop deeper partnerships with local schools, community based organizations, and conservation groups to distribute plants for restoration, landscaping, and educational outreach programs.

Phase 4: COMMUNITY ENGAGEMENT AND EDUCATIONAL PROGRAMS

- Task 1: Host quarterly workshops and events engaging over 500 participants annually in hands-on activities such tree planting, harvesting, moon planting cycles, seed propagation, aquaponic seed bed starters, and cultural practices.
- Task 2: Provide field trips, service-learning opportunities, and curriculum based programs tied to science, culture, and conservation.
- Task 3: Launch a public outreach campaign through our partnership with Pake Salmon and her Menehune Filmmakers NPO.

Phase 5: ONGOING MAINTENANCE AND EVALUATION

- Task 1: Establish rigid maintenance schedules and round the clock staff to ensure the health and vitality of nursery plants AND infrastructure. Training will be done and inspections carried out by Tipu Tipu Staff.
- Task 2: Monitor the distribution and impact of plants used in restoration projects and public landscaping, tracking metrics such as erosion reduction, biodiversity improvements, and community participation.
- Task 3: Conduct semi-annual evaluations of the nursery's operations, identifying areas for growth and incorporating feedback from staff, volunteers, and the community.

RESPONSIBILITIES

- Project Leadership: Neil Iida Project Overseer/Manager Mikala Pieper – Cultural Practitioner and Overseer HAHOKO, Mr Harvey Tomaselli, Director of Workforce Reintegration Tiputipu Restoration & Sustainability – Native Horticulture Expertise and training
- Farm Management: Natasha lida, Executive Director, Ho`inana A Me Ho`ola to coordinate construction, plant propagation, and daily operations with the support of staff and volunteers.

- Zero waste

Month 7-9: Nursery Operations Begin

- Train a core team of 5 staff members and recruit 20+ community volunteers for nursery operations and maintenance.
- Begin propagating native and Polynesian trees, grasses and plants.
- Establish educational signage and create materials for community engagement.

Month 10-12: Community Engagement and Distribution

- Host educational workshops and propagation training, engaging at least 100 community members.
- Distribute the first batch of 1,000 plants for use in reforestation, erosion control and landscaping projects.
- Partner with other schools and organizations to plan the next year's planting initiatives and educational programs.


