II. Background and Summary

Hawaii International Child Placement and Family Services, Inc., doing business as A Family Tree and PonoRoots Counseling Center, was established in 1975 as a nonprofit adoption and family services agency with the mission of supporting family permanency through culturally aware adoption and foster care services, and family and parenting counseling and support. Its mission also includes increasing equity and welfare by offering supportive, mother-lead family planning options for women and providing compassionate mental health assessment and treatment for all members of the 'ohana. Recognizing the evolving needs of the adults, families and children we serve, A Family Tree expanded its services to include counseling under the name **PonoRoots Counseling**. This addition reflected a broader commitment to holistic support for individuals, children and families, addressing mental health, trauma, and adjustment challenges beyond adoption. The name "PonoRoots" signifies a connection to Hawaii's values of balance, righteousness, and connection to one's roots. By integrating counseling services, A Family Tree evolved into a more comprehensive resource, offering therapeutic services that empower families and individuals to navigate life's challenges with resilience and cultural sensitivity. This expansion marked a significant enhancement of A Family Tree's mission, reinforcing our dedication to nurturing healthy, thriving families in Hawaii and beyond.

2. The goals and objectives related to the request;

Goal

- To build Hawaii's behavioral health capacity by offering students a preceptorship program that provides training and hands-on experiences essential to becoming licensed mental health therapists.
- To support the future of Hawaii's mental health landscape by supporting future local mental health specialists, providing increased opportunity for work in and for Hawaii.
- To reduce barriers to mental health by providing lower cost options for mental health treatment, provided by trained specialists, under the supervision of licensed, local experts.
- To increase access to parent support in the form of parent training, using systems created by someone who has been working with local families for more than 30 years.

Objectives over 12 months

- 1. PonoRoots Counseling will train a minimum of 15 students.
- 2. Students will receive 10 hands-on training hours per week during the preceptorship program, including practical skills and knowledge under supervision of an experienced practitioner in the field.
- 3. An estimated 200 children will receive pro bono or reduced-rate mental health treatment, or their families will receive parental training.
- 4. An estimated 100 individuals will receive support for trauma and or domestic violence.
- 5. An estimated 100 couples will receive parenting support directed towards reducing child harm.
- 6. PonoRoots Counseling will hire two (2) licensed and/or doctoral level mental health professionals (preceptors) (LMFT, LCSW, LMHT, or PhD) to support the supervision and training of the 15 mental health graduate students.

3. The public purpose and need to be served;

Many children and families in Hawaii face unique challenges that require culturally competent, specialized care. Hawaii's diverse population, including individuals from various ethnic backgrounds, often experiences mental health issues intertwined with cultural factors. The prolonged impact of the COVID-19 pandemic has exacerbated feelings of isolation, anxiety, and stress among youth, contributing to academic and emotional struggles. Hawaii also has one of the highest youth suicide rates in the nation, underscoring the urgent need for readily available therapeutic services to address these crises. Expanding the pool of trained therapists ensures Hawaii can provide personalized, culturally sensitive care to support children and families, particularly those affected by trauma and collective grief.

The statewide shortage of mental health professionals further compounds these challenges. Hawaii's high youth suicide rates, along with the emotional toll of recent events like the Maui wildfires, have created an urgent need for expanded services. Many families affected by the fires have experienced significant loss, requiring specialized therapeutic care. In addition, the ongoing effects of the pandemic have left many children in need of timely intervention for their mental health struggles. With a limited number of trained therapists statewide, Hawaii's ability to respond to the needs of at-risk populations is constrained. Unfortunately, PonoRoots is forced to turn away a few dozen interns each semester who desperately need preceptor-guided learning experiences to become licensed mental health therapists. Currently, interns are trained by the lead clinician, which limits the number of interns being served each semester as training in the field of mental health necessitates 1-to-1 supervision. Increasing the capacity to train licensed therapists will enable PonoRoots to meet the growing demand for mental health services, providing consistent care and ensuring that children and families across the state receive the support they need to heal and build resilience.

PonoRoots receives referrals from pediatricians, family law attorneys, crisis centers, school counselors, pastors, domestic violence shelters and the Veteran's Administration, seeking mental health support for the children and families they serve. Callers regularly state that they have been seeking support often for months, and that rather than receiving appointments, they are put on wait lists or offered telehealth at best. While telehealth may suffice for many things, children do best with face to face support. PonoRoots has the physical space and ability to treat more waiting children and families.

4. Describe the target population to be served:

This program would target current graduate students and pre-licensed staff with a degree in psychology, social work, marriage and family therapy, and related fields, as well as individuals who are in the process of obtaining their licensure in the same, but need supervised clinical experience. This program would also attract individuals looking to specialize in areas such as trauma, adoption, foster care, fetal alcohol spectrum

disorder, domestic violence, LGBTQIA, or culturally competent therapy, particularly those interested in working to address the mental health needs of children and families.

5. Describe the geographic coverage:

PonoRoots serves children and families across the state of Hawaii offering telehealth for those clients residing on Kauai, Molokai, the Big Island, Maui, or Lanai and offers face to face as well as telehealth for clients living on Oahu. Historically the organization has served communities on all islands with face to face programs, and we plan to increase face to face work to all islands in the future.

Staff will work with current university partners offering advanced mental health degree programs to recruit student interns for the preceptorship program, including University of Hawaii at Manoa, Hawaii Pacific University, Chaminade University, National University and Touro University.

Student Interns

Staff will review CVs and interview interns expressing interest in the program, selecting up to six (6) student interns per semester. Once selected, interns will receive the rare opportunity to gain valuable hands-on experiences and practical skills, such as:

- Shadowing with licensed therapists, learning the intricacies of a therapy practice
- Receiving hands-on training from a practicing therapist, including client intake and documentation, developing and conceptualizing therapeutic cases, and gaining in-depth knowledge of a wide range of mental health conditions and diagnoses.
- Guided clinical training with mainland experts in a variety of treatment-relevant topics.
- Engaging in opportunities to conduct client sessions under supervision, receiving the critical training essential to complete graduate degrees
- Participating in weekly group and individual supervision provided by the clinical director, who will oversee the intern's client caseload and offer guidance on therapeutic interventions.
- Referring a client out and procedures for reporting a case for suspected abuse or neglect
- Coding for insurance purposes
- Managing challenging cases and when to terminate a client

- Conducting child play therapy and when to consider a client for fetal alcohol spectrum disorder treatment
- Working with diverse populations, including transgender awareness and LGBTQIA populations

Pre-licensed Staff

PonoRoots will work with pre-licensed staff, primarily consisting of former interns who select to remain with PonoRoots Counseling Center (PRCC) under the continued direct supervision of the clinical supervisor, as well as other PRCC licensed staff. These individuals will continue to receive the same access to training as the interns (stated above) as well as the ability to conduct therapy under supervision but often independently, providing them with extensive opportunities to gain experience. They will also participate in weekly group and regular one-on-one supervision sessions with the clinical supervisor.

2. Provide a projected annual timeline for accomplishing the results or outcomes of the service;

If awarded State Grant-in-Aid, PonoRoots will immediately draw down on funds to hire additional key personnel essential to expanding the preceptorship program, with 100% of funds fully expended within 12 months of receiving the Notice to Proceed.

PonoRoots will assess student performance through supervisor evaluations, client feedback when applicable and self-reflection, ensuring alignment with professional competency standards. Regularly scheduled supervision sessions, both individual and group-based, will incorporate case reviews, progress tracking, and constructive feedback to support skill development. Staff will evaluate the preceptorship program through surveys and/or focus groups with students, supervisors and stakeholders to identify strengths and areas for improvement. This data will be summarized and discussed with preceptors to ensure the Goal and Objectives of this project are met on time and with fidelity.

A Family Tree and PonoRoots Counseling Center are well-positioned to expand the preceptorship program, leveraging decades of experience and a strong commitment to cultivating Hawaii's next generation of licensed mental health therapists. Since 1975, A Hawaii International Child/A Family Tree has been dedicated to supporting families and children, building a legacy of trust and service in the community. CEO Kristine Altwies, with over 30 years of experience in family-centered care, established PonoRoots Counseling Center to address the growing need for mental health services, inspired by her deep understanding of the challenges and resilience she has witnessed in families across Hawaii.

PonoRoots Counseling Center is a group practice rooted in family systems theory and enriched by evidence-based, supportive therapeutic approaches tailored to meet diverse client needs. The center's multidisciplinary team provides comprehensive mental health care, ensuring interns are exposed to a wide variety of cases and therapeutic modalities, including work with individuals, couples, families, and groups. The center's existing preceptorship program offers structured, hands-on training, emphasizing client documentation, case formulation, therapeutic interventions, and a nuanced understanding of mental health diagnoses. Interns also benefit from weekly group and individual supervision with the clinical director, fostering professional growth and ensuring high standards of care.

By expanding its preceptorship program, PonoRoots Counseling Center aims to address Hawaii's critical shortage of licensed mental health professionals. The organization's established infrastructure, experienced leadership, and commitment to professional development provide a strong foundation for this growth. The expanded program will focus on increasing training opportunities, enhancing supervision capacity, and incorporating advanced topics such as cultural competency and the unique mental health needs of Hawaii's diverse populations. Through this expansion, PonoRoots will play a vital role in building a sustainable pipeline of skilled therapists equipped to serve Hawaii's communities with compassion, cultural sensitivity, and clinical excellence.

PonoRoots rents a three-story building at 1632 S. King Street, which serves as the organization's main headquarters, providing ample space for a range of services, including counseling through PonoRoots Counseling Center. The facility is centrally located within the urban core of Honolulu and is accessible by public transportation. The facility is only a few miles away from Downtown Honolulu and the University of Hawaii at Manoa.

1. Proposed Staffing, Staff Qualifications, Supervision and Training

Kristine Altwies, MA/LMFT (PhD candidate in marriage and family therapy) – Ms. Altwies was born and raised in Detroit and has spent the last 35 years in Hawaii. She holds a Bachelor of Arts degree from Kalamazoo College, a Master of Arts degree in Marriage and Family Therapy from Argosy University, and is completing a Ph.D. in general systems theory, marriage and family therapy at University of Louisianna, Monroe. She holds certifications in play therapy, trauma-informed treatments, eyemovement, desensitization reprocessing (EMDR), fetal alcohol spectrum disorders (FASD), and couples therapy among others. For 30 years Ms. Altwies lead Hawaii International Child Placement and Family Services, Inc. (HIC), a local nonprofit organization dedicated to serving Hawaii's families and children. In 2019 Ms. Altwies founded PonoRoots after noting a need for more trauma-informed, child-centered, family therapy in Hawaii. Regarding her desire to build a vibrant therapy community in which hands-on supervision is a key component Kristine credits her time at Catholic Charities, Hawaii. As a student therapist Kristine was given the opportunity to work directly with felons who had committed sexual offenses and this opened her eyes to the idea of forgiveness and community.

Kristine is a mother of six children, three of whom she adopted. She serves on the board of Holt International Children's Services in Oregon and was appointed by Governor Lingle to the Committee to Protect Reproductive Rights. Her accomplishments include being named a "30 Under 30" awardee by *Pacific Business News* and being recognized as a Pacific Century Fellow. She was also honored as an Angel of Adoption by the Congressional Caucus on International Adoption and received the Honolulu OWL NP Woman Leader of the Year award. Kristine hosts a podcast

called *A Really Good Enough Parent* and is widely regarded as the most frequently cited expert in local media for print and television adoption stories. Kristine will oversee this capacity building preceptorship program.

Kapi'i DeMello, Ph.D., MSCP, MFT-I – Ms. DeMello was born and raised in Hawaii and graduated from Iolani School. She holds a Bachelor of Science Degree in Psychology with a minor in Hawaiian Studies, and a Master of Science Degree in Counseling Psychology with an emphasis in Marriage and Family Therapy from Chaminade University of Honolulu. She received her doctorate degree (Ph.D) in Organizational Leadership with an emphasis in Indigenous Peoples from Chaminade University. Ms. DeMello has 10 years of experience working with children in a variety of settings. She holds a certificate of training in Brain Development in Children: Neuropsychology and the Therapeutic Power of Play. She has experience working with people of Native Hawaiian descent, utilizing culturally sensitive practices and approaches along with Hawaiian values and understanding. Her clinical work has emphasized cultural awareness and has been with individuals and family members of those who have been diagnosed with ADHD and anxiety. She has conducted parent workshops on the effects of Covid on children, teens, and young adults, and the importance of social competency for school age children.

Charles "Chuck" Kamai, MA/LMFT, CSAC – Mr. Kamai was born and raised in Hawaii and graduated from Kamehameha Schools. He holds a Bachelor of Arts degree in Psychology from Argosy University; a Master of Arts degree in Marriage and Family Therapy from Argosy University with Licensure in the State of Hawaii and is a Certified Substance Abuse Counselor through the State of Hawaii, Department of Health, Alcohol and Drug Abuse Division. Mr. Kamai spent ten years employed in various roles within the substance use disorder field in various local mental health organizations. He holds numerous certifications in a variety of mental health theories and interventions. At PonoRoots Mr. Kamai provides direct client work to couples and individuals dealing with trauma, substance abuse, domestic violence and childhood trauma-related issues.

Interns completing the preceptorship program will have options to remain on staff under the continued direct supervision of the clinical supervisor, building a school-to-workforce pipeline that builds capacity for PonoRoots to serve a greater number of at-risk children and families. Alumni will be engaged through a professional network, encouraging donations and mentorship to support future cohorts. By leveraging these strategies, PonoRoots Counseling Center will maintain and expand its preceptorship program while continuing to build capacity for Hawaii's mental health workforce.
