The Hawai'i Parkinson Association (HPA) has already set into motion multiple and free maintenance programs for these participants to maintain their progress once the program has been completed. We are requesting the State of Hawai'i Grant In Aid to fund the SPEAK OUT! Therapy portion of this project secondary to the current Medicare 2025 cuts and the potential end of Medicare coverage for speech therapy telehealth services that is projected to occur at the end of March 2025. Due to these telehealth changes, many individuals on our outer islands will no longer have access to these specialized programs. In addition, with the reduction in Medicare reimbursement, it will become even more difficult for Hawai'i to attract Speech Pathologist specializing in Parkinson' Disease, leaving our Hawai'i community without the help they need. Our goal is to make sure the people of Hawai'i living with Parkinson's Disease do not lose their voice and can receive the services that are vital to their day-to-day life. Please join us in helping those with Parkinson's Disease here in Hawai'i regain and maintain their voice!



The Hawai'i Parkinson Association affirms the grant will be used for a public purpose pursuant to Section 42F-102, Hawai'i Revised Statutes.

II. Background and Summary

1. The Hawai'i Parkinson Association (HPA) is a non-profit *volunteer* organization comprised of people with Parkinson's Disease, caregivers, family members, healthcare professions, educators, and leaders in the business community. The Hawai'i Parkinson Association was first established in 1996.

<u>Mission:</u> The mission of the Hawai'i Parkinson Association is to positively impact the lives of people affected by Parkinson's through support, programs, education, and other services.

What we do:

- Assist and support people with Parkinson, caregivers, family and friends to live their best lives
- Educate patients, caregivers, families, friends, medical professionals, and the public about Parkinson's Disease
- Connect those with Parkinson's Disease to local, state, national, and international resources
- Support ongoing research in finding the cause and a cure for Parkinson's Disease

What we achieved in 2024:

- Development and/or operation of 15 support groups on Kauai, Oahu, Maui,
 & Big Island with 1500 people in attendance
- Operation of a brick-and-mortar Resource Center on Oahu providing information and counseling for individuals with Parkinson's Disease weekly, open to the public 3 days a week
- Hosted an educational symposium about exercise, medications, diet, and other topics regarding living well with Parkinson's Disease, with 210 people

- Participated in 21 outreach events to bring awareness to Parkinson's Disease here in Hawai'i
- Provided newsletters including information regarding Parkinson's Disease in Hawai'i and beyond to 21,600 people
- Assisted in training 35 professional exercise instructors to help design and implement exercise classes for those with Parkinson's Disease here in Hawai'i
- Partnered with local speech pathologists to provide 96 free weekly group speech exercise classes for individuals with Parkinson's Disease who have completed the SPEAK OUT! program (a specialized speech therapy program for individuals with Parkinson's Disease)
- Began preparations for aiding to host/support the International Congress of Parkinson's Disease and Movement Disorders as they will be holding a convention in Honolulu, Hawai'i October 5-9, 2025, in which specialists from around the world gather to discuss research and progress regarding Parkinson's Disease
- 2. The Hawai'i Parkinson Association (HPA) proposes the implementation of specialized speech therapy program for individuals with Parkinson's Disease. This program will provide virtual speech therapy utilizing the SPEAK OUT! Therapy program (Parkinson's specific speech therapy program) to 75 individuals across the Hawai'ian Islands over a 12-month period free of charge. This program will eliminate the dilemma and effects of the 2025 Medicare cuts and Congress's proposed end of telehealth services for 2025 for speech therapy services, which are estimated to reduce specialized services for those with Parkinson's Disease here in Hawai'i dramatically.
- 3. Currently many individuals with Parkinson's Disease in Hawai'i rely on speech therapy telehealth services, due to either no access to a specialist on their islands or due to reduced mobility making leaving the home to seek treatment difficult and taxing. Congress has proposed Medicare cuts/changes, which may no longer allow telehealth options for speech therapy and will cut reimbursement rates, discouraging specialists in the field to provide care for those with Parkinson's Disease here in Hawai'i. As of now, we only have an extension (H.R. 10545) for speech therapy telehealth coverage until March 2025. Under the current political environment, it is projected the new Congress will *not* extend this service past March 31,2025, limiting access to specialized speech therapy for those with Parkinson's Disease here in Hawai'i. With limited telehealth options, embarrassment & depression over the inability to communicate leads to social isolation, causing these individuals to no longer seek out help for not only speech problems but more life-threatening issues.

The SPEAK OUT! program, established in 2010 by the Parkinson Voice Project (PVP) and located in Richardson, TX, is a *specialized* program designed for individuals with Parkinson's Disease. It has been researched and successfully offered by PVP via telehealth with success for the past 5 years. We are modeling our program for Hawai'i after their flourishing endeavors and with their support. An

article in the American Journal of Speech-Language Pathology (March 2024), supports the effectiveness of the SPEAK OUT! program to improve speech impairments with those with Parkinson's Disease including positive effects from those receiving the program via telehealth. Along with this proposed individualized program, we have already established a maintenance program to aid in helping these individuals maintain their progress including 2 weekly speech exercise classes & 2 singing class/monthly, all free to the participants after completing the SPEAK OUT! Therapy program. Logopedics Phoniatrics Vocology (2021), revealed participation in a group maintenance speech session was positively correlated with the level of improvement 1-yr post completion of the program.

Our program will provide these telehealth services *free* to individuals with Parkinson's Disease in Hawai'i. Your voice gives you power and control over your life. Without the ability to communicate, these individuals will fall prey to other health declines, including mental health issues and life-threatening issues such as aspiration pneumonia, which accounts for 70% of the mortality rate for individuals with Parkinson's Disease. Our goal is to make sure the people of Hawai'i living with Parkinson's Disease do not lose their voice and can receive the services that are vital to their day-to-day life, by helping them *regain* and *maintain* their voice!

- 4. The targeted population is any individual with a diagnosis of Parkinson's Disease or Parkinsonism, with an identified/diagnosed speech/voice impairment. Per the Lancet Neurology Journal is the 2nd most common neurodegenerative disease in the world. The Queen's Medical Center reported that Parkinson's Disease affects over 8,000 individuals here in Hawai'i and that this number is expected to double to 16,000 individuals in the next year. According to Standford Medicine (2024), more than 90% of individuals with Parkinson's Disease will have speech impairments, placing them at risk of losing the ability to communicate with others, the ability to care for themselves, & negatively impacting their quality of life.
- 5. This program will be available to any resident in Hawai'i diagnosed with Parkinson's Disease with a speech/voice impairment. The program will be accessible from all inhabitable Hawai'ian Islands via a virtual service delivery model (aka: telehealth).

III. Service Summary and Outcomes

1. The Hawai'i Parkinson Association will hire a contracted Speech Pathologist(s) specializing in Parkinson's Dysarthria (speech impairment) and certified in the SPEAK OUT! program to conduct the assessments and administered treatment sessions via telehealth services across the of Hawai'ian Islands. All individuals interested in the program will need a diagnosed/identified speech impairment by their physician with a recommendation of speech therapy. A physician order will be required to determine eligibility for each participant, reporting an existing speech/voice impairment. Participants will be accepted on a first come first serve basis, pending they meet the qualifications above.

Each participant will be provided with SPEAK OUT! Therapy workbooks through a secured, in-kind donation from the Parkinson Voice Project. All participants will

receive one (1) formal speech pathology assessment and be provided with therapy 2x/weekly for 4-6wks. The duration of therapy will be dependent on the severity of the patient's speech/voice at the time of the assessment and determined by the speech pathologist. On average most individuals will need a minimum of 4 weeks, but most can meet their goals by week 6. On occasion, individuals with more severe symptoms may require 8 weeks of treatment. This time frame will be determined on an individual basis by the Speech Pathologist, specializing in Parkinson's Disease, during the initial assessment. All participants will then receive a 6wk follow-up appointment following their last treatment session to assess maintenance of their progress.

Upon completion of the 4-6 weeks SPEAK OUT! Therapy program, participants will be invited to join a *free* virtual weekly speech therapy maintenance exercise classes led by a Hawai'i licensed Speech Pathologist through a secured in-kind donation. In addition, the participants will be invited to participate twice a month in a *free* singing exercise class led by a Musical Director with the assistance of a licensed Speech Pathologist, funded through a secured, in-kind donations by both leaders, to aid in the participants' maintenance and carryover of their progress. Participants will also receive access to an E-Library (online library) given to them access to other free resources donated by secure, in-kind donations from the Parkinson Voice Project.

- 2. The project will be completed over a 12-month period.
 - a. <u>Month 1</u>- The first month will be spent marketing the program & recruiting participants. Marketing will be conducted by the Hawai'i Parkinson Association through a secured, in-kind donations including but not limited to, monthly newsletters, social media, media interviews, emails, flyers, support groups, and press releases.
 - b. <u>Month 2 through 11</u>- Eight to ten participants will begin therapy *each* month over the course of 10 months until all 75 individuals have been assessed/treated, allowing at least 6 weeks to pass after the final group of participants for the purpose of evaluating them for their 6wk follow up session.
 - c. <u>Month 12</u>- The final month will be spent organizing & preparing the data for the grant report to show the success of the program to the State as well as the Hawai'i Parkinson's Community through Hawai'i Parkinson Association marketing avenues.

This is a projected timeline and the number of participants per month may vary based on available participants at that time; however, our goal is to reach 75 participants by the end of the program (grant cycle).

- 3. Quality Assurance and evaluation plans for this program are as follows:
 - a. A Participant survey will be conducted by the Hawai'i Parkinson's Association on every patient at the completion of the program to measure and evaluate the participant's experience and confirmation that services were provided as outlined.
 - b. Upon completion of the program, the contracted Speech Pathologist will provide a summary of progress across the following assessments.
 - i. Voice Handicap Index
 - ii. UCLA Loneliness Scale

- iii. The MDS (Movement Disorder Society) -sponsored Revision of the Unified Parkinson's Disease Rating Scale (Part 1, Sections: 1.3 Depressed Mood, 1.4 Anxious Mood, 1.5 Apathy; Part 2- Sections: 2.1 Speech, 2.2 Saliva and Drooling, 2.3 Chewing and Swallowing; Part 3-Sections: 3.1)
- Invoices will be required for all services performed by the contracted Speech Pathologist on each participant to provide a record of the assessment and number of treatment sessions provided
- d. The Speech Pathologist(s) hired will hold the following license(s) and certification(s) which each entail their own internal quality assurance guidelines:
 - a. State of Hawai'i Speech-Language Pathology License
 - b. American Speech-Hearing-Language Association Certificate of Clinical Competence
 - c. SPEAK OUT! certification verified by the Parkinson Voice Project
 - d. >/= 1 years' experience working with individuals with Parkinson's Disease
- 4. The measures of effectiveness for the Hawai'i Parkinson Association proposed SPEAK OUT! Speech Therapy program are as follows:
 - a. Did 75 individuals receive assessments and receive the full treatment program? Data provided by invoices from the contracted Speech Pathologist and Participant surveys.
 - b. Were the Participants satisfied with the program and progress made? Data provided by Participant surveys.
 - c. Did the individuals make progress? Data provided by the contracted Speech Pathologist in the following areas:
 - i. Voice Handicap Index
 - ii. UCLA Loneliness Scale
 - The MDS (Movement Disorder Society) -sponsored Revision of the Unified Parkinson's Disease Rating Scale (Part 1, Sections: 1.3 Depressed Mood, 1.4 Anxious Mood, 1.5 Apathy; Part 2- Sections: 2.1 Speech, 2.2 Saliva and Drooling, 2.3 Chewing and Swallowing; Part 3- Sections: 3.1)

It is projected that participants will improve speech/voice function to communicate wants/needs within functional limits to complete activities of daily living successfully, maintain personal/professional/healthcare relationships, and improve overall quality of life. This program will keep participants connected with their community and the additional resources here in Hawai'i for individuals living with Parkinson's Disease. It will give them back their voice and control of their lives!

- 3. Other sources of funding Hawai'i Parkinson Association is seeking for fiscal year 2026 are listed below:
 - a. The Hawai'i Parkinson Association receives funding through event corporate sponsorships and personal donations.
 - b. Additional Grants Requested:
 - i. The goal is to have the project funded by the State *entirely*, but we are applying for other grants in case we only receive partial funding from the State of Hawai'i Grant In Aid.
 - ii. If full funding is provided by *all* grants, then the project will increase the number of participants from 75 to 139 participants. In this instance, we would hire 2 part-time Speech Pathologists (20-24 hours/week) to cover the caseload, if needed.
 - iii. Hawai'i Parkinson Association is applying for 3 private grants to partially fund this project. All additional grants are currently pending as applications have been submitted but no funds awarded to date. Grant limits do not allow us to request full funding from any one of the following organizations. Below are the funds requested for each grant proposal we have submitted:
 - 1) Atherton Family Grant- \$28,125.00 (will cover the SPEAK OUT! Therapy program for 25 individuals)- grant limit \$30,000
 - Cooke Foundation Limited Grant- \$19,125.00 (will cover the SPEAK OUT! Therapy program for 17 individuals)grant limit \$20,000
 - 3) Parkinson Foundation Grant- \$24,750.00 (will cover the SPEAK OUT! Therapy program for 22 individuals)- grant limit \$25,000
 - c. *In-kind Donations* for this proposed project valued at \$22,708.00 have already been *secured*. In-kind donations are outlined below:
 - i. SPEAK OUT! Therapy Workbooks (x75 @ \$100= \$7500) donated by Parkinson Voice Project
 - ii. Weekly Maintenance Speech Group Exercise classes upon

- completion of the SPEAK OUT! Therapy program led by a licensed Speech Pathologist, 2 classes offered every Wednesday (104 classes in 1 year @\$75/class= \$7800)-donated by 4 local Speech Pathologists
- iii. Marketing the Program (\$40/hr-1hr/wk for 1 year= \$2080) donated by Hawai'i Parkinson Association volunteers
- iv. Musical Director for Singing Exercise class (\$24/hour-72 hours/year= \$1,728)- donated by local Musical Director and volunteer for the Hawai'i Parkinson Association
- v. Speech Pathologist for Singing Exercise class (2 hrs/wk for 1 year, 48 hours \$75/hr= \$3,600)- donated by Speech, Swallowing, & Voice Specialists of Hawai'i
- 4. The Hawai'i Parkinson Association has not received any state or federal tax credits in the prior three years. The Hawai'i Parkinson Association has not applied for any capital projects in fiscal year 2026.
- 5. The Hawai'i Parkinson Association in conjunction with the Queen's Medical Center was awarded a State of Hawai'i Grant In Aid in 2023 for the purpose of the creation of a "Movement Disorder Specialists Fellowship". (OCS-GIA-23-48)
- 6. The Hawai'i Parkinson Association has \$434,536.27 in unrestricted current assets as of December 31, 2024.


