1. A brief description of the applicant's background;

Founded in 1992, Healthy Mothers Healthy Babies Coalition of Hawaii (HMHB) is a statewide nonprofit dedicated to improving maternal, child, and family health through collaborative efforts in public education, advocacy, and partner development. Celebrating our 33rd anniversary this year, HMHB has evolved into a creative organization dedicated to ensuring equitable access to health for pregnant and parenting families, as well as individuals of reproductive age, through the integration of social, behavioral health, and clinical care. We provide education, outreach, and

wrap-around services through the following programs: Mana Mama Clinical Care, Mental Health, Hawaii Cribs for Kids, Piko Pals new parent support group, Community-Based Doula Program, and Māna 'ai Food Distribution.

We are currently in a stage of rapid growth. While we are over three decades old, our programs and services have expanded under the leadership of our current staff, who have shifted away from the status quo. We championed adding clinical services in 2020 during the height of the pandemic. This innovation sparked initiatives including launching four mobile clinics and two new offices, opening a 24/7 telehealth line, conducting home visits to ensure the most vulnerable members of our community receive care, and providing reproductive health care in homeless shelters and even on the street. Most recently, in response to the recent Maui wildfires, our team quickly deployed to ensure the needs of pregnant and postpartum women are not overlooked in disaster relief and recovery.

2. The goals and objectives related to the request;

The goal of this proposal is to **improve public health outcomes by providing community health screenings and vaccinations** across three counties: Oahu, Maui (including Molokai), and Hawaii Island. The focus will be on key populations, including keiki (children), pregnant women, and vulnerable groups such as the uninsured, underinsured, low-income individuals, and those in shelters.

HMHB's objective is to administer vaccines including RSV, COVID-19, MMR, TDAP, DTAP, PREVNAR, PEDIARIX, HEP A, HEP B, Varicella, IPV, IPOL, PNEUMOCOCCAL, MENQUADFI, Shingrix, and influenza to the communities on Oahu, Maui, and the Big Island. We want to ensure staff have access to necessary clinical supplies including gloves, sharps containers, hand sanitizer, soap, band-aids, and wipes, to maintain health and safety protocols during screenings and vaccinations. We will also support ongoing health screening efforts and expand services including physical exams, blood draws, and tuberculosis (TB) screening, alongside the administration of vaccines. Lastly, HMHB seeks to **target vulnerable populations** to prioritize underserved groups. such as keiki, pregnant women, and individuals in shelters, as well as those who are uninsured or underinsured, to ensure equitable access to health services. This funding will improve overall health outcomes by increasing vaccination rates and providing comprehensive health screenings to those in need, aiming for a healthier population statewide. By achieving these objectives, HMHB will reduce the spread of preventable diseases and improve the health and safety of Hawaii's most vulnerable communities.

HMHB obtains medical reimbursements for specific vaccines and receives some vaccines in-kind, based on the health insurance of each client. However, these reimbursements do not cover travel expenses and staff time incurred to meet clients in their homes, at community events, or at shelters to ensure they can access vaccinations. Additionally, some vaccine costs aren't fully covered by these medical reimbursements, leading traditional medical offices to discontinue offering them. This

grant aims to fill the financial gap, allowing HMHB to provide all recommended vaccinations to the most vulnerable residents in our community.

3. The public purpose and need to be served;

In the January 9, 2025 news release *MORE HAWAII STUDENTS NOT UP TO DATE ON IMMUNIZATIONS*, Dr. Kenneth Fink, Director of the Department of Health (DOH), stated:

"An increase in the number of students without up-to-date immunizations is a cause for concern... High vaccination rates help protect those who are unable to receive certain vaccines due to medical reasons and those with a non-medical exemption through what's called herd immunity (a large percentage of people are immune to a disease through vaccinations or recovery). Low vaccination rates mean unvaccinated keiki are at increased risk of infection, especially at schools with a high rate of the student population not being up to date. We are already seeing increased cases of pertussis and are at risk for a measles outbreak. Immunizations are necessary to protect infants, children and adults from potentially serious and contagious diseases."

Routine vaccinations and health screenings are crucial for protecting community health. However, recent data reveals an alarming increase in the number of children with incomplete immunizations in Hawaii schools. According to the Hawaii Department of Health, 39,583 students—representing 21% of the total student enrollment across public, charter, and private schools—are missing required immunizations. This marks a staggering 25% increase from the previous school year. These figures reflect students who, despite having immunization records and no exemptions, are missing doses of vaccines as mandated by the CDC's Advisory Committee on Immunization Practices (ACIP) schedule. The Centers for Disease Control and Prevention recommends children receive one dose of the Measles, Mumps, and Rubella (MMR) vaccine at 12-15 months of age, with a second dose at 4-6 years of age. Healthy People 2030 has set a target of 90.8% of children aged 2 years having received at least one dose of the MMR vaccine. However, across Hawaii, only 83.6% of children have met this target (Hawaii Department of Health, 2019).

Decreased vaccinations pose a serious threat to the community as it puts students at risk of absenteeism and increases the potential for the spread of communicable diseases within classrooms. Essential vaccinations are critical for preventing disease outbreaks. Addressing this critical gap in vaccination coverage, **HMHB has taken proactive measures to make accessing vaccines convenient and accessible.**Operating four mobile clinics that visit the homes of families, hosting vaccine drives at community events, and traveling to homeless shelters, HMHB aims to encourage families to receive vaccinations in easily accessible locations. Additionally, **HMHB provides physical exams for children and adults who may struggle to schedule routine visits with their primary care physicians.**

4. Describe the target population to be served; and

While HMHB serves all families across the state, our emphasis is on ensuring **reliable** access to health and social services for uninsured, underinsured, and low-income individuals of reproductive age and their families in underserved and marginalized areas. We particularly reach out to socially high-risk and medically low-risk individuals. Our programs directly address structural and systemic factors that contribute to health inequities for moms and babies. Over 80% of our clients are income-constrained, with household incomes below \$75,000, and 66% identify as Native Hawaiian, Pacific Islander, Filipino, Black, Asian, or other communities of color.

5. Describe the geographic coverage.

HMHB serves families across Hawaii, ensuring access to care statewide through telehealth services. Our physical presence includes offices on the island of Oahu, Hawaii Island, and Maui. Additionally, we operate four mobile clinics across Oahu, Hawaii Island, and Maui.

Collaborating with community health centers, social service agencies, and health plans, HMHB actively addresses gaps in care for underserved populations, particularly those with transportation challenges and incomes below the federal poverty level. Committed to comprehensive family care, the request aims to facilitate vaccinations and health screenings through in-home visits and community events. HMHB seeks funds for vaccines and clinical supplies to enhance meeting community vaccination demands.

The grant will support the administration of over 1,000 life-saving vaccines and community health screenings for 120 individuals, as well as the dissemination of health education through community events. Available vaccines include RSV, COVID-19, MMR, TDAP, DTAP, PREVNAR, PEDIARIX, HEP A, HEP B, Varicella, IPV, IPOL, PNEUMOCOCCAL, MENQUADFI, Shingrix, and influenza.

V. Experience and Capability

1. Necessary Skills and Experience

HMHB is Hawaii's only nonprofit organization dedicated exclusively to supporting the physical, social, and behavioral health needs of perinatal people and their families. We are a known leader for facilitating community maternal and child health workshops as well as the provision of social service and resource referrals. We have evolved to provide direct clinical and mental health care in addition to supportive services. Our highly-skilled team has quickly grown our services to meet the unique needs of the community. Our team consists of a Family Nurse Practitioner, Licensed Certified Professional Midwives, International Board Certified Lactation Consultants (IBCLC), Licensed Mental Health Therapist, community doulas, case managers, and support staff who specialize in culturally competent engagement. We envision a future where Hawaii is a leader in maternal and child health outcomes, where our hapai people and keiki thrive!

Over the past year, HMHB helped nearly 4,000 community members through our programs and services. The following data demonstrates HMHB's impact:

- Hawaii Cribs of Kids launched in 2013, 92% of participants continue safe sleeping practices after completion of the program
- Piko Pals new parent support group launched in 2017 and has provided over 73 families with social, emotional, and educational support in the last year
- The Community-Based Doula Program has resulted in 0% preterm births among participants and 100% of participants receiving mental health screening as well as 100% initiating breastfeeding. 93% of program participants identify as BIPOC
- Nearly 200 home visits (blood draws, physical exams, vaccinations, prenatal visits, postpartum visits, lactation consulting, and mental health therapy) were completed last year
- Over 1,800 vaccine doses have been administered in the past year for individuals 6 months and older
- 40,000 meals and provisions have been delivered to pregnant and new moms

The organization is led and staffed by women and mothers of color who are culturally anchored. Our CEO is an ambitious, results-oriented healthcare leader who holds a Master of Business Administration, is a Registered Nurse, a Certified Lactation Consultant, and is an Army Veteran. HMHB staff ensure that all applicable licensing and operating requirements as well as generally accepted quality standards are integrated

into its policies and procedures. We have extensive experience managing foundation and government contracts. HMHB has received national recognition for its work from organizations such as MIT SOLVE, Direct Relief, and the Institute for Medicaid Innovation.

Our organization is rooted in the following values:

- Equity: we ensure everyone has the same chance to access quality healthcare to stay strong by eliminating health disparities and barriers to care
- Autonomy: we encourage healthy choices and uphold every individual's right to make informed decisions about their own well-being
- Innovation and Growth: we embrace creativity and try new things, learn from mistakes, hold each other accountable, and celebrate successes to foster continuous improvement
- Connection: we build strong relationships, foster collaboration, and create community

2. Facilities

On Oahu:

HMHB leases two office spaces within the Kukui Center (located at 245 N. Kukui St. Suite 102A & 203 Honolulu, HI 96817) with a combined square footage of 2,855 sq feet which accommodates staff offices, food pantry with hot and cold meal storage, lounge/children's playroom, conference rooms for classes/group counseling sessions, client meetings, private offices for individual therapy sessions, medication/supply closet to restock our mobile clinic, and storage for approximately 200 cribs, diapers and breastfeeding/perinatal supplies and donations.

Our mobile clinic is a 2017 Ford Transit extra long, extra tall vehicle that is completely retrofitted as a clinic on wheels, providing home visits and can go directly to the client anywhere on the island of Oahu if visits cannot be done via telehealth or in the office downtown. The mobile clinic is air-conditioned and powered with two 175-watt solar panels on the roof that stores power within three 100-amp hour lithium-ion batteries, with a 3000-watt inverter and battery isolator that charges the car while driving to provide off-grid power. The clinic features two separate client areas separated by a door, a dry flush toilet for urine specimens, a hand washing station with a 7-gallon tank for running water, a vaccine refrigerator, ultrasound capabilities, an infant scale, CPR/AED machine, and all other necessary clinic supplies.

On Hawaii Island:

HMHB leases a 700 sq footage office space in Kailua-Kona for staff offices, client meetings, and storage. We have also retrofitted a 2022 Mercedes-Benz Sprinter for our

Hawaii Island mobile clinic. This new van is solar and battery powered and includes educational materials, a patient bed, handwashing station, toilet, vaccine refrigerator, and capabilities for fetal monitoring and ultrasounds. The clinic on wheels is equipped with 4-wheel drive, a shower, and other technological capabilities, allowing staff to traverse the rugged terrain on Hawaii Island. The van can accommodate at least two patients simultaneously and enables staff to conduct various services, including prenatal and postpartum visits, well-mom exams, reproductive health screenings, infant checks, vaccination administration, and more.

On Maui:

On Maui, we operate from an 800 sq. ft. office space at the Cameron Center, which serves as staff offices, client meeting space, and storage. Additionally, we have a 2021 Mercedes-Benz Sprinter for our Maui mobile clinic and an additional fully electric mobile clinic. Both vans will be retrofitted to match the design and functionality of the Oahu and Hawaii Island vans.

Our mobile clinics are versatile and can be transported to other islands as needed to address emerging needs and expand our reach.

VI. Personnel: Project Organization and Staffing

1. Proposed Staffing, Staff Qualifications, Supervision and Training

HMHB has fourteen full-time staff. We are supported by contracted mental health providers, doulas, nurses, a community health worker, an Organizational Development consultant, eight involved board members, and a corps of volunteers (120+ engaged annually) who carry out the mission of the organization. HMHB's volunteer Board of Directors governs and sets policies, and takes responsibility for strategic planning for the organization. The BOD supervises the CEO and ensures the long-term sustainability of the organization.

The CEO administers the agency and its services with the direction, policies, and long-range plans of the Board of Directors of HMHB. She serves as chief executive and planning officer for information on internal organizational issues and changing community needs.

The three current Directors of Clinical Services (at .25 FTE each) are essential to the success of this initiative, directly supporting vaccine administration and the expansion of critical health services across Oahu, Maui, and the Big Island. Their primary responsibility is to administer vaccines—including RSV, COVID-19, influenza, among others—ensuring broad community access to these vital immunizations. In addition to

vaccine administration, they will provide ongoing support for health screenings and expand services to include physical exams, blood draws, and tuberculosis (TB) screening. Their expertise and leadership are crucial to ensuring the efficient delivery of these essential health services and the overall health and safety of vulnerable populations in these communities.

The staff and board of HMHB reflect the incredible diversity of Hawaii in race, ethnicity, and professional experience. While insurance reimbursements cover some clinical encounters, many essential programs, like keiki vaccinations and home visits, remain underfunded. To bridge the gap to ensure every member of our community can access care, HMHB actively engages in fundraising efforts targeting individual donors and private foundations. Over time, we've seen a progressive increase in funding year over year. We are committed to the long-term viability and growth of our programs, ensuring that HMHB continues to serve and positively impact our community.


