Kalihi-Palama Health Center (KPHC) is a 501 (C) (3) non-profit health care agency. KPHC is a Federally Qualified Community Health Center (FQHC) that plays a critical role in the community by providing health care and social services to patients who typically face significant barriers when accessing health care and social services. KPHC is located in the heart of Kalihi-Palama with a satellite in Honolulu's Downton/Chinatown and a clinic for Homeless in Iwilei Punawai Clinic. We have the highest concentration of public housing and tax subsidized low-income rental units in Hawaii.

KPHC opened its doors in 1975 in response to community concerns regarding both the health and the social determinants of health of poor Native Hawaiians, and immigrants from several Asian Countries and the Pacific Islands. In addition to poverty, these residents continue to face tremendous language and cultural barriers that affect their health and their ability to access health care and to navigate the care delivery systems this diverse community for over 45 years. In 2023, 20,796 patients in 104,415 visits. This does not include our WIC visits.

Our 915 facilities opened its doors in 1994 and celebrates 30 years of services our community this year. The site became our main health care campus and seen much growth during this time. Currently, the roof during heavy down pours leaks which causes KPHC to close down an eligibility workers office and at times an exam room. The roof is in need for replacement. Replace 2 Air Condition Units as these units are old and are in need of replacement. Replace our Dental chairs and x-ray machine are old. We would like to acquire new equipment to provide much needed dental care for the patients and residents in our community. Our bathrooms are also aged. Remodeling by removing old flooring, tiles and bathroom fixtures is needed. Updating our security system which is the original security system for the building.

These renovations will allow patients a better experience when they come in for their health care needs. It will allow patients to feel more welcomes and comfortable int their medical home. It will allow staff to have a good feel in their work environment. This will assist the agency in attracting and maintaining staffing during these times.

- 2. The goals and objectives related to the request; The goals of the project are to make renovations to KPHC's main sit 915 North King Street.
  - 1. Replace aging dental equipment with 2 dental chairs and Panorex xray machine
  - 2. Replace 2 Air Conditioning Units
  - 3. Replace original security system
  - 4. Replace flooring and bathroom fixtures in 2 patient and 2 staff bathrooms.
  - 5. Repaint the interior.
- 3. The public purpose and need to be served;

KPHC serves over 20,000 patients annually from all over the island due to cultural needs and access to health and social service care. Renovations to the 915 sites are needed to continue to provide the same access to care along with providing a comfortable environment for staff to work in and patients to receive care and assistance in. Many of our patients are below the poverty level and approximately 30% require interpretation services.

4. Describe the target population to be served; and

kPHC's target population is predominantly Asian, Native Hawaiian and Pacific Island ethnic minorities. Over 83% of KPHC's patients come from these ethnic minorities. Overall KPHC serves patients in 17 different languages and cultures, with 52%, Asian and 31% Native Hawaiian and other Pacific Islanders. While there are several health care providers in the community, few are proficient in the languages and cultures of the patients KPHC serves.

Poverty, language/cultural barriers, low health literacy and scarcity of health care providers willing and able to serve the target population are significant factors impacting access to care in the target population.

Poverty is a serious barrier. Patients report they did not come for their scheduled visit because they had no money. Eve when KPHC emphasizes that services are provided regardless of the patients' ability to pay, patients are hesitant because they cannot pay for specialty care or hospitalization. Often patients' conditions worsen because they cannot afford to fill their prescriptions.

Our service area includes the highest concentration of densely populated public housing and tax-subsidized low-income rental units in Hawaii.

Multiple ethnicities and languages cause social isolation. Word of mouth plays a significant role in sharing information among the poor and disenfranchised. KPHC has observed that often there is no interaction among neighbors of different ethnicities, so people are cut off from a critical source of information.

Besides being short of capacity for the services that are provided, there is a great need for additional services for diabetes, hypertension, kidney disease, obesity, cancer, asthma, tuberculosis, oral disease, behavioral heath and low birth weight. Many of KPHC's patients suffer from two or more of these conditions.

Of the 20,796 patients served 1,294 patients are homeless.

- 5. Describe the geographic coverage
  - Kalihi-Palama Health Center (KPHC) is located in the heart of Kalihi-Palama, with satellite facilities in Downtown/Chinatown and homeless clinic in lwilei Punawai Clinic. The area is densely populated, multiple ethnicities, multiple language, poor, urban, inner-city community of Honolulu, Hawaii. The area also has a high percentage of unemployed and uninsured citizens. It includes Census Tracts 51 thru 60 and the contiguous areas. The area is designated as a Medically Underserved Population (MUP) and a Medical, Mena Health, and Dental Health Professional Shortage Area (HPSA) by Health Resources and Service Administration (HRSA).

It is important to note that our linguistic and cultural proficiency draws patients from all over Oahu. About 60% of the patients served at KPHC reside outside of our geographic service area.

The project will include , dental chairs and x-ray machine, redo 2 public and 2 staff bathrooms, new alarm system interior replacement of 2 air conditioning units and interior painting. The renovations will promote a positive patient and staff experience at our 30-year-old main site.

The proposal will include the RFP process, permitting and planning, time table Project completion and deliverables of the project. KPHC will be responsible ensuring the project get completed in working with contractor and other vendors and suppliers.

The work will also include staff and patients being temporarily assigned to a Different site while the project is being performed.

. Kalihi Palama Health Center (KPHC) was founded by historic Kaumakapili Church as Hale Ho'ola Hou – House of New Life – because of community concern over the health of its povertystricken residents. In 1975 KPHC was incorporated as an independent 501(c)(3) non-profit organization bearing its current legal name of Kalihi Palama Health Center.

KPHC provides primary care and social services to those who are "in-need." KPHC is distinguished by providing language and culturally appropriate care to those who face significant barriers to accessing such care. KPHC is located in what is considered to be Honolulu, Hawaii's inner city with a satellite clinic in Downtown/Chinatown. The Kalihi Palama area is a densely populated poor, urban community of Honolulu that has the highest concentration of public housing and low-income rental units in Hawaii as well as the largest homeless shelter in the state

Last year per our. Uniform Data System or (UDS) Kalihi-Palama Health Center saw 20,796 patients in 104,415 visits. This does not include our WIC visits. We provide these services to people regardless of ability to pay. These services are provided to 17 distinct languages and cultures from all over the island which is the characteristic that makes Kalihi-Palama Health Center unique.

Diabetes, cardiovascular and chronic kidney disease, cancer, and asthma health are among the major health care needs for KPHC's patient population. In addition, there are challenges that accompany poverty, illiteracy, health illiteracy, language, and culture differences, and what patients consider to be an "alien" health care and social services delivery system, create overwhelming barriers to health and social services for KPHC's patients. These are significant contributing factors to poor health and account for a large number of poverty-stricken residents who because of these barriers find themselves among the homeless ranks.

KPHC's mission is to provide quality, integrated health and social services to its community and all others in need of health care. The organizational focus is on preventative and primary health care, provided in a respectful, caring, and culturally sensitive environment.

KPHC's Healthcare for the Homeless Program is one of the most comprehensive in the State. It is comprised of outreach services for those who are literally homeless living on the streets, in parks and empty buildings; housing for the homeless disabled; walk-in health clinics at homeless shelters for men and women; and respite care for homeless who are discharged but do not have a place to recover from hospitalization. Recently KPHC opened Punawai Clinic which provides Primary Care to the Homeless. In addition we have built our 89 South King Street KPHC Downtown, 952 King Street S and our 710 North King Street sites.

### 2. Facilities

Kalihi-Palama Health Center (KPHC) has 9 sites total. Our sites where we provide clinical services which include medical, dental and behavioral health services are 915 N. King Street, 952 N. King Street, 710 N. King Street and 89 S. King Street. Dojo has administration and Optometry/Social Services, Kohou has Healthcare for the Homeless and we have 2 homeless clinics one located at the IHS Women and Children's shelter the other which opened in January Punawai Clinic and we have our administration at our Austin Lane site. KPHC has long term leases at all of the sites except for 952 which KPHC owns the land.

Our 915 North King Street site is the site we will be requesting assistance for. The site was the first since moving from Kaumakapili Church and served as the main site for KPHC. We recently renewed our long-term lease to May 9, 2082. The building an in 1994 and celebrates its 30 years in operation. The site houses our Patient Records, Referrals, Pediatrics, Women and Adult medical teams, Behavioral Health, Dental, Nutrition, Community Health Workers, ElgibilityWorkers and our Patient Services. The building serves as a place where people work, health and remain healthy. Our dental department sees many for dental emergencies, our medical staff provide primary care and our behavioral health provides therapy and consultation. Our Community Health Workers provide the link between provider and patient in a culturally appropriate manner.

The building has several roof leaks and is in need of a new roof, bathroom floor, toilets, sink which wee have 2 for patients and 2 for staff need to be redone. Our dental department is in need of 2 dental chairs with the units and a panorex x-ray machine.


