Kids Hurt Too's mission is to strengthen connections to the community by **bringing together children**, **teens**, **and their parents impacted by grief and trauma in safe and healing ways**. We provide therapeutic services for children (3-12), youth (13-19), foster system-impacted young adults (18-24), and their families who have experienced trauma through **peer support groups**, **community-based activities**, **training**, **and crisis intervention and management**. The therapeutic components of our programs are empirically based and derived from the model utilized by the National Center for

Grieving Children and Families at the Dougy Center. We provide in-office, school, and community-based mobile initiatives statewide, with our core programming located on Oahu and Maui.

With two decades of experience and a team of five staff members, five board members, over 100 trained volunteers, and numerous community partners, we stabilize children and families in crisis. Beginning in 2001, Kids Hurt Too has served grieving children, youth, and caregivers who have lost a loved one; specifically, the death of a parent or a child/sibling. Over the years, we have broadened our focus to offer services to bereaved family members aged three and older who have experienced the loss of a close relative for various reasons, such as death, divorce, incarceration, deployment, children involved in Child Welfare Services, children who have lost housing due to homelessness or natural disasters, and children who have experienced any trauma.

As our co-founder often states, "We can't prevent domestic violence, the victimization of children, and the loss of family members. But we can provide resources that help children cope with those difficult situations." – Cynthia White

Kids Hurt Too's programs include:

Healing Young Hearts - A peer support group that creates a space for families with similar experiences to gather, share stories, and lean on each other for support. The program builds social connections, provides concrete support for parents, and enhances the social and emotional competence of children.

Kids Hurt Too hosts 300 Healing Young Hearts sessions attended by over 1,500 children and their families annually.

'Āina-Based Mentoring Groups - Kids Hurt Too links children with mentors through community activities. Children learn coping skills and expand their support networks.

Kids Hurt Too connects children with mentors through 160 community-based mentoring and 'aina-based learning opportunities annually.

Grief and Trauma Training - We educate community members, including volunteers, nonprofit organizations, schools, social workers, and counselors, about grief and trauma in young children and teens. This training enhances their knowledge and equips them with practical tools to provide the best care for children affected by loss and trauma.

Since 2006, Kids Hurt Too has trained over 12,000 individuals in supporting grieving and traumatized children.

Crisis Intervention and Management - Providing immediate education and training to frontline providers—such as schools, healthcare professionals, private businesses, and families—who encounter death or loss in their home, office, school, or organization.

Kids Hurt Too responds to six+ crises each year.

2. The goals and objectives related to the request;

Kids Hurt Too seeks funding from the State Grant-in-Aid to enhance grief and trauma services for children in Hawaii. These services reduce long-term mental health issues, prevent the development of complex post-traumatic stress disorder, improve coping skills, boost academic performance, and decrease substance use.

If funded, we will increase the reach of Kids Hurt Too's programs by 33%, providing support to 1,995 children and family members each year through Healing Young Hearts and 'Āina-Based Mentoring Groups. Additionally, it will enable immediate Crisis Intervention and Management following eight community crises annually.

Kids Hurt Too is requesting \$180,820 to employ a Director of Operations, Crisis and Training Manager, and to contract financial management and grant writing/reporting services. With two decades of experience leading impactful programs, we frequently receive invitations to introduce our programs in new schools, Family Assessment Centers/shelters, and community venues. Unfortunately, we have had to decline some opportunities due to our limited capacity, and we currently have a waiting list. Filling these positions will enable us to extend our reach to more schools, shelters, and community locations.

3. The public purpose and need to be served;

Kids Hurt Too offers support to children and their families who have suffered the loss of a loved one or faced trauma. In Hawaii, one in 14 children will encounter the death of a parent or sibling before turning 18 (Childhood Bereavement Estimation Model, 2024). Last year, an average of 1,959 children were in foster care, and 5,073 children were reported as victims of abuse or neglect (Annual Progress and Services Report, State of Hawaii Department of Human Services). According to the Hawaii State Department of Education, nearly 5,880 students are identified in unstable housing across the state, with 477 individuals in 133 families identified as homeless on neighbor islands (Bridging the Gap Point-in-Time Count, 2024) and 1,123 individuals in 276 families experiencing homelessness on Oahu (Partners in Care Point-in-Time Count, 2024).

Children who experience loss and trauma often withdraw from social activities, may have undiagnosed Post-Traumatic Stress Disorder (PTSD), struggle academically, and frequently feel isolated from their communities and families. Recent traumatic events in our community, including the pandemic, Maui wildfires, and the fireworks explosion, have created a need for support among grieving children. The pandemic has led to increased irritability, sleep issues, anxiety, and depression in children (National

Institute of Health). Survivors of the Maui fires report experiencing symptoms of depression and anxiety (Maui Wildfire Exposure Study).

Children's treatment services generally consist of individual therapy or medication, which can be difficult for them to relate to or access. Families that have sought help from Kids Hurt Too have reported long wait times for therapy, often finding openings scheduled several months out. Additionally, Hawaii faces a 45% shortage of child and adolescent psychiatrists, according to the 2024 Physician Workforce Annual Report,

For victims of trauma, group and creative support rooted in culturally informed approaches is an effective tool to support children who are grieving. Kids Hurt Too is increasing access to free services that help participants develop a sense of belonging, feel more secure expressing feelings, learn safe coping behaviors, increase their social capital, and, in turn, increase their economic mobility.

4. Describe the target population to be served; and

Kids Hurt Too supports all children and their families affected by trauma and loss across Hawaii. In the past year, all beneficiaries from Kids Hurt Too lived under the median household income in Hawaii, with 87.5% identifying as Native Hawaiian and Pacific Islander, 2% as Caucasian, 2% as Asian, 5% as Mixed Race (non-Hawaiian), 0.5% as Black, 1% as Latino, and 2% as Other.

5. Describe the geographic coverage.

Kids Hurt Too serves children and families across Hawaii with two physical offices on the island of Oahu (Chinatown and West Oahu) and rented space in Wailuku on Maui. We also operate a mobile grief and trauma support unit on Maui and are building an additional unit for Oahu.

III. Service Summary and Outcomes

Kids Hurt Too offers four key programs—Healing Young Hearts, 'Āina-Based Mentoring Groups, Grief and Trauma Training, and Crisis Intervention and Management—providing crucial support to children and their families facing grief and trauma. Through this grant, we will assist 1,995 children and families via Healing Young Hearts and 'Āina-Based Mentoring Groups, held in various locations including our offices, schools, Family Assessment Centers, and Kids Hurt Too's mobile grief and trauma support unit. Multiple groups operate each week.

'Āina-Based Mentoring Groups are accessible to all who receive services through our peer groups. Staff members create a quarterly schedule of mentoring activities, managing logistics to ensure participation for children and their families. Activities include, but are not limited to:

- Surf for the Soul: Children learn to surf, with the challenges of surfing paralleling their experiences with loss and trauma. Just as waves can be both large and small, youth learn resilience and perseverance.
- Poi for the Soul: This activity draws on Hawaiian culture, teaching children about reciprocal relationships via the care of taro, symbolizes a nurturing bond.
- Seeds of Love: Through outdoor experiences like planting, fishing, and hiking, children discover healthy connections with nature, providing joy and effective coping mechanisms that extend beyond childhood.
- Community and Culture: Cultural activities promote inclusivity and teach youth about community resources.

Grief and Trauma Training occurs year-round. The training is a 2-day program that addresses essential topics: Grief & Trauma Theory, the Kids Hurt Too Program Model, self-awareness, and facilitating children's grief and trauma through play and therapeutic groups. These sessions equip participants with skills to better support grieving families. As grief and trauma symptoms manifest differently in children than they do in adults, we also offer shorter training for healthcare providers and health systems on the specific needs of youth experiencing grief and trauma.

Crisis Intervention and Management is offered free to families, schools, workplaces, and community organizations, aiding immediate responses to crises such as homicide, suicide, accidents, or disasters. Our staff assists those affected by providing education and training on supporting traumatized children. Children and families are connected to Healing Young Hearts and 'Āina-Based Mentoring Groups for ongoing assistance.

All activities follow the Strengthening Families Framework, emphasizing protective factors within families. We prioritize the importance of family bonding and recognize that parents and caregivers often require support when caring for children grappling with grief and trauma. Participants in our peer groups find comfort in shared experiences, often expressing it's the first time they've openly discussed their loss or connected with someone who understands their situation. We firmly advocate that early intervention in grief and trauma is vital for optimal outcomes. In the absence of timely support after grief and trauma, children and teens may resort to unhealthy coping mechanisms.

Kids Hurt Too is expanding to a staff of eight, with 1.5 FTE requested in this proposal. Our current staff includes:

Walker Rowsey, Executive Director, is an experienced leader in the health and nonprofit sectors, with over five years of expertise in growing organizations and managing operations. Under his leadership, Kids Hurt Too increased revenue streams fivefold and expanded from a local to a statewide program with a sustainable annual budget exceeding \$1 million. Walker specializes in strategic planning, program development, fundraising, and community outreach. His notable achievements include launching Hawaii's first mobile social-emotional learning units and leading crisis response initiatives for the Lahaina wildfire. Walker's background also includes roles with the Hawaii LGBTQ Legacy Foundation and Special Olympics Hawaii, where he implemented innovative health and safety protocols during the COVID-19 pandemic.

Kainoa Rudolfo, MA, Director of Operations, holds a Master's in Communication from the University of Hawaii at Mānoa and brings over 14 years of experience in creative media, project management, and nonprofit leadership. Kainoa oversees campaigns, donor management, and digital programming at Kids Hurt Too. He also founded the Hawaii Filmmakers Collective, demonstrating his ability to build and lead organizations. Skilled in social media management, content creation, and community outreach, Kainoa ensures operational excellence and fosters strong community partnerships.

Cynthia White, MA, Training Director, has decades of experience in grief counseling, curriculum development, and training. She co-founded Kids Hurt Too and served as its Executive Director, overseeing program development, training, and crisis intervention. Cynthia has held leadership roles in multiple organizations, including the Hawaii Foster Youth Coalition and the International Association of Childhood Trauma. Her extensive educational background includes a Master's in Education with over 1,300 continuing education units in grief counseling. She has trained volunteers and professionals globally to support grieving children and families.

Hiro Ito, MSW, Oahu Program Director, is a co-founder of Kids Hurt Too and has over two decades of experience in grief and trauma support. Holding a Master's in Social Work, Hiro oversees peer support and mentoring programs, supervises volunteers, and conducts outreach. His additional training includes play therapy, suicide prevention, and Ho'oponopono. Hiro is also an experienced facilitator, having supported children and families in crisis through both clinical practice and community engagement initiatives.

Marissa Meerians, LSW, MSW, Maui Program Director, is a licensed social worker with a Master's in Social Work, and leads the Maui-based programs for Kids Hurt Too Hawaii. She brings years of experience managing peer support groups, school-based services, and early intervention programs for children with special needs. Marissa's expertise in case management and community outreach is complemented by her deep commitment to serving Native Hawaiian families and communities in grief and trauma support.

A pilot of this collaboration is currently underway with the Department of Human Services

Family Assessment Centers, which includes Kids Hurt Too's services in their contracts with homeless service providers.


