This FY 2026 grant-in-aid application aims to replace the over 20-year-old air conditioning unit on the ground floor of the Lanakila Pacific office building, which services our Lanakila Kitchen and Lanakila Meals on Wheels programs. The Lanakila Kitchen, which is part of our Lanakila Food Service program, prepares over 5,600 meals per week that are packed and delivered by Lanakila Meals on Wheels' volunteers to the homebound seniors and adults with disabilities. The current air conditioning system is experiencing significant issues and will become obsolete in the near future. It is vital to replace the unit before it becomes irreparable to ensure that the work areas, including food handling rooms remain temperature controlled and that operations are not affected.

3. Services to be Supported by the Grant;

The capital improvement request to ensure that the air conditioning unit is reliable directly impacts the Lanakila Kitchen and Lanakila Meals on Wheels programs. The air conditioning unit plays a crucial role in maintaining the temperature of the work areas, including the food handling room environments, which is essential for preserving the quality and safety of the food as the routes are prepared for delivery.

The service supported by this grant addresses food insecurity amongst homebound seniors and adults with disabilities. Lanakila Meals on Wheels knows the importance of healthy food for older adults and the impact it can have on their overall health. Nearly 1 in 3 households in Hawaii are food insecure, meaning they lack reliable access to enough nutritious food. This issue is particularly pressing for seniors and adults with disabilities as they face additional challenges such as fixed income, health problems and limited mobility.

Lanakila Meals on Wheels is the only island-wide meal service provider for homebound seniors and individuals with disabilities on Oahu, delivering over 5,600 meals each week. The Lanakila Kitchen prepares all meals for the Lanakila Meals on Wheels in a certified, industrial kitchen that is regularly inspected and approved by the USDA, Department of Environmental Services and State Department of Health, following all state and local laws and regulations regarding safe food handling, food storage, and food preparation.

All meals are USDA-compliant. The menus reflect familiar local flavors and are certified annually by a Registered Dietician to ensure compliance with the Dietary Guidelines for Older Americans.

As part of our mission, Lanakila Pacific recruits, hires, trains and provides ongoing employment of people with disabilities in competitively paid positions in food service, grounds maintenance, and customized apparel/screen printing positions. Lanakila Pacific serves as a leader in accessibility, reasonable accommodations, and creating an inclusive work environment where people with disabilities contribute and prosper. Individuals with disabilities make up at least 75% of Lanakila Pacific's direct labor. These individuals have intellectual and developmental disabilities, mental and behavioral health conditions, are deaf or hard of hearing, and those who are blind.

Funding through the grant-in-aid will not only provide the necessary facility updates to support Lanakila Pacific's mission, but it will also enable Lanakila Meals on Wheels to ensure Oahu's homebound seniors and adults with disabilities receive home delivered meals each week. This aligns with Lanakila Pacific's purpose of allowing employees with disabilities to develop valuable skills while participating in the meaningful task of feeding Oahu's homebound seniors and individuals with disabilities.

4. The target group

Lanakila Meals on Wheels target population to be served through this proposal are food insecure seniors, adults with disabilities, frail and homebound seniors, and individuals with disabilities on the island of Oahu. Meals are delivered straight to the doorstep of homebound seniors and individuals with disabilities at-risk for health issues related to poor diet due to factors such as lack of financial resources or

Lanakila Pacific's budget for the proposed grant-in-aid is \$500,000 to purchase a new air conditioning unit for the ground floor at Lanakila Pacific, located at 1809 Bachelot Street in Honolulu. The Lanakila Pacific Foundation will fund the remaining balance of \$293,240.00. This will ensure that the air conditioning unit will be purchased once the award is received and Lanakila Pacific will be able to expend the award in a timely manner.

II. Background and Summary

A brief description of the applicant's background;

Lanakila Pacific is a Hawaii-based 501(c)(3) that has served Oahu's community for over 85 years. Founded in 1939 as a vocational rehabilitation and training program for people recovering from tuberculosis, the agency has evolved through different models of service. Today, Lanakila Pacific is a family of programs and services that enable adults with disabilities, ranging from cognitive, physical and age-related challenges, to reach their goals and potential, while building independence and promoting community inclusion.

In 1971, Lanakila Pacific established its Lanakila Meals on Wheels department to provide services to vulnerable older adults. What started with a food truck outside of Aala Park, has expanded to include 1) home delivery of meals and fresh produce; 2) community-based, in-person and virtual, congregate dining meals and recreation; and 3) nutrition and SNAP education. Lanakila Meals on Wheels is the only island-wide home delivered meal provider.

2. The goals and objectives related to the request;

To ensure a food safe environment for Lanakila Pacific to produce meals for Kupuna, Lanakila Pacific aims to enhance the efficiency and reliability of the facility's infrastructure. Lanakila Pacific will replace the over 20-year-old air conditioning system with a new, energy-efficient model on the food production and food handling floor of Lanakila Pacific's facility.

Our goal is to use energy more efficiently and minimize disruptions to the delivery of essential services, such as home-delivered meals and community-based programs. By ensuring a stable and comfortable environment, with a target of maintaining indoor temperatures within the optimal range of 68-72°F at least 95% of working hours. This will support the health and well-being of participants, staff, and volunteers along with maintaining a food-safe production and food handling environment by providing a consistently comfortable indoor climate.

3. The public purpose and need to be served;

Lanakila Pacific's proposed 2026 grant-in-aid will be used for public purpose pursuant to Section 42F-102, Hawaii Revised Statutes.

This application seeks funding to replace Lanakila Pacific's over 20-year-old air conditioning unit on the ground floor of the facility. The majority of Lanakila Pacific's

funding is restricted for program support services, making it necessary to secure separate resources for capital improvement projects.

The ground floor or the Lanakla Pacific facility houses the Lanakila Kitchen and Lanakila Meals on Wheels. Lanakila Kitchen produces all of the meals for Lanakila Meals on Wheels, which delivers nutritious meals and fresh produce to homebound elderly individuals, and adults with disabilities ensuring they receive essential nourishment.

Many elderly individuals face mobility challenges and are unable to shop for groceries or prepare meals, making home-delivered meals a critical service. The aging population is at a higher risk of malnutrition, which can lead to serious health complications. Providing regular, balanced meals helps mitigate this risk. Replacing the over 20-year-old air conditioning system will ensure a temperature-controlled environment in the food handling rooms, allowing Lanakila Meals on Wheels to safely prepare meals and continue to deliver to homebound seniors and adults with disabilities without service disruption.

Describe the target population to be served; and

Lanakila Meals on Wheels target population to be served through this proposal are food insecure seniors, adults with disabilities, frail and homebound seniors, and individuals with disabilities on the island of Oahu. Meals are delivered straight to the doorstep of homebound seniors and individuals with disabilities at-risk for health issues related to poor diet due to factors such as lack of financial resources or inability to access food.

5. Describe the geographic coverage.

The entire island of Oahu.

III. Service Summary and Outcomes

Describe the scope of work, tasks and responsibilities;

The project at Lanakila Pacific involves multiple phases to ensure minimal disruption to their operations. It includes modifying or extending the steel air conditioning equipment frame and installing steel guard rails on the roof for safety. Additionally, there will be miscellaneous woodwork and carpentry tasks, along with roof patching and repair to maintain the building's integrity. The project also requires the demolition of partially suspended acoustic ceilings and grids to facilitate the removal and installation of new air conditioning equipment and air ducts. Following the demolition, affected areas will be patched and painted to restore their appearance.

A significant part of the project is the replacement of the cooling tower and chilled water fan coil units with Variable Refrigerant Flow equipment. This upgrade includes installing new equipment to replace the dedicated split Air Handling Units serving the electrical and transformer rooms. Additionally, air conditioning will be provided in the corridors, admin office, and spot cooling in the kitchen on the facility's first floor. A dedicated outdoor air system unit will also be added to improve ventilation.

The project involves the demolition of existing ductwork and the installation of new ductwork for all units, as well as the replacement of existing chilled water piping with new refrigerant piping. Variable Refrigerant Flow controls will be implemented to enhance system efficiency. The ductwork and piping will be insulated to ensure optimal performance, and all air curtains will be replaced to maintain proper air flow, safe food handling, and temperature control within the facility.

2. Provide a projected annual timeline for accomplishing the results or outcomes of the service;

The purchase of the air conditioning system will be a one-time purchase in the first quarter of receiving the award.

3. Describe its quality assurance and evaluation plans for the request. Specify how the applicant plans to monitor, evaluate, and improve their results; and

Lanakila Pacific will solicit a minimum of three proposals from contractors and will select the lowest qualified bid. The selected contractor will be required to submit a comprehensive Quality Control Plan detailing the procedures and measures they will implement to ensure the highest standards and compliance with project specifications.

Billings will be submitted by the contractor monthly for work completed to date.

These invoices must include documentation of the work performed, materials used,

and any other relevant expenses using standard AIA billing templates. Before any payment is made to the contractor, the architect will review and approve all work to ensure it is completed in accordance with the contract documents and meets the required quality standards.

This process helps Lanakila Pacific evaluate and improve their results by ensuring that they receive competitive bids, which can lead to significant cost savings. The Quality Control Plan ensures that the contractor maintains high standards throughout the project. The review of billings by the architect will monitor progress, verify the quality of work, and address any issues promptly, ensuring that the project stays on track and within budget and allow Lanakila Pacific to effectively manage the project.

V. <u>Experience and Capability</u>

1. Necessary Skills and Experience

Lanakila Pacific has 85 years of experience providing services for people with challenged lives on Oahu. Lanakila Pacific's staff have the necessary skills to successfully accomplish the goals set out in this proposal. This is evidenced by our continuous credentialing by national oversight organizations and the State of Hawaii. Then Commission on Accreditation of Rehabilitation Facilities (CARF) has continuously accredited Lanakila Pacific since 1976 and was most recently reaccredited in December 2022 for three years (the highest level at which an organization may be accredited) in the areas of Community Integration, Employee Development Services, and Employment Skills Training Services.

The organization has first-hand, daily experience employing people with disabilities in competitively paid positions in food service, grounds maintenance, custodial, and customized apparel/screen printing positions.

By supporting the recruitment, hiring, training and ongoing employment of people with disabilities within Lanakila Pacific, Lanakila Pacific serves as a leader in accessibility, reasonable accommodations and creating an inclusive work environment where people with disabilities contribute and prosper.

The building hardening at Lanakila Pacific will support the Honolulu Department of Emergency Management's (DEM) efforts to respond to mass feeding needs quickly and effectively. Lanakila Pacific has been meeting with the DEM and they support our plan. As a community-based organization, Lanakila Pacific understands unique needs that are defined by geography, socioeconomic factors, culture, age, disability and more. Through our mission, Lanakila Pacific serves individuals with disabilities and seniors. In addition, through partnerships with other community-based organizations we feed expectant and new mothers, preschool children, and children who qualify for free or reduced meals. In times of disaster, Lanakila Pacific intends to continue serving these vulnerable people.

2. Facilities

The applicant shall provide a description of its facilities and demonstrate its adequacy in relation to the request. If facilities are not presently available, describe plans to secure facilities.

Lanakila Meals on Wheels and Lanakila Kitchen operate out of Lanakila Pacific's main office on Bachelot Street, in Liliha. The 34,000 square foot facility is leased from the state and houses administrative offices as well as its core programs. The building meets ADA requirements, complies with safety and code specifications, and includes visual alarms for the deaf and hearing impaired.

The Lanakila Meals on Wheels' office is 1,748 square feet and the meal packing area is 649 square feet. The Lanakila Kitchen is over 2,000 square feet and has an additional 3,940 square feet in freezer, reefer, dry storage and equipment storage space. The kitchen is equipped with 65-gallon steam kettles, tilt skillets, convection ovens, flattops, convection steamers, 65-quart stand-up mixers, walk-in freezers/refrigerators, and back-up generators. Lanakila Kitchen has the capacity to produce over 5,000 meals a day and in addition to the meals for Meals on Wheels participants, Lanakila Kitchen typically store an additional 18-days' worth of prepared meals for emergency response purposes. Producing meals in-house allows Lanakila Pacific to ensure the quality and nutritional value of our meals. Lanakila prioritizes using locally sourced produce and have optimized our production to take advantage of economies of scale.

The Lanakila Meals on Wheels Director works closely with Facilities' Maintenance Director to ensure all equipment is properly maintained.

In 2024, the Lanakila Pacific Building on Bachelot street has been renovated to support emergency efforts. The Federal Emergency Management Agency (FEMA) grant funds replaced the roof and sealed entrances to the facility to withstand strong winds and flooding. As a backup, Lanakila Pacific also connected its cold storage units to a diesel-powered generator. The work ensures that the Lanakila Kitchen can continue to operate, and provide the meals to the Lanakila Meals on Wheels Program who will deliver to homebound seniors each week.

VI. Personnel: Project Organization and Staffing

1. Proposed Staffing, Staff Qualifications, Supervision and Training

Organizationally, Lanakila Pacific is governed by two Board of Directors. The Lanakila Pacific Center Board establishes policy for the organization, and the Lanakila Pacific Foundation Board is responsible for fundraising and managing funds to maintain perpetuity. Rona Yagi Fukumoto, President & CEO, has over 20 years of experience at the executive level and 26 years of experience working with individuals with disabilities and disadvantaged populations. She has a master's degree in Public Administration and is responsible for overseeing the organization.

Tim Anderson, Chief Financial Officer at Lanakila Pacific, has nearly a decade of executive experience and over 15 years of experience working in Accounting and Finance. Over 10 of those years have been in the Construction industry. He holds a Master of Business Administration as well as a Bachelor of Science in Accounting.

Steve Goo, Vice President of People and Facility Management at Lanakila Pacific, has over 30 years in the financial services industry, including management and executive leadership roles. He currently oversees human resources and the facilities departments. He holds a Master of Business Administration and Bachelor of Science Degree in Business Administration and Finance.

The Lanakila Meals on Wheels Director, Lori Lau is responsible for the overall oversight of the department. 




