Malama Pono Health Services' (MPHS) mission is to provide individualized, compassionate health care services and education to meet the evolving needs of those on Kauai. The organization was founded in 1986 as Kauai's first HIV care center, marking the beginning of its legacy in addressing critical health needs on the island. Initially focused on providing care and support for individuals living with HIV, the organization has grown exponentially to meet the diverse health challenges of the community.

Over the years, MPHS has expanded its services to include comprehensive STD testing and treatment, helping to prevent the spread of infections and educate the public about sexual health. The organization's robust HIV case management program ensures that

individuals living with HIV have access to essential resources, medication, and emotional support.

In addition, MPHS has developed a tobacco cessation program, providing personalized guidance and resources to help individuals quit smoking and improve their overall health. Recognizing the complexity of healthcare accessibility, MPHS also offers insurance assistance to guide clients through enrollment processes and ensure they have coverage for necessary medical care.

Women's health is a cornerstone of the organization's services. MPHS provides women's wellness and reproductive health care, offering routine screenings, family planning, and counseling in a safe, inclusive environment. To support Kauai's LGBTQ community, MPHS offers dedicated transgender services, including hormone therapy, counseling, and a range of affirming care tailored to individual needs.

The organization has also partnered with schools and community providers to offer youth physicals, ensuring young individuals can meet their health requirements for sports participation or school enrollment.

With a commitment to health equity, MPHS continuously adapts to the evolving needs of Kauai's diverse population, emphasizing culturally competent care, education, and advocacy. The requested grant will enable the organization to further expand its outreach, enhance its women's clinic, grow its transgender services, strengthen case management support, and address behavioral health challenges, ensuring comprehensive care for all residents.

2. The goals and objectives related to the request;

Objective 1: Expand access to comprehensive women's health services by increasing clinic availability and staff capacity.

Objective 2: Integrate gender-affirming care into the Women's Wellness Clinic to serve transgender and nonbinary individuals.

Objective 3: Provide supportive programming to empower women and transgender individuals in addressing social determinants of health.

Objective 4: Foster community engagement and advocacy to address systemic barriers to care.

Specific activities will include one-on-one support for transgender individuals and women, with a focus on navigation services to link them to health insurance, comprehensive healthcare, and reproductive health services. Transgender individuals will receive guidance with transition-related care, assistance in accessing legal documentation, and peer-to-peer support to

promote emotional well-being during the ongoing COVID-19 pandemic. Women will benefit from expanded access to wellness exams, cancer screenings, contraception counseling, and prenatal referrals.

3. The public purpose and need to be served;

The public purpose of this project is to improve health equity and access to comprehensive care for underserved populations on Kauai, with a focus on women and transgender individuals. Kauai's rural nature and geographic isolation create significant barriers to healthcare, particularly for Native Hawaiian, Pacific Islander, and LGBTQ communities, who face disproportionate challenges related to health disparities, economic instability, and systemic inequities.

This project addresses these needs by expanding the Women's Wellness Clinic at Malama Pono Health Services, increasing availability of essential services such as reproductive health care, cancer screenings, gender-affirming care, and wellness exams. By hiring a second nurse practitioner, the clinic will extend its operating hours, reduce wait times, and serve more individuals in need.

The need for culturally competent and inclusive healthcare is particularly urgent for Kauai's diverse population. Many women on the island lack access to routine and preventive care, while transgender individuals often struggle to find affirming services and cannot afford to fly to Oahu in order to secure medical needs.

By addressing these gaps, the project serves the public by promoting healthier individuals and communities, reducing health disparities, and fostering a more inclusive healthcare environment that meets the unique needs of Kauai's residents.

4. Describe the target population to be served; and

The target population for this project includes women and transgender individuals on the island of Kauai, with a focus on underserved and marginalized communities.

Women: The project will serve women who face barriers to accessing comprehensive reproductive and preventive healthcare. This includes Native Hawaiian and Pacific Islander women, who are disproportionately impacted by social determinants of health such as economic instability, geographic isolation, and limited access to healthcare services. Many of these women lack regular access to wellness exams, cancer screenings, and contraception counseling, leaving significant gaps in their health and wellbeing.

Transgender Individuals: The project will also target transgender and nonbinary individuals who experience unique challenges in obtaining gender-affirming care and other essential health services. Many transgender individuals on Kauai face stigma, discrimination, and limited availability of affirming providers, leading to unmet healthcare

needs. This includes access to hormone therapy, legal documentation assistance, and mental health support.

Demographics: The target population is diverse, encompassing Native Hawaiian, Pacific Islander, Asian, immigrant, and LGBTQ communities. These groups are often underserved due to systemic inequities, economic challenges, and a lack of culturally competent and inclusive healthcare options.

5. Describe the geographic coverage.

The geographic area served by this project is the island of Kauai, the northernmost of the main Hawaiian Islands. Despite its beautiful appearance, the island faces unique challenges in healthcare access due to its isolated location, dispersed population, and limited medical infrastructure.

Kauai spans approximately 562 square miles and is home to a population of just over 73,000 residents, with many living in rural communities spread across the island's varied terrain. These communities include larger towns like Lihue, Kapa'a, and Waimea, as well as smaller, more remote areas where transportation and healthcare services can be difficult to access.

The population of Kauai is highly diverse, comprising Native Hawaiians, Pacific Islanders, Asians, and a growing number of immigrants. This diversity underscores the need for culturally competent and inclusive healthcare services. Additionally, the island faces a significant gap in resources for underserved groups, such as LGBTQ individuals, women, youth, and those experiencing socioeconomic hardship.

Kauai's geographic isolation also limits residents' access to specialized healthcare services that are more readily available on larger islands or the mainland. Many individuals rely on local organizations, like Malama Pono Health Services, to bridge these gaps and provide critical care in areas such as HIV treatment, STD testing, women's health, and youth physicals.

This project aims to address these challenges by enhancing access to vital healthcare services across Kauai, focusing on outreach to rural areas and underserved populations to ensure equitable healthcare for all residents

As an existing program, the Women's Wellness Clinic at Malama Pono Health Services is poised to expand its scope and capacity upon the execution of this grant proposal. The clinic's team has established strong relationships within the community, ensuring a seamless expansion of services and minimal barriers to reaching and serving the target populations. The proposed timeline includes structured monthly and quarterly activities that are measurable, achievable, and time-sensitive.

Objective 1: Expand access to comprehensive women's health services by increasing clinic availability and staff capacity.

By the end of the grant period, the Women's Wellness Clinic will:

- a. Hire a second nurse practitioner to provide women's health services on the three days currently not covered, increasing clinic accessibility to meet growing demand.
- b. Expand reproductive health services, including routine wellness exams, contraception counseling, prenatal referrals, and cervical and breast cancer screenings, ensuring access to care for underserved women on Kauai.
- c. Conduct at least 100 health consultations and screenings per quarter, with a focus on providing culturally competent care to Native Hawaiian and Pacific Islander women who experience disproportionate barriers to healthcare access.

Objective 2: Integrate gender-affirming care into the Women's Wellness Clinic to serve transgender and nonbinary individuals. By the end of the grant period, the clinic will:

a. Provide gender-affirming medical services such as hormone therapy, referrals for surgical consultations and hair removal guidance, to at least 25 transgender and nonbinary individuals.

- b. Offer case-managed support for gender-affirming care, including assistance with navigating insurance for medical services and applications for legal identity documentation (e.g., name changes, birth certificate updates).
- c. Conduct quarterly outreach to transgender individuals in rural and underserved areas to ensure awareness of and access to the expanded clinic services.

Objective 3: Provide supportive programming to empower women and transgender individuals in addressing social determinants of health.

By the end of the grant period, the Women's Wellness Clinic will:

- a. Host at least 4 workshops (one per quarter) focusing on financial literacy, life skills, and healthcare navigation to empower women and transgender individuals to maintain access to housing, medical care, and other essential services.
- b. Facilitate peer counseling and support groups for women and transgender individuals to address issues such as reproductive health, gender-affirming care, and mental health.
- c. Partner with local organizations to provide educational sessions on topics like menopause, gender transition, and reproductive health, targeting at least 75 attendees annually.

Objective 4: Foster community engagement and advocacy to address systemic barriers to care.

By the end of the grant period, the clinic will:

- a. Engage at least 10 community members, including women and transgender individuals, to participate in discussions with policymakers about the healthcare needs of underserved populations.
- b. Participate in public events such as health fairs, Women's History Month activities, and LGBTQ+ visibility events.
- c. Collaborate with local and state organizations to promote health equity and increase awareness of the clinic's services through public campaigns and outreach efforts.

This expansion will strengthen the clinic's role as a critical resource for women and transgender individuals on Kauai, providing holistic, inclusive, and accessible care while addressing systemic inequities in healthcare delivery.

Malama Pono has been the sole HIV case management and testing services provider on Kauai for over 35 years. MPHS has built a rapport with many organizations and government agencies in the community throughout its lifespan, creating a robust network of care. Currently, the organization offers various services within this program, including testing for gonorrhea, chlamydia, syphilis, HIV, Hepatitis C, and Hepatitis B. All testers are certified by the State of Hawaii and trained in harm reduction and motivational interviewing techniques. Moreover, all prevention staff are Certified Medical Assistants, and the Clinical Manager is a Certified Nursing Assistant and Certified Professional Coder (CPC). Lastly, MPHS finds it imperative to incorporate best practices whenever possible and provides additional training to staff to accomplish this task. This history of service demonstrates the organization's ability to adapt to evolving community needs and maintain a high standard of culturally competent care.

Over the past three years, MPHS has successfully implemented several programs that are directly relevant to the services proposed in this application:

- Women's Wellness Clinic Expansion: MPHS has provided comprehensive reproductive healthcare services, including wellness exams, cancer screenings, contraception counseling, and referrals for prenatal care. The clinic has built strong relationships with local providers, ensuring continuity of care and access to critical health services for underserved women.
- 2. Transgender Care Services: MPHS has offered hormone therapy for many years and is the only provider of these services on Kauai. The program's success is rooted in its inclusive approach and its partnerships with local and off-island specialists.
- 3. Community Outreach and Education: MPHS has conducted health education workshops and outreach events focused on addressing social determinants of health, such as housing instability, food insecurity, and healthcare access. These efforts have directly impacted over 500 community members annually.

The organization's demonstrated expertise in delivering women's and transgender health services, combined with its ability to effectively manage outreach and community-based programs, makes MPHS uniquely suited to execute the proposed project. The staff's cultural competence, deep understanding of local health challenges, and strong partnerships with healthcare providers and community organizations further position MPHS as an appropriate and capable service provider for this initiative. All projects and services provided by MPHS are well-documented, with verifiable outcomes and community impact data available upon request.

2. Facilities

MPHS' clinic is located at 4370 Kukui Grove Street, Suite115, Lihue, HI 96766. This space is 2,486 square feet and in a central island location which provides easier access for patients. The office is also conveniently situated on the Kauai Bus Route, allowing patients an alternative transportation option. The office space provides an optimum layout that increases production and communication among team members. The format of this location includes three exam rooms, a clinical lab, a reception area, a break room, a conference room, and four individual offices. The agency also has a separate office down the hall for HIV case management and a food pantry for MPHS clients living with HIV. This office provides a private setting for HIV clients to receive services without being worried about being identified as HIV positive by the community. Lastly, this facility is very cost-effective and leased by MPHS for ten years.

VI. Personnel: Project Organization and Staffing

1. Proposed Staffing, Staff Qualifications, Supervision and Training

MPHS' team embodies demographic diversity, including racial and sexual minorities and members with lived experience with drug use and criminal legal system involvement. Supervisors facilitate day-to-day operations of our programs and mentor our team of case managers, outreach workers, counselors, patient navigators and staff.

MPHS CEO, Melanie Rule, is a seasoned healthcare professional with over 15 years of dedicated experience. She built a long-standing career with Summa Health Systems in Akron, Ohio where she helped spearhead Summa's inaugural LGBTQ Educational Summit, pioneering inclusive practices. After stepping into a challenging position during a change in multiple leadership positions, she has brought back many community partnerships and has developed a strong strategic plan to move Malama Pono forward for the next five years.

Director of Clinical Services, Melisse Camelo, is a Certified Nursing Assistant and Certified Professional Coder (CPC). She manages the daily activities of our Women's Wellness and STD Clinic: program effectiveness, progress toward S.M.A.R.T. goals, professional development, maintains oversight of the budget, and orders clinical equipment and supplies to fill patient needs. Furthermore, Melisse Camelo oversees medical billing and coding for the Women's Wellness Clinic and is trained in the tobacco cessation program.

Brandi Bartholomew is a licensed independent nurse practitioner. She is responsible for managing health problems and coordinating health care for patients in accordance with State and Federal rules and regulations. She performs diagnoses and treatment of illnesses and carries out health-risk assessments, routine checkups, screening tests and immunization, and counseling for our Women's Wellness Clinic. She also provides hormone injections for our transgender patients.

Malama Pono staff are well-known, highly regarded, and deeply connected to the Kauai community. Each has a personal understanding of the range of issues, obstacles, and challenges faced by the community and those with a Native Hawaiian or Pacific Islander cultural background.

MPHS expects and encourages staff to participate actively in all relevant training opportunities. These fall into four categories: internal training provided on a specific topic by an appropriately experienced staff member; in-service training wherein a representative from another organization or program orients or trains the staff on a particular issue (i.e. AIDS Education & Training Center, the YWCA, and training to deal safely with potentially violent clients); locally organized offsite or virtual group training attended by a number of organizations; and virtual national trainings. Trainings are a key competent to ensure all staff are kept up-to-date and on the cutting edge of providing exemplary services to individuals experiencing hardships.

The following sustainability plan outlines strategies to ensure the continued success and impact of the program:

1. Diversified Funding Sources

- Increased Grant Applications: MPHS will actively pursue other local, state, federal, and private foundation grants focused on women's health, LGBTQ+ health services, and rural healthcare access. The organization has a proven track record in securing funding from diverse sources, which will be leveraged for this program.
- Philanthropic Donations: MPHS will strengthen its donor engagement efforts by cultivating relationships with individual donors and corporate sponsors. Specific fundraising campaigns will be launched to support women's wellness and genderaffirming care, including annual giving drives and targeted appeals.
- Fundraising Events: The organization will expand its calendar of fundraising events, such as benefit walks, community health fairs, and galas, with a portion of proceeds earmarked for sustaining the clinic's operations.

2. Community Partnerships

- Collaborations with Local Providers: MPHS will deepen partnerships with local healthcare providers and other community health centers, to share resources, reduce costs, and maintain service continuity.
- Partnering with State Programs: MPHS will continue collaborating with the Department of Health and other state agencies to integrate clinic services into existing healthcare initiatives and maximize available resources.

3. Revenue Generation

- Sliding Scale Fee Model: MPHS will implement or expand a sliding-scale fee system for clinic services, ensuring affordability while generating revenue to cover operational costs.
- Insurance Billing: The organization will expand its capacity to bill Medicaid,
 Medicare, and private insurance for eligible services, including reproductive health care and gender-affirming care.

By leveraging these strategies, MPHS will ensure that the expanded Women's Wellness Clinic and gender-affirming care services continue to meet the health needs of Kauai's underserved populations well beyond fiscal year 2026.
