Mele Murals is a tuition-free visual arts and cultural program created by Mele Murals LLC, a Hawai'i-based disregarded entity created by the Estria Foundation, a 501(c)(3) nonprofit organization. The program's curriculum is designed to advance the protocols, perspectives, and values of the Hawaiian culture and creative and visual arts techniques developed by Estria Foundation co-founder Todd Johnson, better known by his artist name Estria Miyashiro. Lessons are centered around a cultural based curriculum and hands on creative arts that is designed to foster community and cultural pride in each child. Students, families, and faculty at Ke Kula Kaiapuni 'O Ānuenue, a Title 1 HIDOE School, have voiced their students' need for creative arts programming.

The Mele Murals program continues to serve over 10,000 students per annum through its popular public arts and cultural programs and projects. Each year, our team receives more requests for our Mele Murals Program than our current capacity would allow from HIDOE schools, community groups, private wall owners, and community members.

2. The goals and objectives related to the request;

The Mele Murals Program was designed to honor the last commands of King David Kalākaua where he asserted, "look to the keiki, teach them, groom them, show them wonder, and inspire them." The program's curriculum establishes a platform for our team to teach young people to become visual storytellers, artists, and community leaders. Our primary goal for the Mele Murals Program is to inspire the next generation of visual storytellers. Every Mele Murals collaboration moves the organization closer to achieving its goal by:

- Creating an all-islands public art project that is artistically excellent, deeply
- connected to the history of Hawai'i, and a source of pride.
- Developing arts-interested youth into visual storytellers by educating them on local history, showing them how to connect to ancestors, and developing their artistic skills.
- Teaching public art techniques that are not taught in conventional arts classes,
- helping to develop leadership, organizational, and public speaking skills.
- Enhancing students' creative and critical thinking skills through the mural arts
- process.
- Employ a broad set of media tools to share the stories of the mele with a global
- audience, highlighting important artistic, cultural, and historical themes.
- Building and sustaining an Arts in Public movement across the island chain, filling
- them with professional works of art.
- Providing opportunities for youth to explore Hawaiian oral storytelling tradition, to learn how to decipher kaona (hidden references), and to educate them on
- Hawai'i's cultures, heritage, and values.
- Increasing cross-generation and cross-island engagement by creating new and exciting opportunities for all generations to learn and share mele and stories.

Our goal for fiscal year 2026 is to positively impact 448 unduplicated Ke Kula Kaiapuni 'O Ānuenue students by engaging them through our Mele Murals program, authentic cultural knowledge, and co-creating culturally infused public art works within 'Ānuenue's Campus or at a prominent community space within the district.

3. The public purpose and need to be served;

Mele Murals promotes youth development, arts education, cultural preservation, and community-building through engaging arts and cultural curriculum, field excursions, and hands-on creation of large-scale community murals. Project designs focus on Hawaiian lyrics (mele) that explore moʻolelo ʻaina (stories of place), kaona (hidden references), and a community's cultural heritage. Indigenous artists, cultural practitioners, educators, youth, and community members spanning eight major islands of Hawai'i actively participate in our programs and community projects.

To directly address educational inequalities existing in the communities we serve, TEF partners with many Title 1 schools through its culture-based visual arts programs. Arts engagement with young people has proven to increase participation in schools and communities, increases civic and cultural pride, and reduces social isolation. TEF's arts and culture programs build on the desires of our team of cultural practitioners and arts educators to provide a safe, structured, and creative outlet for children year-round. Through its arts programs, TEF strives to engage Hawai'i's high-risk, at-risk, and vulnerable youth in a positive, extracurricular program that enhances their artistic aptitude and engages them in Hawaiian culture.

Daily lessons employ cultural-based, aloha 'āina and creative and performance arts curricula intentionally designed to foster indigenous pride and places importance on preserving and advancing Hawaiian culture and the wahi pana (storied places) that connect young Kānaka to the 'aina and their kūpuna (ancestors). The program provides culture-interested students and families opportunities to engage with and develop into generational leaders in the indigenous cultural movement that fosters connectedness; preserves the mo'olelo (history), 'ike (knowledge), and wahi pana (storied places) of precontact Hawai'i; and creates valuable public art assets that uplifts the Hawaiian culture.

4. Describe the target population to be served; and

Our Mele Murals Program develops and inspires cultural storytellers using the visual arts. Haumāna (students) are taught leadership and teamwork skills as well as the preservation of our āina (land). Title 1 Ke Kula Kaiapuni 'O Ānuenue School, a public school in House District 21 and Senate District 10, recently became a partner school and school program site for our Mele Murals Program. Ānuenue School's current student population (school year 2024-25) is set at 448 with 54.28% receiving Free and Reduced Lunch assistance.

Ke Kula Kaiapuni 'O Ānuenue is a Kindergarten through 12th grade Hawaiian Language Immersion school located deep in Pālolo Valley on Oʻahu. Students are taught through the Hawaiian language for all content areas and English is introduced in the 5th grade and from that point students focused on learning English for an hour per day. Physically located in House District 21 and Senate District 10, Ke Kula Kaiapuni 'O Ānuenue School serves students residing in zip codes 96701, 96706, 96707, 96734, 96744, 96748, 96761, 96778, 96782, 96786, 96789, 96792, 96795, 96797, 96813, 96814, 96815, 96816, 96817, 96818, 96819, 96820, 96821, 96822, 96825, 96826, and 96828.

Geographically located on 10th Avenue in Palolo, Oʻahu, Ke Kula Kaiapuni ʻO Ānuenue serves students from all Senate Districts on Oʻahu. Ānuenue's student body come to the Hawaiian Language Immersion school from zip codes (HIDOE school year 24-25) 96701, 96706, 96707, 96734, 96744, 96748, 96761, 96778, 96782, 96786, 96789, 96792, 96795, 96797, 96813, 96814, 96815, 96816, 96817, 96818, 96819, 96820, 96821, 96822, 96825, 96826, and 96828.

Ke Kula Kaiapuni 'O Ānuenue School, a k-12 Hawaiian Language Immersion School, has requested our assistance with the delivery of relevant visual arts and cultural education programming that will engage their entire student body. Administrators and teachers at Ānuenue envision a deeply inspiring arts and cultural program that is designed to engage its students in creative arts activities, authentic cultural knowledge, 'āina-based outdoors activities, placemaking, and leadership development in a safe and supportive space. Our Mele Murals Program is designed to develop and inspire cultural storytellers using the visual arts. Haumāna (students) are taught leadership and teamwork skills and are provided opportunities to mālama 'āina (land) in open and culturally significant spaces within their communities.

As a Hawai'i-based arts and culture organization, Mele Murals LLC utilizes the Evaluation with Aloha Framework developed by the Lili'uokalani Trust to evaluate all program offerings including the Mele Murals Program. Mo'olelo (data collection and

analysis) utilizes quantitative methods (measures, instruments, or assessments) to produce scores which are then analyzed using statistical techniques. The primary data collection tools utilized include a hybrid approach inclusive of questionnaires, observation, and interviews of students, school administrations, teachers, and instructors.

Quantitative values including attendance/participation numbers, number of institutions served, number of communities served, student participation hours committed, number of public spaces improved, etc., are collected and analyzed by Mele Murals staff. Once analyzed, data is used to adjust program formatting, delivery, or assessment tools to better administer and assess Mele Murals implementation at community schools and/or organizations.

Qualitative values collected by our team are used to measure end user satisfaction. These values are measured based on a numeric scale of 1-5, with 5 being completely satisfied. Measures include curriculum satisfaction, implementation satisfaction, huaka'i (field trip) satisfaction, etc., are used to measure the qualitative responses of our end users.

Evaluator Director Joan Umi Jensen, Ph.D., conducts periodic evaluations of the Mele Murals program and related projects to ensure that our team continues to deliver high-quality arts and culture programs and that program data is accurately collected and analyzed. Evaluations are used internally to measure the effectiveness and impact of our arts and culture programs.

As a trusted arts and culture organization serving Hawai'i communities and schools, The Estria Foundation, parent organization of Mele Murals LLC, maintains steadfast relationships with many HIDOE school administrations and teachers. Our team believes in nurturing relationships between our Mele Murals Program and with schools, organizations, agencies, and other partners served through our arts and culture programs and projects. Mele Murals has completed over eighty (80) murals throughout the State of Hawai'i in collaboration with community youth and teens, muralists, school administrators and teachers, local families, property owners, and other arts and culture organizations.

Mele Murals is an ambitious public arts project that has grown out of our team's collective decades of experience leading arts education and cultural projects across the State. Our team, comprised of seasoned arts educators, expert muralists, cultural practitioners, and artists has vast experience developing and executing large-scale, culturally inspired murals, with over 1,500 murals projects created throughout the State of Hawai'i and across the world.

Our purpose is rooted in the origins of street artists who create work outside of traditional studio spaces. Our projects traditionally focuses on amplifying historically underrepresented stories often ignored by traditional media outlets, advertising, and formal institutions of knowledge. We work to show that artists are indispensible and transformative community builders and essential visual storytellers. Increasingly, we are drawing on decades of arts education experience in identifying emerging young artists who are interested in collaboration, mentorship, and skills building as they explore public art as a means for community improvement and cultural awareness.

Mele Murals LLC partners with community schools and organizations to conduct our popular arts and culture Mele Murals Program. Because we work directly with Hawai'i's community schools, our team utilizes the campuses of our partner schools to host our Mele Murals program and public arts projects. For this specific request, our team will host our Mele Murals program in collaboration with Ke Kula Kaiapuni 'O Ānuenue located at 3528 10th Avenue, Honolulu, HI 96816.

1. Proposed Staffing, Staff Qualifications, Supervision and Training

With over 30 years of experience and recognition around the world as an urban arts legend, Todd Johnson aka Estria Miyashiro serves as Mele Murals LLC's Executive and Creative Director. As a pioneer in an arts movement that is arguably more influential than the classical renaissance, he is acknowledged as a valued historian, and a community leader who has helped to awaken the social and political consciousness of graffiti writing art.

Originally from Honolulu, Estria was active in the San Francisco Bay Area in the 1980's during the "Golden Age of Graffiti." His graffiti art background led him to produce innovative projects as an educator, entrepreneur, and social activist. From the city streets to executive suites, Estria has worked with numerous nonprofit organizations including Precita Eyes Mural Arts Center in San Francisco and Eastside Arts Alliance in Oakland, as well as a multitude of high profile corporations. In 2007, he co-founded the "Estria Battle," a nationwide urban arts competition that honors and advances creativity in the Hip Hop arts. In 2010, he co-founded the Estria Foundation, the parent nonprofit organization of Mele Murals LLC.

Mele Murals and The Estria Foundation are supported by a team of nonprofit professionals, creative arts educators and cultural practitioners. Our extensive

community network helps our relatively small team conduct large-scale projects, traditionally impossible to implement by an organization of our size. We believe in the Hawaiian practice of kākou, where everyone contributes to the undertaking. Collectively, our team has worked with over 50 schools throughout the State of Hawai'i, produced over 80 Mele Murals, collaborated on over 1,500 murals worldwide, and offered countless arts and cultural classes since the organization's inception. Team members include:



- Plan and present art displays and exhibitions to exhibit students' work
- Select and requisition supplies, books, instructional materials, tools, instructional aids, and maintain required inventory records
- Organize storage areas and control use of materials, equipment, and tools to prevent loss or abuse
- Participate in curriculum and other developmental programs
- Provide individual and small-group instruction to adapt the curriculum to the needs of students with varying intellectual and artistic abilities, and to accommodate a variety of instructional activities
- Instruct students in proper care and use of tools and equipment




