## II. Background and Summary

1. A brief description of the applicant's background;

Namahana Education Foundation (NEF) is an independent nonprofit organization incorporated in 2020 to advance Namahana School, a public charter middle and high school opening in August 2025 in Kīlauea on the north shore of Kaua'i. NEF manages the fundraising and construction process for the Namahana School campus, as well as generates ongoing community support to cover the operational costs not met by the state's per-student allocation.

As the first public tuition-free middle and high school on the North Shore of Kaua'i, Namahana School's mission is to serve the communities of Halele'a and Ko'olau with rigorous 'āina-based education through cultivating relationships with 'āina, kanaka, and ao. Namahana School will prepare students for professional and personal fulfillment, with skills that empower them to actively contribute to a resilient future on Kaua'i.

This coming August 2025, Namahana School will be welcoming its inaugural 7<sup>th</sup> and 8<sup>th</sup> grade classes in a temporary leased facility for the first year, with the option to renew one additional year. The school will add on one grade each year thereafter until reaching full capacity of 360 students in 7-12<sup>th</sup> grades.

Namahana School has gained significant momentum since 2015 with a broad base of community support:

**2015-2018** - Extensive community outreach and involvement: The development of Namahana School involved a thoughtful and inclusive community engagement process, which included community listening sessions, surveys at PTA meetings, farmers' markets, churches, libraries and supermarkets, and individual input from stakeholders in the community, such as local businesses, local non-profit organizations, teachers, cultural practitioners kupuna, kumu, and hula halau. Students at the two elementary feeder schools participated in listening sessions and design workshops to develop the facilities conceptual design and master plan.

**2019-2020:** A high-profile Governing Board was established with respected and experienced community leaders. The Hawaii State Public Charter Commission approved Namahana School's Intent to Apply allowing the school to apply as for charter approval. Due to COVID, the charter application process was suspended until 2022.

**2020:** The Namahana Education Foundation, a 501(c)(3) nonprofit organization, was established to raise funds for the school and manage the land acquisition, permits, design and construction of the facilities. Following the publication of a competitive Request for Proposals, Group 70 International (G70) was selected to conduct a site and infrastructure feasibility analysis, complete a preliminary design and master plan, and develop a construction budget.

**2022:** The Hawaiʻi State Public Charter School Commission unanimously approved Namahana School as a pre-opening public charter school to open in Fall 2025. Namahana School was one of only two schools out of 12 statewide to receive approval. More than 40 individuals and organizations submitted oral or written testimony in favor of the school's application, including representatives of local community organizations and businesses, elected officials, principals from local public elementary schools, prospective students, parents, and residents from other parts of the island. NEF convened the first capital campaign committee to raise the needed funds to start the project. G70 facilitated several design charrettes with key stakeholders, and completed the conceptual design in September 2022

**2023:** An 11-acre property in Kilauea (TMK parcel (4)5-2-005:053) was purchased for the school site. NEF raised \$1.4 million in 3 months to secure the land. G70 completed the final master site plan for the Kīlauea site in 2023. The Special Use Permit to build the school at the location was unanimously approved by the County in December.

**2018 – 2024:** Community Support and Involvement: Namahana Education Foundation, along with the Kauai North Shore Community Foundation and the Namahana School Governing Board, hosted large Community Meetings to keep the community involved and informed. To date, more than 1100 community members have been engaged and over 15 community-based organizations have signed up to serve as field study and internship sites. The school is supported by elected officials including Senator Mazie Hirono, Kaua'i Mayor Derek Kawakami and Kaua'i County Council members, including Felicia Cowden and Addison Bulosan.

Namahana School Facilities: Namahana Education Foundation is prioritizing the construction of the school's essential permanent classrooms, which will total 24 classrooms for 7th - 12th grades. 8 middle school classrooms must be completed by June 2026 and an additional 16 high school classrooms must be completed ongoing through June 2028. The site infrastructure, circulation, and buildings have been designed to meet ADA requirements and all applicable building and zoning regulations adopted by the County of Kaua'i, State of Hawai'i, Hawai'i Department of Education, Hawai'i Department of Health, and any other agency with jurisdiction.

NEF will be utilizing pre-fabricated structures and selected WABi Systems as the most energy efficient, sustainable, and financially responsible facilities. WABi Systems designs and fabricates customizable permanent state-of-the-art modular structures that use a galvanized steel framework and highly energy efficient panels to make extremely durable and energy efficient structures. The use of high-quality pre-manufactured structures saves both time and money as they are more affordable can be installed quickly to meet our current timelines.

NEF is currently working with our architect G70 and WABi Systems to finish the permit set, which includes our middle school classroom buildings, by the end of January 2025. G70 is Hawai'i's largest multidisciplinary design firm with extensive educational design experience, having designed more than 1 million square feet of K-12 educational facilities in Hawai'i and around the Pacific Rim.

NEF's environmental consultant, Terracon, has completed our draft Phase I Environmental Site Assessment report, which will be entering the federal review stage this month, January 2025. We are grateful to the state legislature for the FY2024 \$125,000 Hawaii GIA operating grant of \$125,000, which allowed us to complete this draft Environmental Assessment.

2. The goals and objectives related to the request;

Namahana Education Foundation is requesting \$1,380,000 for capital improvement funds to support the construction of essential permanent classroom facilities for Namahana School. With only two years available at a temporary facility that can accommodates just two grades, no alternative rental options on the North Shore, and approximately 120 students enrolling this fall and an additional 60 students each subsequent year for four years, Namahana School must complete its permanent facilities to remain operational beyond June 2026

**Goal:** To provide Kauai's North Shore families with access to a local tuition-free public education by constructing the first tuition-free public charter middle and high school facility for Namahana School. Core components of the project include the design, manufacturing and installation of 8 classrooms serving 120 students in two grade levels.

#### **Objectives:**

We are requesting funds to cover the installation costs of 8 middle school classrooms.

Objectives of the full project:

- 1) Complete construction documents for middle and high school classrooms
- 2) Hire a General Contractor
- 3) Receive permit approval from the County of Kaua'i to begin construction.
- 4) Fabricate, ship and receive Wabi Systems permanent modular classroom structures
- 5) Install modular classrooms
- 6) Complete Inspections and receive certificate of occupancy

#### 3. The public purpose and need to be served;

The Namahana School campus will address our community's critical need for essential public educational facilities on the North Shore of Kaua'i. At capacity, the school will serve 360 middle and high school students and 39 staff. The campus will also serve as a North Shore hub that connects students to local businesses and organizations through local field studies and internship programs, provides extra curricular activities, hosts school-based community events, and provides accessible meeting spaces for the North Shore community.

Namahana School was born out of a decades-long community dream to have a public middle and high school geographically situated on the North Shore of Kaua'i. Currently, there is no public middle or high school on the North Shore, all students must commute 2-4 hours daily to get to the nearest public high school, which results in physical and social impediments to their education and emotional growth. Students often cannot participate in extracurricular activities, and parents face challenges trying to participate in their children's school. With periodic bus driver shortages, our local DOE public middle and high schools have been forced in the past to drop bus service to our North Shore families, making access to education even more difficult and sporadic. Over the last 30 years, the rural North Shore community (Anahola to Hā'ena) has faced continuous and substantial socio-economic stratification—a product of a burgeoning

population, lack of affordable housing, increased cost of living, low-wage jobs, and displacement of multi-generational families from their communities. The lack of access to a local public middle and high school only exacerbates these economic and social inequities.

Namahana School was modeled to act as a solution to these challenges and will be the first geographically sited and uniquely structured public middle and high school to meet the educational needs of the Kaua'i North Shore community. Namahana School will prepare students for professional and personal fulfillment, with skills that empower them to actively contribute to a resilient future on Kaua'i. Namahana's mission is founded and driven by these three community-determined values: Aloha 'Āina (to practice a shared understanding of our kuleana for 'āina), Aloha Kanaka (to respect and mālama our community, our families, and ourselves), and Aloha i ke Ao (to perpetuate pono practices to navigate cultures of the world).

Namahana plans to utilize 'Āina-based Learning ('ĀBL) throughout the school and across the curricula. 'ĀBL is a dynamic approach to education in which learners can deepen their relationship with the land and its resources, cultivate connections within their communities, and build critical skills that can be applied to real-world issues and meet the needs of the whole community (from student to kūpuna). This experience-based learning style and knowledge-sharing offers students the opportunity to engage in holistic, community-driven solutions that can address 21st century social, economic, and environmental challenges. 'ĀBL will help to instill a sense of kuleana (responsibility) to mālama (care for) place, people, and planet with the flexibility to tailor learning plans to the interests and goals of each student.

Namahana's campus design is unique in that it prioritizes connections with the 'āina and community; our 'āina-based learning model is deeply grounded in real-life experiences with and on the 'āina, in the very places many of our students and families have lived for generations. Namahana students will gain knowledge and skills from community organizations, kūpuna, local businesses, and other local leaders through field studies and internships. Students will also have opportunities to explore their interests through internships and work on addressing issues that directly affect the communities in which they live. All coursework of Namahana School will be designed to prepare students to successfully enter both college and/or a well-paying career in our community, depending upon the student's personal learning plans and interests. Finally, our 'ĀBL model and assessment practices differ from other place-based models in that students' learning must maintain and mālama (care for) relationships in the community.

## 4. Describe the target population to be served; and

Namahana School will open in August 2025 with 120 students in grades 7th and 8th, phasing in one grade/year in the following four years so that Namahana School will be in full operation by Year Five. The completed middle school will serve approximately 120 students and the completed high school will serve approximately 240 students, resulting in a total of 360 students at capacity. Namahana School will primarily serve

students in the geographic location of Halele'a and Ko'olau on Kaua'i. We anticipate that the majority of Namahana students will come from Hanalei Elementary School and Kīlauea Elementary School with some possible enrollment coming from local private and homeschool entities. Based on an analysis of the total population from which our students will come, we anticipate these school enrollment percentages: 40% students eligible for the Free and Reduced-priced lunch program (FRL); 8% students receiving Special Education services, and 5% English Language Learners.

5. Describe the geographic coverage.

Namahana School will primarily serve students from the North Shore towns of Hā'ena, Wainiha, Hanalei, Princeville, Kīlauea, Moloa'a, and Anahola.

## III. Service Summary and Outcomes

<u>Scope of Work:</u> Namahana Education Foundation is requesting funds to cover construction of 8 middle school classrooms, serving 120 students in two grades, just over 30% of the school's student population.

Entire Project Tasks: The following tasks will be performed:

- 1) Complete construction documents and permit set for the classroom buildings.
- 2) Hire a General Contractor to install the WABi classroom structures
- 3) Submission of sitework and building permits
- 4) Fabrication and Shipping of WABi classroom structures
- 5) WABi classroom installation by General Contractor
- 5) Inspections and receipt of certificate of occupancy

The Hawaii GIA funds would cover the cost of the installation and finishing of 8 middle school WABi classrooms. If the GIA funds are disbursed later than expected, NEF would request the funds be used toward the cost of manufacturing 8 high school classrooms.

#### Roles and responsibilities:

- WABi Systems will provide design and engineering for the pre-manufactured classroom structures.
- NEF's architect, G70, will work with WABi to complete schematics and site plan; permit set and construction documents.
- Kurt Fischer Structural Engineering will review and stamp WABi designs to ensure they meet the 2018 International Building Code.

- Namahana's Facilities Advisory Committee (FAC) will provide input and guidance during the design and construction document phase, review General Contractor candidates, and make a recommendation to the NEF board for hire. (see V.1 for FAC's membership and qualifications)
- Namahana Education Foundation's board and Namahana School's Governing board will review and approve facilities construction documents and NEF's board will hire the General Contractor.
- Hanalei CDM will provide Construction Management (CM) Services
- G70 is providing Project Management services, facilitating meetings between Owner, Architect, and Contractor to ensure project is on schedule and within approved budgets.
- Namahana Education Foundation's Executive Director will work with the CM manager and G70's Project Manager to provide oversight and management of the Phase I project.

During the construction phase, NEF's Construction Manager (CM) will review and coordinate project scheduling with the construction contractor and conduct regular site visits to monitor construction contractor's progress and ensure that each stage of the construction is started and completed according to our construction schedule. The CM will review any time extension requests or change orders and advise NEF on any anticipated schedule or cost impacts for the project. Any deviations from the anticipated

schedule or budget will be reviewed and addressed immediately by the NEF Executive Director and Facilities Advisory Committee. The CM will also verify materials delivered to the site and coordinate and receive County inspections. At minimum, bi-weekly progress reports will be provided by the CM to NEF's Executive Director and Facilities Advisory Committee. NEF's Executive Director and Facilities Advisory Committee Chair will provide monthly progress reports to the NEF Board of Directors. G70's Project Manager will facilitate bi-weekly Owner/CM/Architect/Contractor meetings, review and process monthly pay applications, review and process change proposals/change orders and coordinate the close out.

State per-pupil funding for charter schools does not cover any pre-opening operating expenses, nor does it provide funding for facilities construction. As a result, communities must seek funds through other contributions and grants for both operational and capital expenses to start a charter school.

The \$1,380,000 we are requesting for the installation of eight middle school modular classrooms by WABi Systems represents 18% of the total middle school campus construction cost, which is estimated at \$8 million. These modular structures were selected for their cost-efficiency, durability, and ability to meet expedited timelines, reducing overall construction costs compared to traditional methods. The use of high-quality, prefabricated systems minimizes labor costs, shortens the installation period, and ensures compliance with ADA and building standards.

NEF is currently raising funds for the construction of the middle school campus and pre-opening operating costs. Our goal is to raise \$10M. We have already raised \$6M and must raise the remaining \$4M. In addition to our Hawaii GIA capital grant request, we are seeking the following additional sources of funding:

- Federal HUD Congressional Appropriation request for Phase II high school construction: \$3M
- Private donations and grants through our ongoing capital campaign.

We have received the following state and federal grants:

<u>Hawaii State GIA Operating Grant</u> for \$125,000 for FY 2024 to conduct an Environmental Assessment (EA) of the school site and support the completion of pre-

assurances required by the Hawai'i State Public Charter School Commission. With this grant, NEF engaged Terracon, our environmental consultant, and Cultural Surveys Hawaii to complete required archeological literature reviews and Section 106 consultation. Terracon completed a draft Environmental Assessment report, which is now being finalized for federal agency review.

<u>The Federal Charter School Program (CSP) grant</u>: We received a 3-year grant from the federal Department of Education to support Namahana School's operating expenses for the next three years:

- \$206,468 for budget period 10/01/2023 09/30/2024
- \$431,506 for budget period 10/01/2024 09/30/2025
- \$373,303 for budget period 10/01/2025 09/30/2026

## V. Experience and Capability

## 1. Necessary Skills and Experience

The applicant shall demonstrate that it has the necessary skills, abilities, knowledge of, and experience relating to the request. Namahana Education Foundation (NEF) has established a strong track record of fundraising and project management, having raised over \$7 million for the school since its inception in 2020. In 2023, NEF raised \$1.4 million in three months to secure the 11.3 acre site for Namahana School. NEF has consistently demonstrated excellence in project management. NEF has managed the master planning and design process for the school's permanent site, secured necessary entitlements to move the project forward, and secured a temporary rental facility for Namahana School's opening year. We are excited to break ground in the summer of 2025 and provide a permanent home and bring this school to life for North Shore students and their families.

On-going operations: Long-term, Namahana School is in an excellent position of financial solvency. The school received a \$2.08 million grant from a private donor for operating expenses, payable at \$150,000 per year through 2032 to fund pre-opening operating costs for Namahana School. These funds are for operations only and cannot be used toward capital costs. Namahana School also received \$1.1M in Charter School start up federal funds between October 2023 – September 2026 for school operation, and the New School Venture Fund grant for \$215,000 this year. Namahana School plans to apply for a \$1 million federal Charter School Program expansion grant to

support the roll out of additional grades after the first year of operations. Once Namahana School is operational in August 2025, the school will receive per-pupil funding starting in July 2025 from the Hawai'i State Charter School Commission to cover school operational costs.

Fundraising: NEF's capital campaign steering committee is laser-focused on raising the needed funds to complete campus construction, and will include private, state and federal grants. The committee is comprised of respected and influential community members to lead the fundraising effort. NEF hired a full-time Chief Development Officer in January 2024 and engaged a capital campaign consultant to give advanced training to the capital campaign committee and foundation staff.

NEF's board and staff bring extensive skills and experience in educational fundraising, financing, real estate, impact investing, community development, and nonprofit management. Namahana School's leadership and board include a highly capable and experienced School Leader and governing board consisting of school administrators, educators, former nonprofit directors, attorneys, and current and former corporate managers. The Facilities Advisory Committee, which provides oversight of the campus design and build out, consists of NEF and Governing board members and community members with expertise in facilities development, real estate, project management and educational programming (see VI.1 for qualifications of key personnel and leads).

#### 2. Facilities

Namahana School's facilities will be located on 11.3 acres, directly in the heart of Kīlauea town. This new site is the ideal location for a public middle and high school, and will provide multiple benefits to the students and local community: 1) our middle and high school students can walk and bike to school, reducing traffic and easing the transportation burden for parents; 2) nearby businesses and local organizations can serve as walkable/easily accessible internship sites, many of whom have already provided letters of support to serve as internship sites; 3) because the site is located on the future main access road to Kīlauea which will connect directly with Kūhio Highway, parents and students who live north of Kīlauea will be able to access the school without driving through town; and 4) the site is adjacent to two future affordable housing developments which will increase housing options for our teachers.

Namahana School's Master Plan includes four phases: Phase 1 includes middle school classrooms, administrative facilities, a Maker Space and Resource Center; Phase 2 includes 9-12<sup>th</sup> grade high school classrooms; Phase 3 is a Learning Commons for whole school gatherings and a High School Maker Space; and Phase 4 is a gym.

The campus contains three advisory clusters: one for its middle school and two for its high school. Each cluster contains eight advisory classrooms and a central outdoor courtyard that serves as a piko. These classrooms are where curriculum instruction takes place outside the designated advisory periods. The advisory clusters each have a unique identity inspired by a natural element and reflected in artwork and architectural features: 'āina (land), ua (rain) and makani (wind). Surrounding each cluster are edible and educational gardens fed by rainwater catchment systems that support Namahana's 'āina-based curriculum.

The advisory is a pillar of Namahana's personalized and relationship-driven learning philosophy. Each advisory classroom includes a larger and smaller interior space to support different types of individual or group learning experiences. Shared between each pair of advisories are outdoor covered lānai. Designed for ample cross-ventilation, the interior and exterior spaces are interconnected to promote the flow of air, ideas and student interaction. We are requesting funds to construct 8 of these advisory classrooms.

Melanie Parker, Namahana Education Foundation Executive Director. Melanie brings 20 years of nonprofit and public sector experience spanning a variety of environmental nonprofits, county agency and public school programs. She managed a USDA-funded nutrition education program for 14 schools in Berkeley's public school district, and secured bridge funding and long-term sustainable funding streams for her program. Prior to joining NEF, Melanie served as the Namahana School Governing Board Chair through the charter application process. The NEF Executive Director manages all operations of the foundation, including oversight of fundraising and the Phase I facilities build out, working in conjunction with the Construction Manager, architect, Chief Development Officer and Facilities Advisory Committee.

<u>Bridget Thorpe, Chief Development Officer:</u> Bridget brings extensive experience in communications and marketing in both the nonprofit and corporate sector. She worked with Schneider Electric advising global Fortune 500s on renewable energy, carbon, and sustainability marketing initiatives. She received her MBA from University of Colorado at Boulder with an emphasis in Marketing and Corporate Governance from San Diego State University. Bridget will be overseeing the capital campaign, working with the

Executive Director, Capital Campaign Fundraising Consultant, and Namahana Capital Campaign Steering Committee to raise funds for Phase I construction.

## **Facilities Advisory Committee (FAC) Members**

Billy Eckert, FAC Chair: Billy brings extensive real estate and marketing experience, having been involved in over \$800 million dollars in real estate transactions and 10 years in sales and marketing in the surf industry. Billy has successfully guided hundreds of local, national and multinational clients with their real estate acquisitions and dispositions, and has consistently been an award-winning and top producing agent. Billy is serving as the Co-Chair of the Facilities Advisory Committee and is a member of the Namahana Education Foundation Board.

Adam Roversi, FAC Member: Adam currently serves as Housing Director for the County of Kaua'i, where he oversees sizable affordable housing and infrastructure projects from concept to completion including pre-development, site evaluation, contract negotiation, project oversight, and eventual move-in and management of completed projects. He also served five plus years as Deputy County Attorney for the County of Kaua'i. Adam also worked as a former licensed contractor on Kaua'i specializing in residential construction. Adam is serving as the Co-Chair of the Facilities Advisory Committee and is a member of the Namahana School Governing Board.

Jack Lewis, FAC Member: Jack brings over 17 years of project management in commercial construction projects on the mainland and in Hawai'i ranging \$800K - \$600MM. As Director of Development with the North Shore Preserve he managed permit applications, and construction for golf course renovation, utility/infrastructure projects, and vertical building construction with values totaling over \$50M. While at Hensel Phelps Construction Co. on O'ahu, he managed the design-build clinic renovation project for Tripler Army Medical Center from an RFP concept design for five spaces in the active hospital and completed approximately 30,000 SF of dental surgery, administration, physical therapy, and occupational therapy spaces for the hospital over approximately two years. Jack is serving as a member of the Facilities Advisory Committee.

Dr. Kapua Chandler, School Leader for Namahana School brings a wealth of knowledge, history, and educational leadership to the position. Born and raised in Kīlauea, Kapua is a kupaʻāina and lineal descendant of Koʻolau and Haleleʻa. Dr. Chandler has been facilitating key partnerships, working closely with ʻāina-based educators, the governing board, and Big Picture Learning to develop a school model that is reflective of and responsive to the community. She completed her Ph.D. program from UCLA in Higher Education and Organizational Change and holds two master's degrees, in Higher Education and Organizational Change (M.A. from UCLA) and Educational Administration (M.Ed. from UH Mānoa). As School Leader, Dr. Chandler oversees all Namahana School operations and works closely with the board's Academic Committee to develop the school's educational program and curriculum.

Pam Murphy, Namahana School Governing Board Chair: Pam served on Mammoth Mountain Ski Resort's senior management team for nearly 20 years and in her tenure oversaw many divisions including marketing, resort operations, retail, rental, ticket sales, ski and snowboard school, events, hospitality, planning, sponsorships and more. As Senior Vice President she planned and administered annual operating budgets of \$25 million and held accountability for over \$100 million in annual revenues. In her role as Governing Board Chair, Pam provides oversight and leadership for the Governing Board.

Marion Paul, Namahana School Governing Board Member: Marion brings 30+ years of experience in the nonprofit management sector. She is a non-profit consultant working to improve the island's nonprofit capacity. Marion most recently served as president of Kaua'i Planning and Action Alliance (KPAA), including their flagship Keiki to Career Kaua'i, an island-wide collective impact initiative to create great futures for all of Kaua'i's youth. As executive vice president of Junior Achievement, Marion raised eight million dollars and oversaw the construction of a 10,000 square foot mini-city called BizTown, where students learn how to run businesses and manage their money. In addition to serving on the Namahana School Governing Board, Marion is also a member of the Facilities Advisory Committee and Governance Committee.

#### **Contractors:**

Charles Kaneshiro, Group70 International (G70): Charles Kaneshiro is President and COO of G70, Hawai'i's largest multidisciplinary design firm with extensive educational design experience, having designed more than 1 million square feet of K-12 educational facilities in Hawai'i and around the Pacific Rim. Charles specializes in the planning and design of educational and institutional facilities. He has effectively and successfully guided projects from master planning to programming, design and construction. A former high school math and chemistry teacher, Charles has taught in both public and private schools. As one of the first LEED accredited professionals in Hawai'i and 2007-2009 Green Schools advocate for the USGBC Hawai'i Chapter, Charles has a passion for designing sustainable schools. Charles Kaneshiro is leading the G70 team to provide design and planning services for Namahana School's Phase I facilities.



He also served as Construction Manager for tenant Improvements for Starbucks, McCoy Sports, Panache, New York Deli, Unbound Snowboard Shop, Mammoth Daycare Center, Hyde Night Club, and remodels and renovations in large restaurant and retail spaces and the Nordic cross-country center. Jack also served as General Contractor for numerous commercial renovations including Mogul Restaurant, Berger's Burgers, Mammoth Dental Office, Roberto's Restaurant, Ocean Harvest Restaurant, Mammoth Gallery, and 8050 Discovery Center. Jack will be providing Construction Management Services for Namahana Education Foundation.

## 4. Future Sustainability Plan

Namahana Education Foundation is implementing a comprehensive fundraising plan to raise the funds needed to complete campus construction and support operating costs. This plan includes a current \$10 million capital campaign to construct the middle school campus through private, state and federal grants, as well as private donations and community partnerships. We have raised \$6 million toward that goal. NEF has

constructed a capital campaign committee comprised of respected and influential community members to lead the fundraising effort. NEF hired a Chief Development Officer in January 2024 and engaged a capital campaign consultant to ensure the structure of the campaign is sound and to give advanced training to the Executive Director, Chief Development Officer, capital campaign committee and staff. NEF is also currently exploring options to secure a construction loan to provide any additional capital needed to complete construction until the required funds are secured. And for the long term, NEF plans to apply for a USDA Rural Development Community Facilities loan. To support school operating expenses beyond FY2025, NEF secured \$1 million in federal funding from the federal DOE's Charter School Program, which provides operating funds for three years to support high quality start-up charter schools. Namahana School also plans to apply for an additional CSP grant in the first year of school operations for \$1 million over three years for operating support.

In addition to the current funds raised by NEF, the Kauai North Shore Community Foundation (KNSCF) received a \$2.08 million grant from a private donor for operating expenses for Namahana School, payable at \$150,000 per year through 2032. NEF entered into an MOU with KNSCF and is currently receiving annual disbursements of \$150,000 to fund pre-opening operating costs for Namahana School. Once Namahana School is operational in August 2025, the school will receive state per-pupil funding starting in July 2025 from the Hawai'i State Charter School Commission to cover school operational costs.
