Founded in 1989, Pali Momi Medical Center is part of Hawai'i Pacific Health, which is one of the largest health care systems in the state. Pali Momi has delivered many medical firsts for Central and West Oahu, including its Level III Trauma Center, the interventional cardiac catheterization units, and the comprehensive cancer center. With more than 600 physicians on its

medical staff, Pali Momi admits nearly 6,000 patients, has over 43,000 emergency visits, and cares for nearly 500 trauma patients per year. Pali Momi is investing in technology and facilities to continue providing excellent healthcare services for this community.

Pali Momi Foundation was established in 2011 as the philanthropic arm of Pali Momi Medical Center. Our mission is to create a healthier Hawai'i.

2. The goals and objectives related to the request;

Pali Momi Foundation seeks to upgrade its Computed Tomography (CT) scanner. CT scans use a combination of x-rays and a computer to create pictures of a patient's organs, bones, and tissues. The imaging shows more detail than a regular x-ray, allowing for effective diagnosis and treatment of various types of cancer, strokes, heart conditions, and other medical issues.

The project objectives are to:

- 1. Replace the current CT scanner, which is 20 years old, with state-of-the-art equipment offering advanced imaging technology. The Imaging Department will be renovated to accommodate the new scanner and peripheral equipment.
- 2. <u>Improve patient care and safety</u> with superior image quality, reduced scan times, and reduced radiation doses. Patients will further benefit from the equipment features designed for comfort and safety.

3. The public purpose and need to be served;

Pali Momi seeks to upgrade its CT scanner to ensure rapid clinical decision-making for stroke, trauma, and other urgent medical conditions. Physicians often reference the "golden hour" in trauma, which is the period of time following a traumatic event or injury during which there is the highest likelihood that prompt medical and surgical intervention will afford the highest probability of survival and return to functional independence. For example, CT scans are often one of the first tests done in a stroke evaluation; the scan can show areas of abnormalities in the brain and help determine if they are caused by insufficient blood flow (ischemic stroke) or ruptured vessel (hemorrhage). CT scans are also used in trauma and general medicine to diagnose muscle and bone conditions, such as tumors or fractures, and to assess the extent of brain injuries.

Additionally, CT scans are used to detect abnormalities, such as cancer, in many areas of the body including the brain, spine, chest, abdomen, or pelvis. These images are used in cancer treatment to determine the size, location, and shape of tumors; assess if cancer has spread to nearby organs or tissues; and to guide a needle for CT-guided biopsies. Physicians rely on CT in treatment planning such as surgery, biopsy, and radiation therapy and the use of CT reduces the need for exploratory surgeries, which are more invasive and pose higher risk to the patient.

4. Describe the target population to be served; and

Pali Momi Medical Center meets the emergency and healthcare needs of residents living in Central and West Oʻahu. Recognizing that a CT scan is one of the first steps in evaluating a trauma or stroke patient, this investment will save lives with speedier response and higher quality imaging. The Imaging Department conducted 21,200 CT scans in 2024, which was a 27% increase in volume over 16,700 CT scans in 2020. Of the CT scans performed last year, 41% were for emergency patients, 25% were inpatient, 27% were outpatient, and 6% were observation procedures.

Pali Momi admits over 6,000 patients, has over 43,000 emergency visits, and cares for nearly 500 trauma patients per year. Approximately 63% of Pali Momi patients are over the age of 65. About 14% of Pali Momi patients are uninsured or underinsured.

5. Describe the geographic coverage.

Pali Momi Medical Center is located at 98-1079 Moanalua Road, 'Aiea. It is the only Level III Trauma Center serving the Central and West O'ahu areas, providing life-saving emergency and trauma services for this community.

III. Service Summary and Outcomes

The proposed system is a Phillips CT 5300 Pro, which offers advanced positioning and features allowing the technician to stay close to the patient throughout the procedure. This system has advanced features for specialized imaging across all applications including cardiac, bariatric, interventional, and trauma. It uses artificial intelligence to guide patient positioning, so that technicians can efficiently and effectively implement scans.

The Imaging Department has reviewed various options for this investment and is working with the vendor to order the equipment, information technology, and accessories. The Project Management Team developed design and schematics for the areas that will be reconfigured to accommodate this system. They will apply for county construction permits, as needed, and secure a construction contractor through competitive bid process. Once construction is complete, the new CT will be installed, and the Imaging Department will train technicians and radiologists on the new system and features.

The project will be managed by David Yamaguchi, HPH Project Manager. He will oversee the design, planning, permitting, construction, and inspection processes. Mr. Yamaguchi will monitor and evaluate the progress of the project and provide progress reports and necessary feedback to the project stakeholders and executive leadership. The Capital Allocations Committee and Finance Committee will review and approve the project budget. A team of design and construction professionals, under the management of Mr. Yamaguchi, will be responsible for review of construction proposals, material and equipment specifications, vendor selections, periodic progress inspections, and final inspection upon completion.

Pali Momi has been instrumental in elevating the level of care for Central and West Oʻahu through investments in state-of-the-art technology. The medical center brought to West Oʻahu its first permanent MRI, 320-slice CT scanner and cardiac catheterization program.

The Pali Momi Imaging Department offers a full complement of comprehensive diagnostic imaging services and is equipped with the latest, most advanced technology. Imaging services are offered during the early mornings, weekends, and evenings to accommodate patients' busy schedules. Services include CT scans, electroencephalogram (EEG), mammography, magnetic resonance imaging (MRI), nuclear medicine, osteoporosis (DEXA), and ultrasound. The Imaging Department employs safe scanning procedures and ensures that the radiation dosages used are below the nationally recommended levels.

The Imaging Department of Pali Momi Medical Center is a 12,609 square foot facility, including a 500 square foot room for CT scans. The CT scan room will be renovated to accommodate the new system. The total project cost is \$2.5 million, including \$1 million for the Phillips CT 5300 Pro.

His background as a Construction Manager, Owner's Representative, and General Contractor gives him an excellent overall perspective of project management and delivery.

In his current position, Mr. Yamaguchi has managed over 90 projects representing over \$110 million and currently manages \$49 million in projects throughout the system. Mr. Yamaguchi reports directly to Warren Chaiko, who has been with Hawai'i Pacific Health for twenty years. Mr. Chaiko is a Senior Vice President with system-wide responsibility for the company's design, construction, leasing, real estate and facility master planning activities.

Other key staff members contributing to this project are:

- · Gloria Brooks, Chief Operating Officer. Ms. Brooks has more than 30 years of experience in the healthcare industry. She has a bachelor's degree from the University of Tennessee at Memphis and a master's degree in business administration from Loma Linda University School of Public Health.
- Nancy von Borzestowski, ARRT (R) (M), Director of Imaging & Radiology. Ms. von Borzestowski is the lead staff member overseeing MRI, CT, Ultrasound, Nuclear Medicine, Interventional Radiology, Diagnostic Imaging, and the Women's Center. Employed at Pali Momi since 2014, she holds a license in Radiologic Technology and a bachelor's degree in General Studies, Management focus, from Charter Oak State College.
- · Courtney Wagner, Development Officer. Courtney is responsible for raising funds to support the clinical, research, and educational goals of Pali Momi Medical Center. She has an MBA from the University of Hawai'i.

The Pali Momi Emergency Department is a Level III Trauma Center designated by the State of Hawai'i and verified by the American College of Surgeons. This designation demonstrates the ability to provide prompt assessment, resuscitation, stabilization, surgery, and intensive care of injured persons. Elements of Level III Trauma Centers include: 24-hour immediate coverage by board-certified physicians from emergency medicine, general surgery, orthopedics, and anesthesiology. Other requirements include a quality assessment and performance improvement program; transfer agreements for patients requiring higher levels of care; acceptance of patients from rural and non-trauma capable hospitals; ongoing educational offerings of nursing and allied health personnel or the trauma team; offering injury and disease prevention efforts and active outreach programs for its referring communities.

Pali Momi is accredited as an American Heart Association/American Stroke Association (AHA/ASA) Primary Stroke Center and has achieved multiple consecutive year awards of distinction from the AHA/ASA Get With the Guidelines recognition program.

Staff members of the Imaging Department hold the appropriate licenses and certifications for their respective positions.
