Special Olympics Hawaii Inc. (SOHI) is a non-profit 501(c)(3) organization dedicated to transforming the lives of people with intellectual disabilities (ID) through programming in sports, health, education, and community building. Special Olympics Hawaii was founded in 1968.

Our competitive program, for athletes ages 8 and over, serves 4200 athletes and unified partners (individuals without ID who compete alongside athletes with ID). Our Young Athlete Program serves over 800 2-7 year olds annually. In addition to sports, our initiatives include:

- A Young Athlete Program that introduces children with ID ages 2-7 to sports skills, movement, and socialization and provides parents and teachers with a curriculum
- Unified Champion Schools for K-12 schools programming that promotes social inclusion by providing opportunities for young people with and without disabilities to join unified sports teams, inclusive student clubs, school or community-wide initiatives, and youth leadership training

- Leadership Conferences for athletes, volunteers and family members
- An O'hana Task Force offering support, education, and a voice to our families
- Athlete leadership and public speaking training: Toastmaster's, Global Messengers, and an Athlete Leadership Council
- Healthy Community status as accredited by Special Olympics Inc., for work in creating and training a network of care givers for those with ID, for providing Healthy Athlete screenings in 7 disciplines, physician referrals with follow up, health education, and free medical exams required for sports participation
- Holo Holo walking clubs, fitness and conditioning training
- 2. The goals and objectives related to the request;

This request is to provide funding for sports training, competitions, fitness, and health exams and screenings for individuals with intellectual disabilities. SOHI offers 10 sports, and over 40 competitions and 3 State Games annually with weekly practices and training throughout the State of Hawaii. SOHI also provides free medical screenings, an introduction to sports for preschoolers, and inclusionary sports and recreation opportunities for elementary, middle, and high school students.

The three primary sports seasons include spring and early summer competitions with the sports of softball, track and field, powerlifting, and swimming with a final State Summer Games held in June. Summer sports include soccer and bocce with a state competition held in August, called the Aukake Classic. The fall season includes bocce, basketball, and bowling with the Holiday Classic State Games held in November. A season for flag football is held from January to March.

Goals and objectives include:

- 1. 2000 athletes and unified partners will participate in sports training and competition. Sports are a catalyst for people with ID to benefit from an inclusive, active, responsive environment where they can excel, gain confidence and fitness, and enjoy friendships that last a lifetime.
- 2. 40 competitions and 3 State Games will be held with 10 sports offered. For a typically underserved population the opportunity to achieve personal bests, experience team sports and unforgettable sports moments is often a stepping stone for further life achievements.
- 3. 800 Pre-school young athlete (ages 2-7) will participate in programs including annual Play Days in each district, monthly Play Days held at the SOHI complex, and Kama'Aina Kids Basketball in January, February and March. Preschool teachers also receive a curriculum that can be implemented in their classrooms.
- 4. 150 students will participate in school based Unified League Play. Unified participation in sports in middle and high schools creates understanding, acceptance, and inclusion beyond the playing field. Middle and High school students compete in League Play which includes an early spring season of flag football with local competitions, fall basketball, and Move to Include Holo Holo competitions in November and April. League Play is in addition to the sports that schools and students may participate in for the annual 3 State Games through Unified Champion Schools.

- 5. 300 free health exams and screenings will be completed through Medfests held on Oahu, the Big Island, Maui, and Kauai, and at Healthy Athlete venues at State Games. SOHI's Pediatric Healthy Athlete initiative screens preschool children. Athlete medicals often reveal previously unnoticed conditions that can sometimes be treated on the spot or if needed through a referral to a physician familiar with ID. Diagnosing problems early improves the lives of the athletes for the long term and ensures they can participate in sports at a meaningful level. Healthy Athlete events screen athletes in 7 disciplines including eyes, hearing, feet, dental health, health promotion, fun fitness, and strong minds. Health screenings educate both the clinician and the athlete. SOHI trains clinicians in the best way to reduce fears athletes often have regarding medical issues and authority figures, and how to recognize that symptoms are not necessarily due to a disability.
- 3. The public purpose and need to be served;

SOHI's mission is to provide year round sports training and athletic competition in a variety of Olympic-type sports for children and adults with intellectual disabilities, giving them continuing opportunities to develop physical fitness, demonstrate courage, experience joy, and participate in a sharing of gifts, skills, and friendship with their families, other Special Olympics athletes, and the community.

SOHI addresses the needs of people with ID directly by providing resources, educational and leadership programs not only for athletes but for health providers and the community. We promote positive health behaviors, reduce risky behavior, and enhance self-advocacy among individuals with ID. These initiatives and SOHI's in-depth sports programs teach individuals with intellectual disabilities the skills to achieve healthy lifestyles and self-efficacy. As one of only 50 worldwide programs accredited as a Healthy Community, SOHI advocates for equitable access to quality health care, education, and services for individuals with ID. Year-round programming builds community resilience for athletes, families, coaches and volunteers. Now, at our permanent location, SOHI's stakeholders can be assured they have support and resources easily accessed in accommodating surroundings.

4. Describe the target population to be served; and

SOHI serves individuals with intellectual disabilities beginning at age 2. Kupuna of any age are welcome in all programming and SOHI supports intergenerational participation. To provide individuals with intellectual disabilities the opportunity to participate and grow in an inclusive community, SOHI also provides Unified team sports and activities where athletes with intellectual disabilities interact, compete, and socialize with fellow students, volunteers, and O'hana on a regular and recurring basis.

Over 55% of all SOHI participants are adults with intellectual disabilities who meet HUD's definition of severely disabled, all of whom qualify as low- to moderateincome according to HUD guidelines. In addition, at least 75% of the participants served qualify as low- to moderate-income according to HUD guidelines. 5. Describe the geographic coverage.

Special Olympics Hawaii provides services on the islands of Oahu, Maui, Kauai, Hawaii Island, Lanai, and Molokai.

For 56 years SOHI has grown in numbers and programming and triumphed over numerous challenging obstacles to best serve individuals with intellectual disabilities. SOHI annually provides extensive, quality, year-round sports training and athletic competitions, health and youth initiatives, leadership programming, Ohana support and engagement, volunteerism ranging from dedicated, long-term coaches to annual day of partners in an inclusive setting for children and adults with ID. SOHI's programs and services foster an increased understanding and integration of people with intellectual disabilities in the greater community, advancing self-efficacy for the athletes.

SOHI met key indicators of success in the past 3 years. In 2024 and 2023, SOHI held 3 State Games with over 40 competitions in 10 sports serving 2000 athletes and partners annually. In 2022, despite lingering Covid fears, SOHI held 3 State Games, and 25 competitions serving 1400 athletes and partners. SOHI has consistently provided programming for 800-1000 Young Athletes which included virtual programming in 2022. League Play started in 2021 and has performed consistently over the last 3 years with 100-175 participants. Since 2016, SOHI has provided health initiatives to our community. Health exams and screenings through Healthy Athlete venues and Medfest have numbered from 300-500 annually.

On the national level, the excellence of our programs is illustrated by Special Olympics being named the Top Disability Organization in the Harris Poll Annual EquiTrend Study. This study was based on consumer responses of the strongest brands in nearly 100 categories across multiple industries, measuring an organization's brand health over time based on familiarity, quality, and purchase consideration to determine equity rating for each brand.

As a recognized Healthy Community, SOHI continues to make strides in Hawaii toward equitable access to quality health care education and services in all communities for people with ID.

Charity Navigator has scored SOHI at 100% with a 4 star rating, signifying that the organization achieves or exceeds industry standards. SOHI adheres to sector best practices and is accredited by Special Olympics, Inc. annually, ensuring that programs maintain the highest level of standards for its participants and families.

Special Olympics Hawaii works with the University of Hawaii, Kaiser High School, Waiau District Park, Joint Base Pearl Harbor Hickam, and Marine Corp Base Kaneohe to secure facilities for State Competitions. SOHI secures facilities far in advance of State Games and competitions and maintains relationships throughout the year to ensure facilities are available for our competitions and State Games.

SOHI works with the numerous Department of Education schools and County Parks to secure training and competition sites for practices and area/regional competitions. SOHI can now also use the field, and soon, the outdoor play court, at our new facility in Kapolei to accommodate some local competitions

## VI. Personnel: Project Organization and Staffing

#### 1. Proposed Staffing, Staff Qualifications, Supervision and Training

SOHI's proven organizational and logistical skills, extensive sports training, institutional experience, and intimate knowledge of the joys and challenges experienced by individuals with intellectual disabilities uniquely qualify our organization to fulfill the grant goals and scope of work. Our CEO and Senior Vice President have trained Special Olympic National and World Games coaches and have stepped up to pilot programs such as Healthy Communities and Toastmasters. Hawaii is well respected in the Special Olympics community and our Summer Games is a flagship for other state programs.

Senior Vice President Nip (Margaret) Ho, with SOHI since 1996, will oversee all sports training and competitions, Area Director staff and Management Teams. Nip was a Special Education teacher for 6 years and is certified for Special Education Birth – 12th Grade, regular Elementary Education and Physical Education. She served as the Area Director of Wyoming for 6 years prior to joining SOHI. Nip has managed 80 State Games and innumerable competitions. Nip reports to SOHI's CEO and Board of Directors.

Cindy Ujimori, our Vice President of Community Outreach since 2005, will oversee volunteer recruitment, manage housing and transportation for all State Games, and recruit sponsors for State Games. She runs logistics at State Games for the Law Enforcement Torch Run in addition to assisting with Opening Ceremonies, hospitality, and other multiple venues. Cindy is also the Human Resources Director for SOHI and has a BA in Business Administration from UH-Manoa. Cindy reports to SOHI's CEO and Board of Directors.

#### Regional Directors:

SOHI's 2 Regional Directors oversee multiple Area programs and Staff. The Maui County Area Director oversees the Neighbor Islands including Maui, Molokai, Kauai, Lanai, and Hawaii. The Oahu Area Director oversees Leeward, Windward, and Central Oahu programs. Their key responsibility is to ensure that quality Special Olympics sports training programs and athletic competition events are available to all eligible individuals with ID in a specific geographic location. AD's conduct area and regional competitions, recruit new athletes, manage athlete registration, medical records, competition results, and volunteer screening. They create and maintain relationships with coaches, heads of delegations, and family members holding frequent meetings and communications to ensure quality programming. Regional Directors report to the Senior Vice President and CEO.

SOHI's Senior Staff have been with the organization for over 75 years bringing institutional and logistical knowledge combined with direct, hands on experience and an educated perspective regarding the needs and abilities of individuals with ID.

Over the years, we have been successful in increasing the sponsorship levels of several longtime supporters to become our Mission Partners, Year-Round Partners, and Event Sponsors. We hold a series of historically successful fundraisers annually that are recognized by the public, many of whom look forward to participating annually. These include Cheer for Champions, Over the Edge, Badges and Buckets, and Tip a Cop. We continuously review, transform, and research new revenue sources with the assistance of our Board of Directors, the Law Enforcement Torch Run, and our strong Development Team. SOHI continues to employ a diverse revenue plan to meet all program needs.
