1. A brief description of the applicant's background;

In 1983, Straub Medical Center (now Straub Benioff Medical Center) established the first and only burn unit serving Hawai'i and the Pacific Region. More than 2,000 people have received lifesaving and limb-preserving treatment at this burn unit. Patients of all ages receive state-of-the-art care for burns that may include chemical, electrical and thermal burns. In addition to

time-sensitive critical care, patients access multi-disciplinary services, including occupational therapy, psychological counseling, and rehabilitation services.

Reflecting on the response to the 2023 Maui wildfires, nine victims were transferred to Straub Benioff for care, which included complex surgeries and many months of in-patient recovery. Due to the technology and training available today, Straub Benioff can successfully treat patients with burns covering large portions of their body. If the casualties are higher than the facility can manage, as was the case in the 2024 New Year's Eve disasters, patients are served at nearby hospitals or flown to the mainland. By investing in this facility, Hawai'i will be better prepared to support victims of fires, chemical burns, and other disasters in the future.

2. The goals and objectives related to the request;

Straub Foundation seeks a Hawai'i State Grant-In-Aid to expand resources and increase capacity of the Straub Benioff Burn Care Unit. The recent fires in Lahaina and Salt Lake reiterate the need to invest in this highly specialized facility, as it serves residents and visitors from every community in Hawai'i.

The proposed project will:

- 1) <u>Increase capacity to respond to high acuity events.</u> Funding will support specialized staffing and training needs. Responding to high casualty events, nurses are pulled from other departments to meet the influx of victims. Staff members require training in burn triage and treatment, pain management, chemical attacks, and other specialty areas of burn care. The facility will further increase capacity by investing in equipment such as burn recovery beds, which help distribute a patient's weight using air or water.
- 2) Expand resources to improve the mental and physical recovery of burn victims. Psychological distress is common for burn patients. Many patients exhibit acute stress related to their pain, trauma response from the accident, depression due to their physical condition, and other psychological complications. Specialized training can help providers handle crisis situations in ways that de-escalate, while supporting the patient and avoiding additional trauma.

The facility will further invest in technology tools, such as pain distraction software, laptops, and iPads. These tools are used to help patients let their minds go somewhere else while their wounds are cleaned and dressed; the mental and emotional distraction significantly reduces their experience of pain and pain anxiety. Patients may also use technology to connect with friends and family members during extended hospital stays.

3. The public purpose and need to be served;

Catastrophic burn injuries are among the most devastating and painful injuries an individual can live through, according to the American Burn Association. Severe burns damage all three layers

of skin, as well as bone, muscle and blood vessels. Thus, burn units must be highly trained and highly coordinated to effectively respond to the variety of medical problems occurring for each patient.

The mental and emotional aspects of surviving trauma may be harder to overcome than the physical injuries. Patients struggle with the emotional impacts of their experience, which can impede their healing and recovery. Pain management is an essential component of patient care, as daily washing and dressing can be incredibly painful. Straub pursues new approaches and modern technologies to help patients deal with pain, so they can fully heal.

In disaster scenarios, Hawai'i residents may not survive if they had to be flown to the mainland for burn treatment. Without the Straub Benioff Burn Care Unit, surviving patients would be separated from their families and extended relationships if they had to recover in hospitals far from home. Last August, for example, nine Lahaina residents were transferred from Maui to Straub Benioff, some of whom suffered second- and third-degree burns covering up to 70 percent of their bodies. This was the largest influx of patients from a single incident in the history of this facility. Several patients were treated for many months, undergoing multiple surgeries and the arduous road to recovery.

4. Describe the target population to be served; and

Each year, the Straub Benioff Burn Care Unit serves more than 120 individuals, many of whom are transferred from neighbor islands and other medical facilities. On average, acute burn patients are hospitalized for three months and severely burned patients are hospitalized for more than twelve months. Burns do not discriminate; thus, our patient population represents the ethnically diverse community of Hawai'i.

5. Describe the geographic coverage.

Straub Benioff Medical Center is located at 888 S. King Street, Honolulu, serving the urban core of Honolulu and the entire island of Oʻahu. The burn unit regularly takes patients from the neighbor islands, other U.S. territories such as Guam, Pacific nations such as Micronesia, and victims from fires occurring at sea.

III. Service Summary and Outcomes

The scope of work of the Burn Care Unit includes responding to large-scale events, training and preparing staff members, and providing patient care, which can last many months.

Straub Benioff relies on its 40 years of experience to deal with large-scale events, such as the recent New Year's Eve tragedies. In responding to a high influx of victims, physicians must review cases and determine which patients need to be transferred to Straub Benioff. Less severe cases may be better served at nearby medical centers. The stress and timing of travel is considered in high-casualty events.

Burn specific training is essential because burn injuries attack multiple systems in the body. Within 24 hours, the physiological changes brought on by the burned skin can be lethal. As skin burns, it loses bacterial barrier and thermoregulation. Toxic products from the burn lead to vascular changes that require large amounts of intravenous fluid. Otherwise, blood pressure will drop to shock level and organs may stop functioning. Ongoing training helps ensure burn victims receive appropriate care at every interaction, which may include care provided by emergency responders, other medical providers, and our staff at Straub Benioff.

Patient care is multi-faceted and offered with the utmost compassion. For example, nurses must administer pain medication when providing baths to remove dead skin and prevent infection. Burn unit staff members possess the clinical skill to know how much medication is medically appropriate, while offering comfort and reassurance to help patients endure this process.

This project will be managed by Straub Benioff Medical Center Burn Care Unit Supervisor, Amy Chong, RN. She will evaluate the staff member's progress and performance closely to provide feedback and guidance as necessary. Additionally, Straub Benioff Medical Center's capital expense meeting committee will oversee the purchase and implementation of all new equipment. This committee will review vendors, costs and inspect upon receipt.

The Straub Benioff Burn Care Unit has been saving the lives of burn victims for more than 40 years. As the only specialized burn facility in the Pacific region, Straub Benioff has unique skills, abilities and experience to provide this type of healthcare.

Straub Benioff is the only provider of ABLS training in the state, engaging with statewide networks to increase access to burn training. These organizations include Hawai'i Trauma Advisory Council, Hawai'i Society of Trauma Nurses, Hawai'i Fire Department, and American Burn Association. Lead staff members travel to neighbor islands to train first responders, including firefighters and EMTs. Straub collaborates with Kapiolani Community College to provide EMT and burn-specific training.

Straub Benioff is affiliated with several groups focused on burn injuries and treatment, including American Burn Association, Sons of the Flag (support groups for military and first responders burned in the line of duty), International Association of Firefighters, City & County of Honolulu Fire Department, Western Regional Burn Disaster Consortium, and Phoenix Society for Burn Survivors. Our behavioral health partners include the Straub Social Work team, affiliated

psychiatric providers, and the Phoenix SOAR Group (Survivors Offering Assistance in Recovery).

A recent project within the last three years include the renovation of Straub Benioff Emergency Department to improve efficiency and expand capacity. This facility was upgraded to meet the growing healthcare needs, serving 30,000 patients annually. Funded by private donations, grants, and operating capital, this project was completed on time at a cost of \$2 million.

2. Facilities

The Burn Care Unit is located at the Straub Benioff Medical Center, 888 South King Street, Honolulu. The facility is available 24 hours a day, 365 days a year for emergency response and specialized care. The Burn Care Unit currently has four licensed burn beds and coordinates with the Critical Care Unit to accommodate higher patient loads. For mass casualty events, Straub Benioff coordinates with the regional burn disaster consortium to find available burn beds in western states; patients are transported to other burn centers, keeping family members together whenever possible.

VI. Personnel: Project Organization and Staffing

1. Proposed Staffing, Staff Qualifications, Supervision and Training

Patients of the Burn Care Unit have access to a multidisciplinary health care team who provide both inpatient and outpatient care. Burn injuries require a highly coordinated, multidisciplinary team approach. Serious burns affect many functions of the body, so the team at Straub Benioff must quickly assess patients and design a complex response that is tailored to each individual. Surgeons coordinate interventions that affect multiple systems. Physical and occupational therapists work to protect patients from loss of motion and strength. Social workers provide support with issues ranging from loss of family members to rehabilitation after discharge. Every member of the team plays a vital role in the care, recovery and outcome of each patient.

The lead staff members are:

Director Robert W. Schulz, MD, who joined Straub Benioff in 1977 and helped establish the Burn Unit in 1983. He was honored as the 2016 Healthcare Hawai'i Physician of the Year. He holds a Doctorate in Medicine from George Washington University and is board certified by the American Board of Plastic and Reconstructive Surgery.

Amy Chong, RN, Burn Care Unit Supervisor, Amy received her RN and Master's Degrees from the University of Hawai'i at Manoa. She has been an employee of Hawai'i Pacific Health for almost 20 years, the past five years serving on the burn care unit team moving into progressive leadership roles.

David Cho, MD, a board-certified plastic surgeon specializing in cosmetic and reconstructive surgery. Dr. Cho has been named as one of Honolulu Magazine's "Top Doctors in Hawai'i" and is listed in Castle Connolly's Top Doctor Guide. He is board certified by the American Board of Plastic Surgery and is an active member of the American Society of Plastic Surgery.

Michael Pharaon, MD, who received his medical degree from the Medical College of Wisconsin and completed his General Surgery Residency at the University of California, Irvine. He is board certified by the American Board of Plastic Surgery. Additionally, Dr. Pharaon travels each year internationally to perform surgery for those in need.

Straub Foundation has one full-time and five shared employees, along with seven volunteer foundation board members. Straub Medical Center has 1,737 staff members and 34 active volunteers.

Straub Benioff Medical Center is a not-for-profit organization that relies on community support to offer the specialized and essential services of this burn unit. Many burn victims do not have sufficient health insurance to cover the actual costs of surgeries and extended stays. Thus, Straub Benioff often cannot recuperate the costs of treatment due to the limits to insurance coverage for severe burns. For these reasons, Straub Benioff pursues public and private funds to offset the expense of life-saving care for burn victims.

As large-scale wildfires and natural disasters persist in Hawaii and the U.S., the need for specialized burn healthcare endures. With support from this community, Straub Benioff will continue to invest in training and equipment to provide the best care available for the people of Hawai'i.
