Hina Mauka began services at the Hawaii State Hospital in 1969 and later was established as The Alcoholic Rehabilitation Services of Hawaii Inc. in July 1977 and has been serving the community for over five decades. With a dedicated team of 85 full-time and 21 part-time employees, we provide care to low-income adults (ages 18 and older) struggling with substance use disorders and co-occurring mental health conditions. Many our patients come from low to moderate income backgrounds, with 89% reporting an annual income of less than \$20,000.

Hina Mauka is a leader in treating individuals with complex needs, including substance use disorders, addiction, mental health challenges, and chronic health conditions. We offer a comprehensive range of services such as substance use treatment, co-occurring mental health disorder treatment, case management, peer mentoring, psychiatric services, prevention, and family education. Our approach is collaborative, involving multiple referral and treatment agencies in the development of personalized care plans.

Our treatment modalities include residential, day treatment, intensive outpatient programs, continuing care, and motivational enhancement groups. We utilize a variety of therapeutic techniques, including individual and group counseling, process groups, skill-building exercises, and relapse prevention education. We also provide cognitive therapies and peer group support to help clients achieve recovery.

Recently, we have expanded our services to include integrated care for mildly complex patients, offering coordination with psychiatrists, primary care physicians, and psychologists to address co-morbid health conditions. Additionally, we have introduced medication-assisted treatment and offender reentry programming to further support our clients.

Thanks to community and legislative support, we were able to add a new 16-bed wing to our residential facility to accommodate a long waitlist. However, our original 48-bed facility is showing signs of significant aging and deterioration, requiring attention to maintain our ability to provide essential services.

2. The goals and objectives related to the request;

The objective of this project is to continue with our roofing and solar capital improvement project in phase 2 ensuring the existing roof that has not been repaired in phase 1 of our project can withstand the expected 20-year lifespan of the newly installed solar panels.

Built in 1998, Hina Mauka is a healthcare facility providing 24/7 residential treatment services located in Windward Oahu and is committed to providing essential services to uninsured and underinsured individuals and Medicaid recipients. Located on state land, the facility faces substantial electrical demands, with monthly utility costs exceeding \$11,500. In response to these challenges, Hina Mauka has embarked on a Capital Improvement Project to repair and reinforce its aging roof and install solar panels. This initiative aims to enhance structural integrity, reduce operational costs, and transition to renewable energy sources, ultimately reducing the facility's carbon footprint.

Phase 2 of this Capital Improvement Project focuses on ensuring that the roof can sustain the 20year lifespan of the newly installed photovoltaic solar panels by repairing old roofing materials with durable, weather-resistant materials will be used to upgrade the roof, and waterproofing and sealing measures will be implemented to guard against environmental damage and leaks.

Goals:

1. Improve Infrastructure Resilience

- > Ensure structural integrity and durability to withstand environmental stresses.
- > Provide a reliable energy source during emergencies and power outages.
- Ensure roofing materials meet durability standards to withstand environmental factors over the 20-year solar panel lifespan.

2. Enhance Energy Efficiency and Sustainability

- > Transition to renewable energy sources to reduce carbon footprint.
- > Minimize energy consumption through modern roofing and solar technology.

> In alignment with Hawaii's Energy Information Administration mandate

3. Reduce Operational Costs

- > Lower energy bills through solar energy generation.
- > Minimize maintenance costs with modern, durable roofing systems.

4. Support Long-Term Financial Planning

- > Leverage rebates, and grants for renewable energy installations.
- Reduce monthly energy expenses, reallocating savings to patient care and facility improvements.

Expected Outcomes:

- > A structurally sound roof prepared to support solar panels.
- A reduction in energy costs, leading to financial savings that can be reinvested in patient services.
- > Lower carbon emissions, contributing to Hawaii's sustainability goals.
- Reliable energy availability to support Hina Mauka's 24/7 operations, including emergency scenarios.

By addressing critical roof repairs, Hina Mauka is positioning itself to seamlessly transition to solar energy. This project promises not only economic and environmental benefits but also reinforces the facility's commitment to sustainably while supporting Hawaii's vision for a clean energy future.

3. The public purpose and need to be served;

Hina Mauka, one of the state's largest substance abuse treatment facilities, provides comprehensive care to patients with multiple chronic conditions (MCC), including substance use disorders (such as alcohol, methamphetamine, and opioids), co-occurring mental health disorders (e.g., depression, anxiety, PTSD), and co-morbid physical conditions (e.g., heart disease, liver disease, diabetes, hypertension). Unfortunately, MCC patients face significant barriers to care, such as fragmented, uncoordinated, and underfunded services. Many of these individuals are homeless and experience severe medical and behavioral health challenges. According to the 2024 Homeless Point in Time Count, homelessness in Hawaii increased by 12% from 2023 to 2024, with 6,389 people experiencing homelessness statewide. Of these, 4,494 were on Oahu, and over half (62%) were unsheltered. Additionally, 26% of these individuals reported a substance use disorder, 33% reported a mental illness, 55% reported one or more disabling conditions, and 51% were Native Hawaiian or Other Pacific Islander.

The combination of untreated substance use disorders, co-occurring mental health issues, and physical health disorders among this population results in a high cost to the state—approximately \$82,000 per year per person. According to the Hawaii Health Department's January 2020 report, individuals experiencing homelessness and chronic homelessness are especially vulnerable to substance dependence issues. Hawaii has the third-highest per capita rate of homelessness in the nation, 2.7 times higher than the national average.

While opioid abuse is on the rise, alcohol and methamphetamine remain the most commonly abused substances among Hawaii's adults. The impact of homelessness and drug-related activity also negatively affects local businesses, with increased property damage and customer complaints due to rising concerns over street behavior (Star-Advertiser, 2019).

As a 24/7 inpatient treatment facility, Hina Mauka is heavily reliant on the current electrical grid, which results in significant energy costs—approximately \$11,500 per month. To reduce our carbon footprint, Hina Mauka plans to install solar panels capable of generating enough renewable energy to power the facility and contribute back to the electrical grid. This shift from reliance on fossil fuel-generated electricity to solar power will not only reduce our substantial energy costs but also benefit the Island of Oahu. The savings will be reinvested to enhance our integrated healthcare services, enabling us to better serve patients with substance use, mental health, and physical health issues, especially among the chronically homeless population. Evidence consistently shows that an integrated healthcare approach is the most effective and cost-efficient method of addressing these complex issues.

4. Describe the target population to be served; and

Located in Windward Oahu, we provided services to the entire State of Hawaii. Our primary population consists of low-income adults aged 18 and older who are affected by chronic drug and alcohol addiction, mental health disorders and disabling medical conditions. This vulnerable group includes individuals who are homeless, elderly, battered spouses, illiterate, disabled, and veterans facing mental health challenges. Among our patients, 81% are between the ages of 20 and 49. The ethnic breakdown of those we serve includes 50% Native Hawaiian/Pacific Islander, 21% Caucasian, and 11% Asian. Additionally, 61% of our patients meet the HUD definition of homelessness, and 79% report an annual income of less than \$10,000.

Hina Mauka provides residential services to residents statewide.

Hina Mauka will continue to work with the roofing and solar contractors to:

Hina Mauka will work closely with the state as well as contractors to ensure that all work meets regulatory codes and requirements of this grant. Hina Mauka's facility maintenance department will review all plans/proposals and review the work of the contractor to ensure compliance with the scope of services.

As a large treatment provider for low-income residents with over 50 years of experience, Hina Mauka has state licenses e.g. Special Treatment Facility (STF), national accreditation Commission of Accreditation of Rehabilitation Facilities (CARF), and about 25 contracts with the government to provide residential treatment services.

Residential operations began in 1995 when Hina Mauka successfully constructed the residential facility (24,000 sq. ft.) funded by State Grant-in-Aid Funds as well as numerous local foundations and businesses.

Hina Mauka has an extensive history in completing Capital Improvement Projects. Our most significant was completing our expansion capital improvement project called Pakui' Hale. The goal of this project was to add an additional 16 beds to our existing 48-bed facility. Kaneohe: 45-845 Po'okela Street, Kaneohe, Hawaii 96744

Hina Mauka's Kaneohe facility has the ability to provide residential services to 64 clients at any given time. This residential facility has adequate space for several outpatient groups and houses our administrative staff, kitchen, dining room, laundry room, and individual counseling rooms. The residential clients reside upstairs, which is accessible by stairs and elevator. On the ground floor, there are 5 large, enclosed group rooms, an expansive dining room that also serves for client groups, recovery meetings and staff trainings, 9 individual enclosed counseling rooms, a Treatment Associates' office that is open 24 hours a day, a physician's office, a nursing office, a physical examination room, a large, enclosed chart/documentation room, and a large enclosed clinical administrative office. Double closed doors provide privacy and separate the clinical area from the large open lobby where our receptionist and intake specialist's welcome guests, our patients, families, and those seeking program services.

The building meets all ADA regulations and has been further designed to accommodate persons with disabilities. The building is equipped with an elevator; wide doors; client rooms and offices that accommodate wheelchair access; accessible bathrooms and several handicap parking spaces. The facility is isolated, providing client confidentially, and is several blocks from the nearby Hawaii State Hospital, Kaneohe Court House, Windward Community College, Windward Mental Health and the Windward District Park. The facility is accessible by bus and there is a bus stop within 2 blocks of the facility.

Pursuant to our state licensing requirements, the Kaneohe building meets all federal, state and local regulations (e.g. building codes). The building was specifically designed for alcohol and other substance abuse rehabilitation, with the integrity of the confidential relationship and the personal dignity of the client of primary consideration. Hina Mauka modified the existing inhouse bathrooms according to recommendations from the US District Court representatives to

improve upon the integrity and accuracy of urine collections. The health and safety of employees, clients and the community is a priority and is monitored by the Office of Health Care Assurance annually.

To meet the growing needs of our community, Hina Mauka expanded its operations with the completion of the Annex building in 2008. The completion of the project has given Hina Mauka the capacity to provide comprehensive services that include peer mentoring, psychiatric services, family program services and case management. The Annex is equipped with a large conference room used for provider, family and board meetings, monitoring/audits, clinical group supervision, and education/process groups. It also provides office space for management and outpatient counselors. The second floor affords enough space to house all clinical medical records for 7 years. The Annex building meets all ADA regulations.

Security - Ingress and egress is maintained 24/7 using personnel, surveillance cameras and door locks armed with an alarm system. Adequate personnel are on hand and signs direct people to the front desk where visitors are required to sign in. Personnel are stationed in the main lobby to welcome visitors and ensure only authorized persons are allowed on the premises. Any movement from the upstairs residence to the first floor and any attempt to open external doors will be identified by the alarm. As an extra layer of security Hina Mauka has surveillance cameras throughout the perimeter and buildings.


