The initiative meets a public need/purpose to 1) provide mental wellness programming for youth across the state, 2) provide youth leadership programs and out-of-school time programs to keep youth safe and off the streets in the urban core, 3) support Title 1 nearby DOE schools through program collaborations, and 4) transform the aging Nu'uanu Y campus to better serve keiki, kupuna, and the community. This directly addresses urgent and prominent issues of loneliness and isolation voiced both by our community and documented in research conducted and reported in the 2023 Surgeon General's Advisory, "Our Epidemic of Loneliness and Isolation." A community gathering space is needed in these neighborhoods. The YMCA reduces barriers to access by providing financial assistance to those who can't afford to use the facilities and participate in programming.

II. Background and Summary

A brief description of the applicant's background;

The YMCA of Honolulu provides critical programs and services that enrich communities through its mission to build a healthy spirit, mind, and body for all. Guided by our core values of caring, honesty, respect, responsibility, and diversity, the Y is dedicated to giving people of all ages, backgrounds, and walks of life the opportunity to reach their full potential with dignity.

Founded in 1869, the YMCA of Honolulu (Y) was incorporated under the laws of the Kingdom of Hawai'i in 1882. We are an independent, local, tax-exempt 501(c)(3) organization that has grown to become one of the largest nonprofit organizations in Hawai'i. With our long history, the Y has provided programs and activities for generations. The Y has changed with the times, customs, and philosophies to meet the evolving needs of the community.

For more than 150 years, the Y has been a catalyst for positive change in our islands. The Y delivers programs and services at nine Y facilities and more than 100 other locations, many of them schools across Oʻahu, as well as programs on Kauaʻi, Molokaʻi, Lānaʻi, and Maui. The Y serves more than 50,000 people of all ages each year with a focus on healthy living, youth development, and social responsibility.

The following are examples of some of the Y's programs and services:

- 198 children ages 2 to 5 years attend Y Preschools (full and part-time), with plans to increase this number by securing additional community delivery locations.
- The YMCA College Camp has helped more than 600 underserved high school students realize that higher education is within their reach by providing a network of support and resources to apply for and succeed in college.
- Seasoned teen counselors and directors, along with mental health professionals, have developed programs to prevent mental health problems and identify and provide needed interventions to help struggling youth. Last year, preventive and intervention-level mental health programs helped over 1,605 elementary, middle, and high school students.
- As the island's largest provider of kūpuna programs, serving thousands through Medicare Advantage insurance programs or regular memberships, the Y provides nutrition, health, and wellness activities to keep kūpuna healthy.

2. The goals and objectives related to the request;

The goal of this request is to acquire funding to *complete the planning and design phase of the initiative*, which is a robust, multi-faceted, long-term plan to reimagine a community hub in downtown Honolulu.

The Y has an opportunity to address some of the state's most pressing issues, including housing, mental wellness, health disparities, and early childhood education. We have launched a comprehensive fundraising campaign that is focused on both capital and

program needs that will 1) help increase the number of early childhood education seats available to support working families, 2) provide mental wellness programming for youth across the state, and 3) transform the aging Nu'uanu Y campus to better serve keiki, kūpuna, and the greater community. The Y is requesting support for Phase 1 of the Nu'uanu Y initiative.

Of these three focus areas, the redevelopment of the Nu'uanu Y campus will significantly increase the number of people we serve, as well as those to be served through an affordable housing partner. Centrally located in the iconic gateway to downtown Honolulu, the Nu'uanu Y has served the community at its current location since 1963. Over 5,000 people annually visit the Nu'uanu Y, which provides health and wellness programs, youth and leadership programs, and kūpuna services.

Construction of a new 50,000 (usable) square-foot modern, multi-story building will allow the Y to maximize outdoor spaces and include areas that welcome youth, kūpuna, and community members to gather for fellowship and engagement and to foster their sense of belonging—one of the pillars in the social determinants of health. New technology-equipped multipurpose spaces will allow us to provide in-person and virtual classes and expand mental wellness programs onsite and in the community. Members will enjoy a rooftop multi-sport court, wellness, meeting and program spaces, and an outdoor pool. Plans for the lobby to be open to the community include a café, a community meeting space, and a healthcare facility onsite run by a partner organization.

One of the most impactful developments in the plan will be Phase 3: The construction of two residential towers providing a mix of 500 affordable and workforce housing units to address Honolulu's severe housing shortage. Data show that 25 percent of adults 65+ years are socially isolated, and 8.5 percent live below the poverty level. Housing on the Y campus will provide kūpuna with a safe place to live and access to programming that can contribute to their quality of life with better health outcomes. Within walking distance of our campus are high-quality healthcare, pharmacy, grocery, government services, and other important retail elements.

With its proximity to green space and educational institutions, plus all of the important services mentioned above, the Nu'uanu campus will become a hub for a thriving community in the downtown area.

For this funding request, the following objectives will be accomplished:

Objective 1: Complete concept design drawings

Objective 2: Complete schematic design drawings

Objective 3: Secure permits

The YMCA has initial concept designs and a viable budget that have allowed us to begin a campaign and achieve significant early support for the project. Outside of this grant, upon full completion, we will track increase in membership, access to affordable housing, engagement of members (as a indicator of social connectedness), and many other metrics to quantitatively show impact across multiple domains.

3. The public purpose and need to be served;

The public purpose is to provide an accessible hub for people to thrive while addressing the need for early childhood education, mental wellness support, and engagement opportunities. The initiative also paves the way for future affordable housing.

In 1917, five YMCA leaders made a bold decision to combine the separate Japanese, Chinese, Korean, and Filipino YMCA associations into a single, unified branch where everyone would be welcomed. The branch they founded was the Nu'uanu YMCA. At a time when racial segregation was prevalent in many parts of the U.S., this decision stood as a landmark achievement for racial integration and a powerful example for YMCAs nationwide. Those five leaders were Frank C. Atherton, Dr. Iga Mori, Dr. Wm. D. Westervelt, Dr. Singman Rhee, and Chung K. Ai. The culture of inclusiveness they envisioned remains a core value instilled in the current Nu'uanu Y, now located at the corner of Pali Hwy. and Vineyard Blvd.

In the fall of 2022, a feasibility study of community leaders revealed four initiatives that were of high priority for stakeholders. These are expanding early childhood education, supporting youth mental wellness, and rebuilding the Nu'uanu Y facility. Redevelopment of the Nu'uanu Y campus also presents an opportunity for the Y to build much-needed housing for working families, allowing the Y to maximize the usage of its 2.6-acre property. This exciting project promises to be transformational for the greater community and the Y.

- Reimagining the Nu'uanu Campus Constructed in 1963, the Nu'uanu Y building
 is showing its age. This presents a timely opportunity for the Nu'uanu Y to once
 again lead the way in transforming a community. Redeveloping the Nu'uanu
 campus will enable the Y to expand its programs and facilities to address some
 of the state's most pressing issues.
- Early Childhood Education About half of Hawai'i's keiki do not attend preschool. The state estimates that Hawai'i needs roughly 400 more classrooms to reach its goal of providing universal access to preschool by 2032. Researchers report that high-quality preschool education can be critical in preparing children for academic achievement and success in life. Last year, only 30% of kindergarteners entering Hawai'i public schools showed readiness in areas like physical development, social skills, literacy, and math. Our goal is to open 25 classrooms to do our part to narrow that gap, whether on Y campuses or in community locations.
- Youth Mental Wellness While teens often face challenges, today's youth struggle with mental health issues at higher rates than ever. The Office of the Surgeon General's 2023 Advisory on Social Media and Youth Mental Health reports that up to 95% of young people aged 13-17 report using a social media platform. It also states that youth who spend more than 3 hours a day on social media face double the risk of mental health problems, including symptoms of

- depression and anxiety.¹ In February 2024, the Hawai'i State Dept. of Education reported that more than 1/3 of public high school students reported feeling sad or hopeless almost every day for two or more weeks; some continue to struggle with suicide ideation.
- Housing for Working Families With more people living without shelter or struggling with high rents, housing on O'ahu continues to be a challenge.
 According to a 2019 State Department of Business, Economic Development & Tourism report, O'ahu needs about 5,200 additional affordable housing units for each of the next five years.

4. Describe the target population to be served; and

The YMCA strives to serve all, regardless of ability, economic status, race, or religion, and our demographic surveys support the fact that we are consistent in serving the needs of the community broadly.

5. Describe the geographic coverage.

The Nuuanu YMCA is located in the heart of downtown Honolulu. The urban neighborhood has a very high percentage of low-income people (justicemap.com, based on the 2020 census). In the 96813 zip code/census tract, 28% of people speak a language other than English, 20% of the population is 65 or older, and the median household income is more than \$10,000 less than the state level. The site is within walking distance of many amenities, including elementary and middle schools, a pharmacy, Kamamalu Neighborhood Park, healthcare, pharmacy, grocery, government offices, downtown office workers, and other important services.

Greg Waibel will be the Y's point person for the initiative. 2. **Facilities**

The YMCA owns the 2.6-acre site for the redevelopment of the Nu'uanu YMCA and the construction of two affordable housing towers. City-owned Kamamalu Neighborhood Park borders the YMCA property and is incorporated into the redevelopment plan. The Y will construct 114 parking stalls and a comfort station in Kamamalu Park for the City Department of Parks and Recreation, which will be available for both the Y and park users. This arrangement allows the YMCA to remain open while the new facility is built and provides for additional program offerings at the park.

Greg Waibel, president and CEO, oversees the project along with the Y Property Committee, composed of board members who bring their real estate development and construction expertise to the committee. Construction and building estimates have been provided by various sources and validated by a cost estimation firm experienced in development projects.

VI. Personnel: Project Organization and Staffing

1. Proposed Staffing, Staff Qualifications, Supervision and Training

Kerri Van Duyne is the Vice President of Development. Lisa Ontai is the Vice President of Marketing and Mission Advancement. Jennifer Townsend is Vice President of Youth Development. Leigh Ann Landreth is Vice President of Membership and Healthy Lifestyles. The executive leadership team will be actively involved in overseeing the project based on individual roles to ensure successful completion.

Gregory Waibel - President and CEO

Greg Waibel will oversee the entire project. He brings more than 28 years of executive for-profit and non-profit leadership experience, with 18 of those years in service at the YMCA. Since 2006, Mr. Waibel has served at the YMCA of the North (YMCAN). Headquartered in Minneapolis and serving the metro, southeastern, and northern areas of Minnesota and western Wisconsin, YMCAN is the third-largest YMCA in the USA.

Most recently, Mr. Waibel has served as YMCAN's Chief Operating Officer (COO) and, prior to that, as the organization's Chief Financial Officer and Chief Information Officer. As COO, Waibel was responsible for providing strategic direction and operational oversight for the YMCAN's 28 facility locations and program sites, eight overnight camps, ten day camps, and more than 90 childcare sites that engage nearly a quarter million men, women, and children of all ages, incomes, and backgrounds.

Mr. Waibel's major achievements have included helping to increase YMCAN's revenue growth from \$133 million to \$170 million, assisting in a \$175 million comprehensive campaign, multiple new partnerships with community, government, and healthcare agencies, opening three new YMCA locations, one non-profit merger and the addition of its eighth overnight camp site, and aggressive growth in youth, family, membership, and health and well-being programs.

Mr. Waibel has been a champion for the YMCA's continued efforts in advancing diversity and equity within the Y and throughout the region that has included leading the equity learning community, serving on the national YMCA of the USA LGBTQ network, acting as executive sponsor of the local LGBTQ, Hispanic Latino, and Asian Pacific Islander resource networks as well as serving on the board of the MN State Alliance of YMCAs.

Prior to YMCAN, Mr. Waibel served as Chief Financial Officer, Chief Information Officer, and Vice President of Operations for the YMCA of Greater Saint Paul (YGSP) predecessor organization to YMCA of the North, from 2006 through 2011. While at YGSP, Waibel was instrumental in restructuring YGSP's operations and investment management that led to a 36% increase in revenue growth, elevating the Y from \$36 million to \$49 million, and the successful 2012 merger between YGSP and YMCA of Metropolitan Minneapolis which ultimately resulted in the formation of YMCA of the North.

Mr. Waibel was named Minneapolis/St. Paul Business Journal's CFO of the Year in 2009 and 2013 in recognition of his work at the YMCA.

Belinda Johnson - Vice President of Finance

Belinda Johnson will oversee the financial portion of the project activities. She joined the YMCA of Honolulu in July 2022. Here at the Y Belinda is responsible for the financial and accounting activities of our Organization, including the accounting

component of the A+ Programs. Belinda graduated from the University of Auckland with a B.Com is also a Public Certified Accountant that has an MBA from New Zealand. Belinda has over 22 years of financial experience. Belinda has worked with large and small organizations in the for and not for profit areas such as the New Zealand Defence Force, New Zealand Ministry of Health and the New Zealand Ministry for Children to name only a few.

Kerri Van Duyne - Vice President of Development

Kerri Van Duyne will lead efforts to secure project funding. She oversees fundraising efforts, working with nine branches island-wide and 500+ volunteer campaigners. Annual Campaign brings in \$1,000,000+ annually from individuals (6,000+ donors) and \$900,000 in private grant funds for program support. She has been instrumental in completing a \$9 million capital campaign for Camp Erdman and Waianae YMCA in 2020. She has also conducted a comprehensive campaign for \$12+ million for Nuuanu YMCA, mental health programs, and preschool expansion. She seeks and establishes strategic partnerships and secures contract funding to support association-wide programs. In addition to this, she is responsible for government relations, including seeking government funding to support Y initiatives (\$10+ million secured to date).

Jen Townsend - Vice President of Youth Development

Jen Townsend will be involved in branch leadership for the project. She is also responsible for providing strategic leadership and oversight for the A+/Summer, Preschool, Teen, and Young Adult programs. She is also DHS-qualified and registered as the Preschool Director for two state-licensed, full-day YMCA Preschool sites.
