Aloha President Kouchi and Speaker Nakamura:

Agreements have been reached concerning the Hawai'i Government Employees Association's (HGEA) collective bargaining for Units 2 (Blue Collar Supervisors), 3 (White Collar Employees), 4 (White Collar Supervisors), 8 (Administrative, Profession, and Technical Employees of the University of Hawai'i (UH)), 9 (Registered Professional Nurses), 13 (Professional and Scientific Employees), and 14 (State Law Enforcement Officers) to resolve grievances relating to temporary hazard pay (THP) during the COVID-19 pandemic. Funding was provided by Act 49, SLH 2024. However, the requested amounts have been found to be insufficient, so additional funding is being requested. Additionally, arbitration awards (UH and State Executive) or agreements (Hawai'i Health Systems Corporation) have been reached or issued concerning the United Public Workers (UPW) class action grievances for Units 1 (Blue Collar Employees) and 10 (Institutional, Health, and Correctional Workers), and an agreement has been reached with the Hawai'i Firefighters Association for Unit 11 (Firefighters), relating to THP during the COVID-19 pandemic.

In accordance with Section 89-11, HRS, cost items must be submitted to the Legislature for appropriation. The amounts also include estimated funding for the UPW arbitration award still pending for the Department of Education.

The following is a summary of the included and excluded requirements of the settlement agreements and arbitration awards for the current fiscal biennium being transmitted to the Legislature for appropriation:

A BILL FOR AN ACT

RELATING TO PUBLIC EMPLOYMENT COST ITEMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 PART I

2 SECTION 1. This Act is recommended by the governor for
3 immediate passage in accordance with section 9 of article VII of
4 the Constitution of the State of Hawaii.

5 PART II

6 SECTION 2. There is appropriated or authorized from the
7 source of funding indicated below to collective bargaining
8 statewide (BUF 102) the following sum or so much thereof as may
9 be necessary to fund for fiscal biennium 2023-2025 all
10 collective bargaining cost items in the agreement negotiated
11 with the exclusive representative of collective bargaining units
12 (2), (3), (4), (8), (9), (10), (13), and (14) and their excluded
13 counterparts. These amounts are in addition to the amounts
14 provided in Act 49, Session Laws of Hawaii 2024:

1 SECTION 3. Funds appropriated or authorized by this part
2 shall be allotted by the director of finance to the appropriate
3 state departments for expenditure in the respective fiscal year
4 for the purposes of this part.

6 SECTION 4. There are appropriated or authorized from the
7 sources of funding indicated below to collective bargaining
8 statewide (BUF 102) the following sums or so much thereof as may
9 be necessary to fund for fiscal biennium 2023-2025 all
10 collective bargaining cost items in the agreement negotiated
11 with the exclusive representative of collective bargaining units
12 (1) and (10) and their excluded counterparts. These are for
13 separate arbitration awards for the department of education, the
14 University of Hawaii and other state departments:

1 SECTION 5. Funds appropriated or authorized by this part
2 shall be allotted by the director of finance to the appropriate
3 state departments for expenditure in the respective fiscal year
4 for the purposes of this part.

5 PART IV

6 SECTION 6. There is authorized from the source of funding
7 indicated below to Hawaii health systems corporation - corporate
8 office (HTH 210) the following sum or so much thereof as may be
9 necessary to fund for fiscal biennium 2023-2025 the collective
10 bargaining cost items in the agreement negotiated with the
11 exclusive representative of collective bargaining units (1) and
12 (10) who is assigned to the Hawaii health systems corporation:

14 General funds \$11,540,875

15 SECTION 7. Funds authorized by this part shall be allotted
16 by the director of finance to the Hawaii health systems
17 corporation for expenditure in the respective fiscal year for
18 the purposes of this part.

19 PART V

20 SECTION 8. There are appropriated or authorized from the
21 sources of funding indicated below to collective bargaining
22 statewide (BUF 102) the following sums or so much thereof as may

1 be necessary to fund for fiscal biennium 2023-2025 all
2 collective bargaining cost items in the agreement negotiated
3 with the exclusive representative of collective bargaining unit
4 (11) and their excluded counterparts:

8 SECTION 9. Funds appropriated or authorized by this part
9 shall be allotted by the director of finance to the appropriate
10 state departments for expenditure in the respective fiscal year
11 for the purposes of this part.

12 PART VI

13 SECTION 10. Salary increases and cost adjustments provided
14 in this Act for any officer or employee whose compensation is
15 paid, in whole or in part, from federal, special, or other funds
16 shall be paid wholly or proportionately, as the case may be,
17 from the respective funds, provided that if the respective funds
18 are unable to support such payments, appropriations from other
19 means of financing may be used with the approval of the
20 Governor.

1 SECTION 11. Funds appropriated or authorized by this Act
2 that are not expended or encumbered by June 30, 2026, shall
3 lapse as of that date.

4 SECTION 12. In accordance with section 9 of article VII of
5 the Constitution of the State of Hawaii and sections 37-91 and
6 37-93, Hawaii Revised Statutes, the legislature has determined
7 that at the beginning of the regular session of 2025, the
8 general fund expenditure ceiling for fiscal year 2024-2025 was
9 exceeded by \$8,551,795, or one per cent. The appropriations
10 contained in Act 1, Session Laws of Hawaii 2025, caused the
11 general fund expenditure ceiling for fiscal year 2024-2025 to be
12 further exceeded by an additional \$30,334,159. Therefore, the
13 general fund expenditure ceiling for fiscal year 2024-2025 has
14 already been exceeded by \$38,885,954, or one per cent.

15 The appropriations contained in this Act will cause the
16 general fund expenditure ceiling for fiscal year 2024-2025 to be
17 further exceeded by \$204,592,499, or three per cent. This
18 declaration takes into account the additional general fund
19 appropriations authorized for fiscal year 2024-2025 in this Act
20 only. The reasons for exceeding the general fund expenditure
21 ceiling are that the appropriations made in this Act are

1 necessary to serve the public interest and to meet the needs
2 addressed by this Act.

3 SECTION 13. This Act shall take effect upon its approval.

Provides appropriations for collective bargaining cost items for the members of Units (1), (2), (3), (4), (8), (9), (10), (11), (13), and (14) and their excluded counterparts, including the cost of salary adjustments negotiated between the State and the bargaining unit representative for fiscal biennium 2023-2025. Declares the expenditure ceiling for fiscal year 2024-2025 is exceeded. Effective upon approval. (CD1)
