# A BILL FOR AN ACT

MAKING EMERGENCY APPROPRIATIONS FOR PUBLIC EMPLOYMENT COST  
ITEMS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 PART I

2 SECTION 1. This Act is recommended by the governor for  
3 immediate passage in accordance with section 9 of article VII  
4 of the Constitution of the State of Hawaii.

5 PART II

6 SECTION 2. There are appropriated from the sources of  
7 funding indicated below to collective bargaining statewide (BUF  
8 102) the following sums or so much thereof as may be necessary  
9 to fund for fiscal biennium 2023-2025 all collective bargaining  
10 cost items in the agreement negotiated with the exclusive  
11 representative of collective bargaining units (1), (2), (3),  
12 (4), (8), (9), (10), (13), and (14) and their excluded  
13 counterparts. The amounts are for a negotiated settlement for  
14 the executive branch and the university of Hawaii, and an  
15 arbitration award for the department of education. These



1 amounts are in addition to the amounts provided in Act 49,  
2 Session Laws of Hawaii 2024:

1 SECTION 3. Funds appropriated by this part shall be  
2 allotted by the director of finance to the appropriate state  
3 departments for expenditure in the respective fiscal year for  
4 the purposes of this part.

5 PART III

6 SECTION 4. There are appropriated from the sources of  
7 funding indicated below to judiciary administration (JUD 601)  
8 the following sums or so much thereof as may be necessary to  
9 fund for fiscal year 2024-2025 all collective bargaining cost  
10 items in the agreement negotiated with the exclusive  
11 representative of collective bargaining units (1), (2), (3),  
12 (4), (8), (9), (10), and (13):

16 SECTION 5. Funds appropriated by this part shall be  
17 expended by the chief justice in the respective fiscal year for  
18 the purposes of this part.

19 PART IV

20 SECTION 6. There are appropriated from the source of  
21 funding indicated below to Hawaii health systems corporation -



1 corporate office (HTH 210) the following sums or so much  
 2 thereof as may be necessary to fund for fiscal year 2024-2025  
 3 the collective bargaining cost items in the agreement  
 4 negotiated with the exclusive representative of collective  
 5 bargaining units (1), (2), (3), (4), (8), (9), (10), and (13)  
 6 and their excluded counterparts:

10 SECTION 7. Funds appropriated by this part shall be  
 11 allotted by the director of finance to the Hawaii health  
 12 systems corporation for expenditure in the respective fiscal  
 13 year for the purposes of this part.

14 PART V

15 SECTION 8. Salary increases and cost adjustments provided  
 16 in this Act for any officer or employee whose compensation is  
 17 paid, in whole or in part, from federal, special, or other  
 18 funds shall be paid wholly or proportionately, as the case may  
 19 be, from the respective funds.

20 SECTION 9. Notwithstanding any provision of this Act,  
 21 with the approval of the governor, the director of finance may



1 transfer between parts II and IV of this Act the unrequired  
2 balances as may be available from the appropriated funds of  
3 parts II and IV of this Act as necessary.

4 SECTION 10. Funds appropriated or authorized by this Act  
5 that are not expended or encumbered by June 30, 2025, shall  
6 lapse as of that date.

7 SECTION 11. In accordance with section 9 of article VII  
8 of the Hawaii State Constitution and sections 37-91 and 37-93,  
9 Hawaii Revised Statutes, the legislature has determined that  
10 the appropriations from previous years have caused the state  
11 general fund expenditure ceiling for fiscal year 2024-2025 to be  
12 exceeded by \$ or per cent. In addition, the  
13 appropriation contained in this Act will cause the general fund  
14 expenditure ceiling for fiscal year 2024-2025 to be further  
15 exceeded by \$ or per cent. The reasons for  
16 exceeding the general fund expenditure ceiling are that:

- 17 (1) The appropriation made in this Act is necessary to  
18 serve the public interest; and
- 19 (2) The appropriation made in this Act meets the needs  
20 addressed by this Act.



**1** SECTION 12. This Act shall take effect on July 1, 3000.
