
A BILL FOR AN ACT

RELATING TO PUBLIC EMPLOYMENT COST ITEMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 PART I

2 SECTION 1. There are appropriated or authorized from the
3 sources of funding indicated below to collective bargaining
4 statewide (BUF 102) the following sums or so much thereof as may
5 be necessary to fund for fiscal biennium 2025-2027 all
6 collective bargaining cost items in the agreement negotiated
7 with the exclusive representative of collective bargaining unit
8 (11):

14 SECTION 2. Funds appropriated or authorized by this part
15 shall be allotted by the director of finance to the appropriate
16 state departments for expenditure in the respective fiscal year
17 for the purposes of this part.



PART II

SECTION 3. There are appropriated or authorized from the sources of funding indicated below to collective bargaining statewide (BUF 102) the following sums or so much thereof as may be necessary to fund for fiscal biennium 2025-2027 the salary increases and other cost adjustments authorized by chapter 89C, Hawaii Revised Statutes, for state officers and employees who are excluded from collective bargaining and belong to the same compensation plans as those officers and employees within bargaining unit (11):

SECTION 4. Funds appropriated or authorized by this part shall be allotted by the director of finance to the appropriate state departments for expenditure in the respective fiscal year for the purposes of this part.

1 SECTION 5. Salary increases and cost adjustments provided
2 in this Act for any officer or employee whose compensation is
3 paid, in whole or in part, from federal, special, or other funds
4 shall be paid wholly or proportionately, as the case may be,
5 from the respective funds.

6 SECTION 6. Funds appropriated or authorized by this Act
7 that are not expended or encumbered by June 30, 2026, and
8 June 30, 2027, of the respective fiscal years, shall lapse as of
9 those dates.

10 SECTION 7. In accordance with section 9 of article VII of
11 the Constitution of the State of Hawaii and sections 37-91 and
12 37-93, Hawaii Revised Statutes, the legislature has determined
13 that the state general fund expenditure ceiling for fiscal year
14 2025-2026 has already been exceeded by \$ or per
15 cent. In addition, the appropriations contained in this Act
16 will cause the state general fund expenditure ceiling for fiscal
17 year 2025-2026 to be further exceeded by \$, or one per
18 cent. The reasons for exceeding the general fund expenditure
19 ceiling are that the appropriations made in this Act are
20 necessary to serve the public interest and to meet the needs
21 addressed by this Act.



1 SECTION 8. This Act shall take effect on July 1, 2050.
