
A BILL FOR AN ACT

RELATING TO CAPITAL ADVANCEMENT CONTRACTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 266-19.5, Hawaii Revised Statutes, is
2 amended by amending subsection (d) to read as follows:
3 "(d) The department of transportation may execute capital
4 advancement contracts pursuant to subsection (a) with a total
5 contract value of [~~\$2,000,000~~] \$5,000,000 or less without
6 legislative approval. [~~If the total value of a capital
7 advancement contract pursuant to subsection (a) is greater than
8 \$2,000,000 then the department of transportation shall obtain
9 legislative approval in the form of the adoption of a concurrent
10 resolution affirming the purpose, project, and contract issuance
11 prior to executing the capital advancement contract.~~] The total
12 aggregate value of all capital advancement contracts entered
13 into by the department pursuant to this section shall not exceed
14 [~~\$5,000,000~~] \$20,000,000 in any [~~calendar~~] fiscal year. The
15 department shall submit a report to the legislature of all
16 executed capital advancement contracts for the previous twelve
17 month period from July 1 to June 30 no later than twenty days

1 prior to the convening of the regular session of 2026 and each
2 regular session thereafter."

DOT; Harbor Improvements; Capital Advancement Contracts

Description:

Amends section 266-19.5(d), HRS, for the purpose of increasing the cap for the contract value of any one capital advancement contract (CAC) and the cap for the total aggregate value of CACs in a fiscal year entered into by the Department of Transportation with private parties for harbor improvements. Adds reporting requirements for the department.

JUSTIFICATION SHEET

DEPARTMENT: Transportation

TITLE: A BILL FOR AN ACT RELATING TO CAPITAL ADVANCEMENT CONTRACTS.

PURPOSE: To increase the cap for the contract value of any one capital advancement contract (CAC) and the cap for the total aggregate value of CACs in a fiscal year entered by the Department of Transportation with private parties for harbor improvements and to add reporting requirements for the department.

MEANS: Amend section 266-19.5(d), Hawaii Revised Statutes (HRS).

JUSTIFICATION: Increasing the cap for the contract value of any one CAC from \$2,000,000 to \$5,000,000 and the cap for the total aggregate value from \$5,000,000 to \$20,000,000 of CACs in a fiscal year entered into by the department for harbor improvements will expedite certain projects at state commercial harbor facilities and increase project efficiencies when private parties lead such projects in a manner that minimizes project impacts on cargo operations. Additionally, increasing the maximum amounts of the CAC caps is necessary because the department anticipates escalating project costs due to inflation and rising costs of materials and labor. The higher limits will facilitate improved project delivery given these factors.

Impact on the public: The amendment will allow the department to expedite additional projects and prioritize public improvements to state commercial harbor facilities.
