
A BILL FOR AN ACT

RELATING TO AUTOMATED SPEED ENFORCEMENT SYSTEMS PROGRAM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. There is appropriated out of the state highway
2 fund of the State of Hawaii, the sum of \$5,000,000 or so much
3 thereof as may be necessary for fiscal year 2025-2026; to be
4 deposited into the automated speed enforcement systems program
5 special fund established by Act 112, Session Laws of Hawaii
6 2024.

7 The sum appropriated shall be expended by the department of
8 transportation for the purposes of this Act.

9 SECTION 2. There is appropriated out of the automated
10 speed enforcement systems program special fund the sum of
11 \$5,000,000 or so much thereof as may be necessary for fiscal
12 year 2025-2026 for the establishment and maintenance of the
13 automated speed enforcement systems program.

14 The sum appropriated shall be expended by the department of
15 transportation for the purposes of this Act.

16 SECTION 3. Any provision of this Act to the contrary
17 notwithstanding, the appropriation authorized under this Act
18 shall not lapse at the end of the fiscal year for which the

1 appropriation is made. Any unexpended and unencumbered balance
2 of the appropriation made in this Act as of the close of
3 business on June 30, 2029, shall lapse back to the credit of the
4 state highway fund.

5 SECTION 4. This Act, upon its approval, shall take effect
6 on July 1, 2025.

JUSTIFICATION SHEET

DEPARTMENT: Transportation

TITLE: A BILL FOR AN ACT RELATING TO AUTOMATED SPEED ENFORCEMENT SYSTEMS PROGRAM.

PURPOSE: To appropriate funds out of State Highway Fund and deposit into and expenditure of out the Automated Speed Enforcement Systems Program Special Fund for the fiscal year 2025-2026 for the establishment and maintenance of the Automated Speed Enforcement Systems Program.

MEANS: An appropriation out of the State Highway Fund for deposit into and expenditure out of the Automated Speed Enforcement Systems Program Special Fund.

JUSTIFICATION: This bill is necessary to fund the Automated Speed Enforcement Systems Program. Special Fund for the establishment and maintenance of the Automated Speed Enforcement Systems Program established by Act 112, Session Laws of Hawaii 2024.

Impact on the public: The program will reduce speed-related motor vehicle fatalities and injuries.

Impact on the department and other agencies: The program will further the Department of Transportation's objectives of promoting safer roads.

GENERAL FUND: None.

OTHER FUNDS: \$5,000,000 for fiscal year 2025-2026 out of the State Highway Fund for deposit into and expenditure out of the Automated Speed Enforcement Systems Program Special Fund.
