
A BILL FOR AN ACT

PROPOSING AMENDMENTS TO THE HAWAII CONSTITUTION TO PROMOTE
ACCOUNTABILITY IN ELECTED OFFICIALS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that accountability and
2 trust in public servants are essential to maintaining a healthy
3 democracy.

4 The purpose of this Act is promote accountability in state
5 elected officials by proposing to amend the Constitution of the
6 State of Hawaii to:

7 (1) Provide that any state elected official charged with a
8 criminal offense relating to the official's duties
9 shall be suspended without pay from serving in the
10 official's state elected office pending the final
11 adjudication of the charge;

12 (2) Provide that any elected official convicted of a
13 criminal offense relating to the official's duties
14 shall be permanently barred from holding any elected
15 or appointed office within the State, and shall

- 1 forfeit any pension, benefits, or privileges
2 associated with public office;
- 3 (3) Impose a term limit of ten consecutive years for
4 members of the state house of representatives;
- 5 (4) Impose a term limit of twelve consecutive years for
6 members of the state senate;
- 7 (5) Provide that service as governor or lieutenant
8 governor for longer than one half of one term shall be
9 considered service for one full term for the purpose
10 of term limits; and
- 11 (6) Provide that a state legislator, governor, or
12 lieutenant governor who has reached the applicable
13 consecutive term limit may run for election to the
14 same elected office after a four-year absence from the
15 office.

16 SECTION 2. Article XVI of the Constitution of the State of
17 Hawaii is amended by adding a new section to be appropriately
18 designated and to read as follows:

19 "Section . Any state elected official charged with a
20 criminal offense relating to the official's duties shall be



1 suspended without pay from serving in the official's state
2 elected office pending final adjudication of the charge.

3 Any state elected official convicted of a criminal offense
4 relating to the official's duties shall be permanently barred
5 from holding any elected or appointed office within the State,
6 and shall forfeit any pension, benefits, or privileges
7 associated with public office."

8 SECTION 3. Article III, section 4, of the Constitution of
9 the State of Hawaii is amended to read as follows:

10 **"ELECTION OF MEMBERS; TERM**

11 **Section 4.** Each member of the legislature shall be elected
12 at an election. If more than one candidate has been nominated
13 for election to a seat in the legislature, the member occupying
14 that seat shall be elected at a general election. If a
15 candidate nominated for a seat at a primary election is
16 unopposed for that seat at the general election, the candidate
17 shall be deemed elected at the primary election. The term of
18 office of a member of the house of representatives shall be two
19 years [~~and the~~]; provided that for terms beginning on or after
20 the general election of 2026, no person shall serve as a member
21 of the house of representatives for more than ten consecutive



1 years; provided further that a person who has reached this limit
2 may seek election to the house of representatives after a
3 four-year absence from membership in the house of
4 representatives. The term of office of a member of the senate
5 shall be four years[-]; provided that for terms beginning on or
6 after the general election of 2026, no person shall serve as a
7 member of the senate for more than twelve consecutive years;
8 provided further that a person who has reached this limit may
9 seek election to the senate after a four-year absence from
10 membership in the senate. The term of a member of the
11 legislature shall begin on the day of the general election at
12 which elected or if elected at a primary election, on the day of
13 the general election immediately following the primary election
14 at which elected. For a member of the house of representatives,
15 the term shall end on the day of the general election
16 immediately following the day the member's term commences. For
17 a member of the senate, the term shall end on the day of the
18 second general election immediately following the day the
19 member's term commences."

20 SECTION 4. Article V, section 1, of the Constitution of
21 the State of Hawaii is amended to read as follows:



1 "ESTABLISHMENT OF THE EXECUTIVE

2 **Section 1.** The executive power of the State shall be
3 vested in a governor. The governor shall be elected by the
4 qualified voters of this State at a general election. The
5 person receiving the highest number of votes shall be the
6 governor. In case of a tie vote, the selection of the governor
7 shall be determined as provided by law.

8 The term of office of the governor shall begin at noon on
9 the first Monday in December next following the governor's
10 election and end at noon on the first Monday in December, four
11 years thereafter.

12 No person shall [~~be elected to~~] serve in the office of
13 governor for more than two consecutive full terms. After the
14 general election of 2026, service in the office for longer than
15 one half of one term shall be considered service for one full
16 term. A person who has reached the term limit in this section
17 may seek election to the office of the governor after a
18 four-year absence from the office of the governor.

19 No person shall be eligible for the office of governor
20 unless the person shall be a qualified voter, have attained the



1 age of thirty years and have been a resident of this State for
2 five years immediately preceding the person's election.

3 The governor shall not hold any other office or employment
4 of profit under the State or the United States during the
5 governor's term of office."

6 SECTION 5. Article V, section 2, of the Constitution of
7 the State of Hawaii is amended to read as follows:

8 **"LIEUTENANT GOVERNOR**

9 **Section 2.** There shall be a lieutenant governor who shall
10 have the same qualifications as the governor. The lieutenant
11 governor shall be elected at the same time, for the same term
12 and in the same manner as the governor; provided that the votes
13 cast in the general election for the nominee for governor shall
14 be deemed cast for the nominee for lieutenant governor of the
15 same political party. No person shall [~~be elected to~~] serve in
16 the office of lieutenant governor for more than two consecutive
17 full terms. After the general election of 2026, service in the
18 office for longer than one half of one term shall be considered
19 service for one full term. A person who has reached the term
20 limit in this section may seek election to the office of the
21 lieutenant governor after a four-year absence from the office of



1 the lieutenant governor. The lieutenant governor shall perform
2 such duties as may be provided by law."

3 SECTION 6. The question to be printed on the ballot shall
4 be as follows:

5 "Shall the Constitution of the State of Hawaii be amended
6 to:

7 (1) Provide that any state elected official charged with a
8 criminal offense relating to the official's duties
9 shall be suspended without pay from serving in the
10 official's state elected office pending the final
11 adjudication of the charge;

12 (2) Provide that any elected official convicted of a
13 criminal offense relating to the official's duties
14 shall be permanently barred from holding any elected
15 or appointed office within the State of Hawaii, and
16 shall forfeit any pension, benefits, or privileges
17 associated with public office;

18 (3) Impose a term limit of ten consecutive years for
19 members of the state house of representatives;

20 (4) Impose a term limit of twelve consecutive years for
21 members of the state senate;

1 (5) Provide that service as governor or lieutenant
2 governor for longer than one half of one term shall be
3 considered service for one full term for the purpose
4 of term limits; and

5 (6) Provide that a state legislator, governor, or
6 lieutenant governor who has reached the applicable
7 consecutive term limit may run for election to the
8 same elected office after a four-year absence from the
9 office.

10 SECTION 7. Constitutional material to be repealed is
11 bracketed and stricken. New constitutional material is
12 underscored.

13 SECTION 8. This amendment shall take effect upon
14 compliance with article XVII, section 3, of the Constitution of
15 the State of Hawaii.
