# A BILL FOR AN ACT

RELATING TO HOMELESS YOUTH.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. Act 130, Session Laws of Hawaii 2022,  
2 established a safe spaces for youth pilot program within the  
3 department of human services. Act 130 will be repealed on June  
4 30, 2025. The office of youth services has worked on planning  
5 and developing the safe spaces for youth pilot program and, with  
6 appropriations, recommends the pilot program become permanent,  
7 and is ready to open the first state-funded shelter for young  
8 adults on the island of Hawaii.

9           The purpose of this Act is to make the safe spaces for  
10 youth pilot program a permanent program within the office of  
11 youth services.

12           SECTION 2. Chapter 352D, Hawaii Revised Statutes, is  
13 amended by adding a new section to be appropriately designated  
14 and to read as follows:

15           "§352D- Safe spaces. (a) There is established within  
16 the office of youth services a safe spaces for youth program,  
17 which shall provide, subject to the availability of funds, safe



1 spaces in each county for youth and young adults experiencing or  
2 at risk for homelessness.

3 (b) The program shall collaborate with all departments of  
4 the State and its political subdivisions that offer services for  
5 the purpose of ensuring the well-being of youth and young adults  
6 in Hawaii, including the department of education, the department  
7 of corrections and rehabilitation, the department of health,  
8 department of human services, the department of land and natural  
9 resources, the department of law enforcement, the state office  
10 on homelessness and housing solutions, the county police  
11 departments and other agencies, and the judiciary, to coordinate  
12 the identification of youth and young adults who are  
13 experiencing homelessness, and placement of these youth and  
14 young adults at a shelter for homeless youth or young adults.

15 (c) The office of youth services may enter into contracts  
16 with nonprofit organizations to provide services for youth or  
17 young adults experiencing homelessness or who are at risk of  
18 homelessness. Any nonprofit organization contracted under this  
19 subsection shall have the knowledge, experience, and  
20 qualifications, including licenses as needed for child caring  
21 institutions, and other requirements to operate a shelter for



1 youth or young adults at risk of homelessness or who are  
2 experiencing homelessness. Youth under the age of eighteen  
3 shall not be sheltered with young adults eighteen to twenty-  
4 four.

5 (d) Notwithstanding any other law to the contrary, a  
6 shelter for homeless youth contracted under subsection (c) may  
7 admit a youth into the shelter's care for up to ninety days  
8 without the consent of the youth's parent or guardian.

9 (e) The office shall submit a report pertaining to the  
10 safe spaces for youth program to the legislature no later than  
11 twenty days prior to the convening of each regular session.

12 (f) The office may adopt rules pursuant to chapter 91  
13 necessary to carry out the purposes of this section.

14 (g) For the purposes of this section:

15 "Shelter for homeless youth" means a facility that operates  
16 to receive youth or young adults twenty-four hours a day, seven  
17 days a week, and provide youth or young adults with services,  
18 including:

19 (1) Overnight lodging and supervision;

20 (2) Hot meals and hot showers;

21 (3) Access to medical and behavioral health services; and



1        (4) Education and employment support."

2        SECTION 3. New statutory material is underscored.

3        SECTION 4. This Act shall take effect upon its approval.



**Report Title:**

OYS; Safe Spaces for Youth Program; Homeless Youth and Young Adults; Shelter; Reports

**Description:**

Makes the Safe Spaces for Youth Pilot Program permanent within the Office of Youth Services. Requires the program to collaborate with all state and county departments that offer services for youth and young adults to coordinate the identification of youth and young adults who are experiencing homelessness and placement of these youth at a shelter for homeless youth or young adults. Authorizes the Office of Youth Services to contract with nonprofit organizations to provide shelters for homeless youth or young adults. Requires annual reports to the Legislature. (SD1)
