
HOUSE CONCURRENT RESOLUTION

REQUESTING THE DEPARTMENT OF TRANSPORTATION SERVICES OF THE CITY AND COUNTY OF HONOLULU TO IMPLEMENT A RESTRICTED PARKING ZONE PILOT PROGRAM IN THE KO 'OLINA, HONOKAI HALE, NĀNĀKULI, AND MAILI NEIGHBORHOODS.

1 WHEREAS, a restricted parking zone manages the use of
2 public on-street non-metered parking spaces through permits and
3 signage; and
4

5 WHEREAS, restricted parking zones can be used in
6 residential areas where there is also significant demand for on-
7 street parking from non-residents because of an identifiable
8 traffic generator, such as a nearby college or hospital; and
9

10 WHEREAS, a restricted parking zone can increase parking
11 access for area residents and visitors, as well as pedestrian
12 safety and the local use of transit; and
13

14 WHEREAS, restricted parking zones can also reduce traffic
15 congestion, air and noise pollution, commuter parking in
16 neighborhoods, and blight; and

18 WHEREAS, in 2017, the Department of Transportation Services
19 of the City and County of Honolulu identified Kalihi Valley as
20 the initial site for a Restricted Parking Zone Pilot Program;
21 and

23 WHEREAS, during the Kalihi Valley Restricted Parking Zone
24 Pilot Program, the Department of Transportation Services
25 observes that there was an eighty-six percent decrease in non-
26 residential on-street parking, and seventy percent increase in
27 available on-street parking spaces; and

1 WHEREAS, Ordinance 23-37 established a process for
 2 designating other neighborhoods as restricted parking zones; and
 3

4 WHEREAS, the Ko ‘Olina, Honokai Hale, Nānākuli, and Maili
 5 neighborhoods experience many similar issues that Kalihi Valley
 6 experienced before the implementation of the Kalihi Valley
 7 Restricted Parking Zone Pilot Program, including trash on the
 8 streets and sidewalks, frequent encounters with people sleeping
 9 in cars, loitering and nighttime disturbances, abandoned
 10 vehicles on the street, and difficulty finding parking; now,
 11 therefore,
 12

13 BE IT RESOLVED by the House of Representatives of the
 14 Thirty-third Legislature of the State of Hawaii, Regular Session
 15 of 2025, the Senate concurring, that the Department of
 16 Transportation Services of the City and County of Honolulu is
 17 requested to implement a Restricted Parking Zone Pilot Program
 18 in the Ko ‘Olina, Honokai Hale, Nānākuli, and Maili
 19 neighborhoods; and

21 BE IT FURTHER RESOLVED that certified copies of this
 22 Concurrent Resolution be transmitted to the Mayor of the City
 23 and County of Honolulu, Director of the Department of
 24 Transportation Services of the City and County of Honolulu, and
 25 member of the Honolulu City Council representing District 1.
