
HOUSE CONCURRENT RESOLUTION

REQUESTING THE DEPARTMENT OF TRANSPORTATION, DEPARTMENT OF
EDUCATION, AND DEPARTMENT OF TRANSPORTATION OF THE COUNTY
OF MAUI TO COLLABORATE TO PROPOSE VIABLE SOLUTIONS TO
IMPROVE PEDESTRIAN AND TRAFFIC SAFETY AND RELIEVE TRAFFIC
CONGESTION AROUND HAIKU ELEMENTARY SCHOOL.

1 WHEREAS, Haiku Elementary School is a public educational
2 institution providing pre-kindergarten through grade five
3 curriculum, serving a significant number of students and
4 families on Maui's north coast; and

5
6 WHEREAS, traffic congestion around Haiku Elementary School,
7 particularly during school drop-off and pick-up times, has
8 become a growing concern, impacting the safety of students and
9 efficiency of traffic flow in the area; and

11 WHEREAS, pedestrian and vehicle safety concerns, including
12 the need for safer crosswalks, better signage, improved routing,
13 and more efficient traffic management, have been raised by
14 parents, teachers, and community members; and

15
16 WHEREAS, the Department of Transportation, Department of
17 Education, and Department of Transportation of the County of
18 Maui are key stakeholders with the expertise to address these
19 issues; and

21 WHEREAS, collaborative efforts between these departments
22 are necessary to develop comprehensive solutions that will
23 improve traffic safety and reduce congestion around Haiku
24 Elementary School; now, therefore,

26 BE IT RESOLVED by the House of Representatives of the
27 Thirty-third Legislature of the State of Hawaii, Regular Session
28 of 2025, the Senate concurring, that the Department of



1 Transportation, Department of Education, and Department of
2 Transportation of the County of Maui are requested to
3 collaborate to propose viable solutions to improve pedestrian
4 and traffic safety and relieve traffic congestion around Haiku
5 Elementary School; and

7 BE IT FURTHER RESOLVED that the Department of
8 Transportation, Department of Education, and Department of
9 Transportation of the County of Maui are requested to:

- 11 (1) Assess the current traffic patterns and identify areas
12 for improvement;
 - 13
 - 14 (2) Explore infrastructure changes such as additional
15 signage, signals, and pedestrian crossings;
 - 16
 - 17 (3) Develop plans to better manage vehicle and pedestrian
18 flow during school drop-off and pick-up times;
 - 19
 - 20 (4) Review potential modifications to bus routes, road and
21 curb space, and school parking areas to alleviate
22 congestion; and

 - 24 (5) Consult with community members, including parents,
25 school officials, and residents, to incorporate their
26 feedback into the proposed solutions; and

28 BE IT FURTHER RESOLVED that the Department of
29 Transportation, in consultation with the Department of Education
30 and Department of Transportation of the County of Maui, is
31 requested to submit a report of its findings and
32 recommendations, including any proposed legislation, to the
33 Legislature no later than thirty days prior to the convening of
34 the Regular Session of 2026; and

36 BE IT FURTHER RESOLVED that certified copies of this
37 Concurrent Resolution be transmitted to the Director of
38 Transportation, Chairperson of the Board of Education,
39 Superintendent of Education, and Director of Transportation of
40 the County of Maui.
