# HOUSE CONCURRENT RESOLUTION

URGING KAMEHAMEHA SCHOOLS / BISHOP ESTATE TO PRIORITIZE  
COMMUNICATION AND TRANSPARENCY WITH THE HAWAII KAI  
COMMUNITY AMID LEASE EXPIRATIONS OF PROMINENT NEIGHBORHOOD  
ASSETS AND MAINTAIN THE STATUS QUO IN FUTURE LAND USE  
DECISIONS.

1           WHEREAS, Kamehameha Schools / Bishop Estate (KSBE) is the  
2 largest landowner in Hawaii Kai; and

3  
4           WHEREAS, Hawaii Kai was designed by Henry Kaiser as a  
5 community with intentionally planned infrastructure, recreation,  
6 and residences, including approximately eighty acres set aside  
7 for farmers under lease from KSBE; and

8  
9           WHEREAS, numerous leases for properties owned by KSBE are  
10 soon set to expire, with the future of multiple beloved  
11 community assets now uncertain; and

12  
13           WHEREAS, in July 2025, KSBE's farm leases in Kamilonui  
14 Valley will expire, affecting multiple long-standing community  
15 farmers who are in their seventies, make a modest income, and  
16 have recently been burdened by a \$10,000 fine passed on to them  
17 from KSBE who was fined by the Environmental Protection Agency  
18 regarding cesspool conversions, further worsening their  
19 financial situation; and

20  
21           WHEREAS, in 2028 the leases for land in Hahaione Valley  
22 currently home to properties including the Japan-America  
23 Institute of Management Science (JAIMS) are set to expire,  
24 causing concern for what might become of this area and the view  
25 plane of the residents in nearby condominiums; and

26  
27           WHEREAS, the Hawaii Kai community and elected  
28 representatives have made efforts to foster an open dialogue

1 with KSBE to ensure community sentiment is taken into account in  
2 their planning processes and that those interested in the future  
3 of these properties can stay informed; and  
4

5 WHEREAS, by and large, KSBE has rejected opportunities for  
6 community discussion, and the vast majority of residents feel an  
7 extreme lack of transparency and openness from KSBE's  
8 representatives for what is to come; and  
9

10 WHEREAS, the Hawaii Kai community is very invested in the  
11 future of these properties and others with impending KSBE lease  
12 expirations and is due a clear line of communication as it comes  
13 to what is to occur in their own backyard; now, therefore,  
14

15 BE IT RESOLVED by the House of Representatives of the  
16 Thirty-third Legislature of the State of Hawaii, Regular Session  
17 of 2025, the Senate concurring, Kamehameha Schools / Bishop  
18 Estate is urged to provide regular, informative, and timely  
19 updates to the Hawaii Kai community regarding properties with  
20 expiring leases and plans for future use and possible  
21 development; and  
22

23 BE IT FURTHER RESOLVED Kamehameha Schools / Bishop Estate  
24 is encouraged to maintain the status quo in future land use  
25 decisions, minimizing impacts to the surrounding community and  
26 limiting disruptions to how the present assets are currently  
27 utilized; and  
28

29 BE IT FURTHER RESOLVED that certified copies of this  
30 Concurrent Resolution be transmitted to Kamehameha Schools /  
31 Bishop Estate's Chief Executive Officer, Senior Asset Manager,  
32 Land Asset Manager, and Board of Trustees; Chair of the Hawaii  
33 Kai Neighborhood Board; President of the Japan-America Institute  
34 of Management Science; Manager of The Oahu Club; and Kamilonui  
35 Valley Farmers Association.
