
HOUSE CONCURRENT RESOLUTION

REQUESTING THAT THE HAWAII STATE OFFICE OF ELECTIONS CONVENE A
WORKING GROUP ON AUTOMATIC VOTER REGISTRATION.

1 WHEREAS, the legislature finds that every eligible person
2 should be able to register to vote in a convenient and secure
3 way that is beneficial to new voters and administrators alike;
4 and

6 WHEREAS, key voter registration improvements can ensure
7 state election systems are secure and efficient, safeguard
8 votes, and save money; and

9
10 WHEREAS, in the 2024 primary election, for example, our
11 state experienced its lowest turnout in 65 years, with only 32.1
12 percent of registered voters filling out a ballot; and

13
14 WHEREAS, to improve statewide voter turnout, we must enact
15 measures that strengthen the right to vote; and

16
17 WHEREAS, in 2021, Hawaii established automatic voter
18 registration to increase the State's historically low voter
19 participation rates; and

20
21 WHEREAS, the automatic voter registration system
22 established by the legislature was an opt-in system that places
23 the responsibility for registration on the part of individual
24 voters, which fails to fully include the total potential
25 population of new voters; and

27 WHEREAS, changing the state's automatic voter registration
28 system from an opt-in to an opt-out model would maximize
29 democratic participation by making voter registration as
30 streamlined as possible; now, therefore,

1 BE IT RESOLVED by the House of Representatives of the
 2 Thirty-third Legislature of the State of Hawaii, Regular Session
 3 of 2025, the Senate concurring, that the Hawaii State Office of
 4 Elections is requested to convene a working group on automatic
 5 voter registration; and

 7 BE IT FURTHER RESOLVED that the working group is requested
 8 to consist of the following members:

- 10 (1) The Chief Election Officer for the Hawaii State Office
 11 of Elections or the Chief Election Officer's designee,
 12 who is requested to serve as the working group's
 13 Chairperson;

 - 15 (2) The Director of the Honolulu Department of Customer
 16 Services or the director's designee;

 - 18 (3) A representative from Common Cause Hawaii;
 - 19
 - 20 (4) A representative from the League of Women Voters;
 - 21
 - 22 (5) A representative from the Institute for Responsive
 23 Government; and

25 BE IT FURTHER RESOLVED that the task force is requested to
 26 submit a report of its findings and recommendations, including
 27 any proposed legislation, to the Legislature no later than
 28 twenty days prior to the convening of the Regular Session of
 29 2026; and

 31 BE IT FURTHER RESOLVED that certified copies of this
 32 Resolution be transmitted to the Chief Elections Officer for the
 33 Hawaii State Office of Elections and the Director of the
 34 Honolulu Department of Customer Services.
