
HOUSE CONCURRENT RESOLUTION

CONDEMNING THE IMPACT OF FEDERAL BUDGET CUTS ON HAWAI'I'S
PROGRAMS AND SERVICES.

1 WHEREAS, the Trump administration, in collaboration with
2 Congress, is implementing significant federal budget cuts,
3 leading to widespread layoffs and funding reductions across
4 various federal agencies; and

5
6 WHEREAS, these cuts have resulted in the termination of
7 approximately two thousand two hundred federal positions in
8 Hawai'i, excluding potential additional losses at the University
9 of Hawai'i, thereby exacerbating unemployment and economic
10 instability within the State; and

11
12 WHEREAS, the University of Hawai'i Economic Research
13 Organization has projected that these federal budget cuts,
14 coupled with proposed tariffs, could place Hawai'i at risk of a
15 recession in the coming years; and

16
17 WHEREAS, the Department of Government Efficiency, under the
18 guidance of Elon Musk, has initiated extensive layoffs within
19 federal agencies, including the United States Fish and Wildlife
20 Service, leading to the termination of approximately 5 percent
21 of its workforce; and

22
23 WHEREAS, these layoffs have adversely affected critical
24 conservation efforts in Hawai'i, notably within the Kaua'i
25 National Wildlife Refuge Complex, resulting in the loss of
26 essential personnel responsible for protecting endangered
27 species and maintaining vital habitats; and

28
29 WHEREAS, the administration's attempt to temporarily freeze
30 federal grants and loans, pending a review for compliance with



1 new executive orders, has created uncertainty and potential
2 disruptions in funding for essential state programs and
3 services, including education, healthcare, social services, and
4 wildfire recovery efforts; and

5
6 WHEREAS, the House of Representatives has endorsed a
7 federal budget resolution proposing \$880 billion in Medicaid
8 cuts over the next decade, which could significantly reduce
9 healthcare access for over four hundred twenty thousand Hawai'i
10 residents who rely on Medicaid and the Children's Health
11 Insurance Program; and

12
13 WHEREAS, Medicaid cuts would place an increased financial
14 strain on Hawai'i's hospitals and healthcare providers,
15 particularly in rural and neighbor island communities where
16 Medicaid patients represent a significant portion of those
17 served, potentially leading to hospital closures or service
18 reductions; and

19
20 WHEREAS, reductions in Medicaid funding would impact makule
21 (seniors) and individuals with disabilities who rely on long-
22 term care services, as well as Native Hawaiian and Pacific
23 Islander communities who already face significant health
24 disparities; and

25
26 WHEREAS, proposed congressional cuts to the Supplemental
27 Nutrition Assistance Program (SNAP) threaten to reduce benefits
28 by at least twenty percent, putting over six hundred thousand
29 Hawai'i residents, including seventy thousand children and
30 thousands of makule, at increased risk of food insecurity; and

32 WHEREAS, the high cost of living in Hawai'i already puts
33 families on the brink of economic hardship, and cuts to SNAP
34 would disproportionately harm working families, Native Hawaiian
35 and Pacific Islander households, and rural communities where
36 access to affordable food is already limited; and

37
38 WHEREAS, food banks and community service organizations in
39 Hawai'i, which are already struggling to meet demand, would face
40 overwhelming pressure to fill the gap left by federal cuts,
41 leading to increased hunger and hardship across the State; and

1 WHEREAS, the cumulative effect of these federal actions
 2 threatens the economic stability, environmental conservation
 3 efforts, and the overall quality of life for the people of
 4 Hawai'i; now, therefore,

5
 6 BE IT RESOLVED by the House of Representatives of the
 7 Thirty-third Legislature of the State of Hawaii, Regular Session
 8 of 2025, the Senate concurring, that this body condemns the
 9 recent federal budget cuts and policy decisions that have
 10 adversely affected Hawai'i's programs and services; and
 11

12 BE IT FURTHER RESOLVED that the federal administration and
 13 United States Congress are urged to reconsider these budgetary
 14 and policy decisions, taking into account their detrimental
 15 impact on the State of Hawai'i and its residents; and
 16

17 BE IT FURTHER RESOLVED that the Governor is urged to
 18 explore and implement measures to mitigate the adverse effects
 19 of these federal actions, ensuring the continuity and stability
 20 of essential programs and services for the people of Hawai'i; and
 21

22 BE IT FURTHER RESOLVED that certified copies of this
 23 Concurrent Resolution be transmitted to the President of the
 24 United States, Administrator of the United States Department of
 25 Government Efficiency, Majority Leader of the United States
 26 Senate, Speaker of the United States House of Representatives
 27 members of Hawaii's congressional delegation, and Governor.
