
HOUSE RESOLUTION

REQUESTING THE DEPARTMENT OF LAND AND NATURAL RESOURCES TO
ESTABLISH A COLLABORATIVE WORKING GROUP TO SURVEY,
IDENTIFY, AND MONITOR CULTURALLY SENSITIVE SHORELINES
IMPACTED BY EROSION.

1 WHEREAS, the State recognizes the cultural and historical
2 significance of Native Hawaiian burial sites and the need to
3 protect these sacred places; and
4

5 WHEREAS, Native Hawaiian iwi kūpuna were historically
6 interred along sandy shoreline areas, which are now increasingly
7 threatened by coastal erosion; and
8

9 WHEREAS, multiple culturally sensitive shoreline areas
10 across the State, including Lahilahi Beach Park in Wai‘anae,
11 Kaulahao Beach in Hamakuapoko, and the Old Kona Airport Beach
12 Park in Kailua-Kona, have experienced ongoing coastal erosion,
13 resulting in the continuous exposure of iwi kūpuna; and
14

15 WHEREAS, pursuant to section 13-300-2, Hawaii
16 Administrative Rules, iwi exposed due to erosion are classified
17 as inadvertent discoveries; and
18

19 WHEREAS, the appropriate Island Burial Council is the
20 designated entity responsible for the disposition of
21 inadvertently discovered iwi kūpuna; and
22

23 WHEREAS, iwi discovered through shoreline erosion are
24 frequently located within the high-water mark, making it
25 difficult to preserve them in place; and

27 WHEREAS, iwi found in shoreline areas also fall within the
28 jurisdiction of the State, complicating quick reinterment
29 efforts within the immediate vicinity due to the need for
30 permission from adjacent property owners; and

1 WHEREAS, legislation has been introduced to address the
2 discovery of iwi kūpuna exposed along Hawaii's shorelines due to
3 coastal erosion; and
4

5 WHEREAS, the establishment of an inter-division program to
6 coordinate efforts among state and county agencies is necessary
7 to ensure the successful coordination of efforts in locating,
8 protecting, and restoring Native Hawaiian burial sites and iwi
9 kūpuna affected by coastal erosion; now, therefore,
10

11 BE IT RESOLVED by the House of Representatives of the
12 Thirty-third Legislature of the State of Hawaii, Regular Session
13 of 2025, that the Department of Land and Natural Resources is
14 requested to establish a collaborative working group to survey,
15 identify, and monitor culturally sensitive shorelines impacted
16 by erosion; and
17

18 BE IT FURTHER RESOLVED that the collaborative working group
19 is requested to include the following members:
20

- 21 (1) Chairperson of the Board of Land and Natural
22 Resources, or the Chairperson's designee;
23
- 24 (2) Chairperson of the Board of Trustees of the Office of
25 Hawaiian Affairs, or the Chairperson's designee;
26
- 27 (3) Administrator of the Department of Land and Natural
28 Resources' State Historic Preservation Division, or
29 the Administrator's designee;
30
- 31 (4) A representative from the Department of Land and
32 Natural Resources' Office of Conservation and Coastal
33 Lands;

- 35 (5) A representative of the Island Burial Councils, to be
36 selected by the Chairperson of the Board of Land and
37 Natural Resources;

- 39 (6) A representative from the City and County of Honolulu,
40 to be selected by the Mayor;

- 1 (7) A representative of the County of Hawaii, to be
- 2 selected by the Mayor;

- 4 (8) A representative of the County of Maui, to be selected
- 5 by the Mayor; and

- 7 (9) A representative of the County of Kauai, to be
- 8 selected by the Mayor; and

10 BE IT FURTHER RESOLVED that the collaborative working group
 11 is requested to determine a process to address iwi kūpuna
 12 exposed along shorelines, ensuring their protection from adverse
 13 impact; and

14
 15 BE IT FURTHER RESOLVED that the collaborative working group
 16 is requested to assess public lands near culturally sensitive
 17 areas where iwi kūpuna were exposed along shorelines to determine
 18 locations that may be designated as suitable reinterment sites;
 19 and

 21 BE IT FURTHER RESOLVED that the Department of Land and
 22 Natural Resources is requested to consider the appropriate
 23 methods of funding to support the collaborative working group,
 24 including for the construction of secure and culturally
 25 appropriate reinterment vaults in areas designated by the
 26 collaborative working group to ensure the respectful and
 27 permanent protection of iwi kūpuna; and

 29 BE IT FURTHER RESOLVED that the collaborative working group
 30 is requested to submit a report of its findings and
 31 recommendations, including any proposed legislation, to the
 32 Legislature no later than twenty days prior to the convening of
 33 the Regular Session of 2026; and

 35 BE IT FURTHER RESOLVED that certified copies of this
 36 Resolution be transmitted to the Chairperson of the Board of
 37 Land and Natural Resources; Chairperson of the Board of Trustees
 38 of the Office of Hawaiian Affairs; Administrator of the
 39 Department of Land and Natural Resources' State Historic
 40 Preservation Division; Administrator of the Office of
 41 Conservation and Coastal Lands; and Mayors of the City and



- 1 County of Honolulu and County of Maui, County of Hawaii, and
- 2 County of Kauai.
