
A BILL FOR AN ACT

RELATING TO UNIVERSITY OF HAWAII CONFERENCE CENTER REVOLVING
FUND.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 304A, Hawaii Revised Statutes, is
2 amended by adding to subpart D of part V, a new section to be
3 appropriately designated and to read as follows:

4 "§304A- University of Hawaii conference center revolving

5 fund. (a) There is established the university of Hawaii

6 conference center revolving fund for conference center programs

7 conducted by the university. The university may establish and

8 collect fees and charges for the costs of providing these

9 services. All fees, charges, and other moneys collected in

10 conjunction with the conference center programs of the

11 university shall be deposited in separate accounts within the

12 revolving fund. The university may establish accounts under the

13 university of Hawaii conference center revolving fund to

14 facilitate the administration of this fund among the various

15 campuses and operating units of the university of Hawaii system.

16 The university is authorized to expend funds from the



1 appropriate account in the revolving fund for all costs
2 associated with conducting conferences, seminars, and courses
3 provided by the conference center programs, including but not
4 limited to expenses for honoraria, hotel and room rentals, food
5 and refreshment, printing and mailing, airfare and per diem,
6 lei, rental of audiovisual equipment, and other conference
7 related services, fees, supplies and materials, without regard
8 to section 103D-1002 and any competitive bidding requirements
9 pursuant to state procurement requirements.

10 (b) The university shall prepare an annual report to the
11 legislature accounting for all income and expenditures of each
12 separate account within the revolving fund."

13 SECTION 2. Section 304A-2272, Hawaii Revised Statutes, is
14 repealed.

14 SECTION 3. Section 304A-2273, Hawaii Revised Statutes, is
15 repealed.

16 SECTION 4. On July 1, 2025, all appropriations and
17 encumbrances in the conference center revolving fund, university
18 of Hawaii at Hilo, and in the community college conference
19 center revolving fund shall be transferred to the university of
20 Hawaii conference center revolving fund.



1 SECTION 5. There is appropriated out of the general
2 revenues of the State of Hawaii the sum of \$ or so
3 much thereof as may be necessary for fiscal year 2025-2026 and
4 the same sum or so much thereof as may be necessary for fiscal
5 year 2026-2027 for conference center programs among various
6 campuses and operating units of the university of Hawaii system.

7 The sums appropriated shall be expended by the university
8 of Hawaii for the purposes of this Act.

9 SECTION 6. Statutory material to be repealed is bracketed
10 and stricken. New statutory material is underscored.

11 SECTION 7. This Act shall take effect on July 31, 2050.

Establishes the University of Hawaii Conference Center Revolving Fund and accounts under the fund to facilitate the administration of the revolving fund for conference center programs among various campuses and operating units of the University of Hawaii system. Repeals the Conference Center Revolving Fund, University of Hawaii at Hilo, and the Community College Conference Center Revolving Fund. Transfers all appropriations and encumbrances of the Conference Center Revolving Fund, University of Hawaii at Hilo, and the Community College Conference Center Revolving Fund to the University of Hawaii Conference Center Revolving Fund. Effective 7/31/2050.
