
A BILL FOR AN ACT

RELATING TO FITNESS TO PROCEED.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. (a) The following shall be required for
2 buildings constructed after December 31, 2025. The department
3 of corrections and rehabilitation shall establish a five-year
4 fitness to proceed pilot program to help reduce overcrowding at
5 the Hawaii state hospital and ensure the safety of the
6 hospital's staff and personnel while an inmate is awaiting a
7 determination on the inmate's fitness to proceed pursuant to
8 chapter 704, Hawaii Revised Statutes.

9 (b) For purposes of the pilot program, the department of
10 corrections and rehabilitation shall reserve at least one cell
11 or personal living space to accommodate every two inmates who
12 have filed a motion or cited a defense pursuant to chapter 704,
13 Hawaii Revised Statutes.

14 (c) An inmate housed in a reserved cell or living space
15 shall be in the joint custody of the department of corrections
16 and rehabilitation and department of health until a



1 determination is made regarding the inmate's fitness to proceed
2 pursuant to chapter 704, Hawaii Revised Statutes.

3 For the purposes of this subsection, "joint custody" means
4 the department of corrections and rehabilitation having primary
5 physical custody of an inmate and the department of health
6 having responsibility for the mental health services and
7 medications of the inmate.

8 (d) The department of corrections and rehabilitation shall
9 submit an interim report to the legislature on the status of the
10 pilot program no later than twenty days prior to the convening
11 of the regular session of 2027 and a final report of its
12 findings and recommendations, including any proposed
13 legislation, no later than twenty days prior to the convening of
14 the regular session of 2030.

15 SECTION 2. There is appropriated out of the general
16 revenues of the State of Hawaii the sum of \$ or so much
17 thereof as may be necessary for fiscal year 2025-2026 and the
18 same sum or so much thereof as may be necessary for fiscal year
19 2026-2027 for the establishment and implementation of the
20 fitness to proceed pilot program.



1 The sums appropriated shall be expended by the department
2 of corrections and rehabilitation for the purposes of this Act.
3 SECTION 3. This Act shall take effect on July 1, 2077.
