SENATE CONCURRENT RESOLUTION

REQUESTING THE COUNTY OF MAUI TO FULFILL ITS AGREEMENT WITH THE STATE AND RESOLVE LONGSTANDING JURISDICTIONAL AMBIGUITIES BY COMPLETING THE TRANSFER OF THE HUI ROADS, INCLUDING HUI ROAD F, FROM THE JUDICIARY.

1 WHEREAS, the State and County of Maui have previously
2 entered into an agreement to transfer ownership and jurisdiction
3 of certain roads, including the Hui Roads, from the Judiciary to
4 the County of Maui; and

5
6 WHEREAS, the Hui Roads, including Hui Road F in West Maui,
7 are among many "roads in limbo" whose ownership and maintenance
8 responsibilities have been subjects of prolonged ambiguity and
9 dispute between state and county agencies; and

11 WHEREAS, this jurisdictional uncertainty has led to the
12 significant neglect of these roads, resulting in deteriorating
13 conditions that pose safety hazards to residents, impede
14 emergency response efforts, and affect overall quality of life
15 in the community; and

16
17 WHEREAS, the community of West Maui, including residents
18 along Hui Road F, has repeatedly expressed concerns over the
19 lack of maintenance and clarity regarding responsibility for
20 these roads, requesting governmental action to resolve these
21 issues; and

23 WHEREAS, the Judiciary has regularly communicated with the
24 County of Maui and has taken steps to complete the conveyance of
25 the Hui Roads to the County, including the preparation of a
26 quitclaim; and

28 WHEREAS, in spite of the Judiciary's efforts, the County of
29 Maui has not yet assumed ownership of the Hui Roads; and

1 WHEREAS, the County of Maui has previously acknowledged the
2 necessity of accepting and maintaining these roads to ensure
3 public safety and infrastructure reliability; now, therefore,
4

5 BE IT RESOLVED by the Senate of the Thirty-third
6 Legislature of the State of Hawaii, Regular Session of 2025, the
7 House of Representatives concurring, that the County of Maui is
8 requested to fulfill its agreement with the State and resolve
9 longstanding jurisdictional ambiguities by completing the
10 transfer of the Hui Roads, including Hui Road F, from the
11 Judiciary to the County of Maui; and

13 BE IT FURTHER RESOLVED that the County of Maui is strongly
14 encouraged to allocate appropriate funding and resources for the
15 immediate repair and ongoing maintenance of these roads to
16 address safety concerns and improve accessibility for all
17 residents and visitors; and

19 BE IT FURTHER RESOLVED that certified copies of this
20 Concurrent Resolution be transmitted to the Administrative
21 Director of the Courts, Mayor of the County of Maui, Chair of
22 the Maui County Council, and Director of Transportation of the
23 County of Maui.
