SENATE CONCURRENT RESOLUTION

REQUESTING THE UNITED STATES TRANSPORTATION SECRETARY SEAN P.
DUFFY TO INITIATE A PERFORMANCE REVIEW OF THE HONOLULU RAIL
TRANSIT PROJECT.

1 WHEREAS, the Rail Project is the most expensive publicly
2 funded project in the State of Hawaii, and due to its use of
3 city, state and federal funding it is the Legislature's belief
4 that a performance review under the 2024 Amended Full Funding
5 Grant Agreement ("Amended FFGA") to determine whether
6 satisfactory progress is being made to complete the Rail Project
7 should be initiated by the United States Transportation
8 Secretary Sean P. Duffy and the FTA; and

9
10 WHEREAS, Sections 17-101 and 17-103.1 of the Revised
11 Charter of Honolulu 1973 (Amended 2017 Edition) establish the
12 Honolulu Authority for Rapid Transportation ("HART"), which has
13 the authority to develop the City's fixed guideway system, known
14 as the Honolulu Rail Transit Project ("Rail Project" or
15 "Project"); and

16
17 WHEREAS, ballot measures in 2008 and 2010 presented to and
18 approved by the fully registered voters of the City and County
19 of Honolulu ("City") approved the establishment of a public
20 transit authority (now known as "HART") with the responsibility
21 to establish the rail transit system; and

22
23 WHEREAS, on February 22, 2011, the City broke ground in
24 East Kapolei near the site of the 1st of 21 stations for the 20-
25 mile rail route with an expected price of \$5.5 billion; and

26
27 WHEREAS, in 2012, the City and the Federal Transit
28 Administration ("FTA") entered into a Full Funding Grant
29 Agreement for the Rail Project providing federal grant funding
30 to the City in the amount of \$1.55 billion, with the City
31 pledging to complete the system for public use by 2020 at a
32 total cost of \$5.2 billion; and

2 WHEREAS, since breaking ground in 2011, the embattled Rail
3 Project has faced massive cost overruns, huge delays, and
4 multiple lawsuits which put the current timeline for finishing
5 the Project in 2030, with an estimated cost of \$12.45 billion;
6 and

8 WHEREAS, the State of Hawaii has twice now passed
9 legislation to bailout the plagued Rail Project by providing
10 additional funding of \$1.5 billion in 2015 and \$2.4 billion in
11 2017 through a general excise tax surcharge that is set to
12 expire in 2030; and

13
14 WHEREAS, in 2019 the Honolulu City Council approved
15 Resolution 19-29, FD2 which supported the Office of the City
16 Auditor initiating an independent forensic audit of HART, but
17 plans were set aside in 2020 due to the global pandemic; and

18
19 WHEREAS, in 2024 the City and the FTA signed an Amended
20 FFGA with a stated purpose that included defining milestones of
21 when the federal government would release remaining funds and
22 facilitating a timely and efficient management of the Rail
23 Project; and

24
25 WHEREAS, Sections 15 and 19 of the Amended FFGA provide for
26 Project Management Oversight through Hill International Inc., a
27 consultant that monitors the rail project for the FTA, and
28 governmental authority to review HART's performance and
29 determine whether satisfactory progress is being made to
30 complete the rail project; and

31
32 WHEREAS, as late as 2024 it was reported that Hill
33 International Inc. repeatedly flagged the Rail Project for
34 problems it faced filling vacancies in critical positions; and

35
36 WHEREAS, to date, HART has received just over \$1.1 billion
37 in federal funding with another \$364 million expected as more
38 Project milestones are met; and

40 WHEREAS, on February 20, 2025, the United States
41 Transportation Secretary Sean P. Duffy announced that the
42 Federal Railroad Administration initiated a compliance review of



1 the federal grants for the battered California High-Speed Rail
2 Project which faces significant funding shortfalls and extreme
3 delays similar to the Honolulu Rail Project; now, therefore,
4

5 BE IT RESOLVED by the Senate of the Thirty-third
6 Legislature of the State of Hawaii, Regular Session of 2025, the
7 House of Representatives concurring, respectfully requests the
8 United States Secretary Sean P. Duffy and the FTA initiate a
9 performance review under the Amended FFGA to determine whether
10 satisfactory progress is being made to complete the Rail
11 Project; and

13 BE IT FURTHER RESOLVED that certified copies of this
14 Concurrent Resolution be transmitted to United States Secretary
15 of Transportation Sean P. Duffy, the Federal Transit
16 Administration, Hill International Inc., consultant and Project
17 Management Oversight for the Rail Project, and the Executive
18 Director and Chair of the Board of the Honolulu Authority for
19 Rapid Transit.
