SENATE CONCURRENT RESOLUTION

REQUESTING THE ESTABLISHMENT OF AN INTERGOVERNMENTAL TASK FORCE
TO ERADICATE ILLEGAL GAMBLING AND DRUG ACTIVITIES AND TO
ESTABLISH COMMUNITY SAFE ZONES.

1 WHEREAS, the Legislature acknowledges the harmful effects
2 of illegal gambling and drug activities in communities across
3 the State, including an increase in other criminal activities,
4 such as crimes of violence and sex trafficking; and
5

6 WHEREAS, addressing these criminal activities individually
7 and separately is not the most effective means to deter and
8 eradicate these activities; and
9

10 WHEREAS, a more effective approach involves a collaborative
11 effort among federal, state, and county agencies to examine
12 relevant issues, determine the resources needed to address these
13 issues, and devise a coordinated action plan; now, therefore,
14

15 BE IT RESOLVED by the Senate of the Thirty-third
16 Legislature of the State of Hawaii, Regular Session of 2025, the
17 House of Representatives concurring, that the Department of the
18 Attorney General is requested to establish a special
19 intergovernmental task force to eradicate illegal gambling and
20 drug activities; and

22 BE IT FURTHER RESOLVED that the task force consist of the
23 following members:
24

- 25 (1) The Attorney General or the Attorney General's
26 designee, who is requested to serve as the chair;
27
- 28 (2) The Director of Law Enforcement or the Director's
29 designee;

- 31 (3) The Director of Transportation or the Director's
32 designee;

(4) The respective Chiefs of Police of the Counties of Hawaii, Maui, and Kauai and of the City and County of Honolulu, or their designees;

(5) The respective Directors of the planning or permitting agencies of the Counties of Hawaii, Maui, and Kauai and of the City and County of Honolulu, or their designees;

(6) A representative from the office of the United States Attorney, District of Hawaii; provided that, if participating, the representative is requested to be invited to serve as vice chair of the task force; provided further that the Attorney General is requested to designate another task force member to serve as vice chair if necessary;

(7) A representative from the United States Department of Homeland Security;

(8) A representative from the United States Drug Enforcement Agency;

(9) A representative from the Federal Bureau of Investigation; and

(10) A representative from any governmental or private entity deemed relevant by the chair of the task force; and

BE IT FURTHER RESOLVED that the task force is requested to dedicate itself to the eradication of illegal gambling and drug activities in the State; and

BE IT FURTHER RESOLVED that the task force is requested to engage in an organized, collaborative effort to examine relevant issues, determine the resources needed to address these issues, and devise a coordinated action plan; and

1 BE IT FURTHER RESOLVED that the task force is requested to
2 consider the necessary resources and legislative actions that
3 may be necessary to establish the following:
4

- 5 (1) A statewide program under the Department of the
6 Attorney General to identify and eliminate illegal
7 gambling houses and drug houses; and
8
- 9 (2) Community safe zones throughout the State for the
10 purpose of enforcing zoning and other restrictions on
11 lands that may be used for gambling activities,
12 including casino gaming, regardless of whether the
13 activities are legal or illegal; provided that the
14 task force is requested to endeavor to establish, at a
15 minimum, a requirement that lands that may be used for
16 any type of gambling activity, and any structure
17 thereupon, be situated more than ten thousand feet
18 from any church, school, or residential area; provided
19 further that the task force is requested to also
20 endeavor to establish an appropriate enforcement
21 mechanism for this requirement; and
22

23 BE IT FURTHER RESOLVED that the chair and vice chair of the
24 task force are requested to oversee the activities of the task
25 force and lead the decision making of the task force members;
26 and

28 BE IT FURTHER RESOLVED that no member of the task force be
29 considered an employee for the purposes of chapter 84, Hawaii
30 Revised Statutes, based solely upon that member's participation
31 in the task force; and

33 BE IT FURTHER RESOLVED that the task force is requested to
34 submit a report of its findings and recommendations, including
35 any proposed legislation, to the Legislature no later than
36 twenty days prior to the convening of the Regular Session of
37 2026; and

39 BE IT FURTHER RESOLVED that the task force be dissolved
40 upon adjournment sine die of the Regular Session of 2026; and

6 of Honolulu; the respective Directors of the planning or
7 permitting agencies of the Counties of Hawaii, Maui, and Kauai
8 and of the City and County of Honolulu; the United States
9 Attorney, District of Hawaii; the United States Department of
10 Homeland Security; the United States Drug Enforcement Agency;
11 and the Federal Bureau of Investigation.
