
SENATE RESOLUTION

REQUESTING THE OFFICE OF HAWAIIAN AFFAIRS TO ESTABLISH AND PROVIDE LEGISLATIVE ENGAGEMENT FORUMS TO EDUCATE AND EMPOWER THE NATIVE HAWAIIAN COMMUNITY REGARDING THE LEGISLATIVE PROCESS.

1 WHEREAS, this body finds that the duties of the Office of
2 Hawaiian Affairs include:

- 4 (1) Advancing the betterment of conditions of Native
5 Hawaiians;

 - 7 (2) Assessing the policies and practices of other agencies
8 impacting Native Hawaiians;

 - 10 (3) Conducting advocacy efforts for Native Hawaiians; and

 - 12 (4) Serving as the principal public agency in the State
13 responsible for the performance, development, and
14 coordination of programs and activities relating to
15 Native Hawaiians; and

17 WHEREAS, the legislative process plays a crucial role in
18 shaping policies and laws that directly impact the Native
19 Hawaiian community; and

21 WHEREAS, increasing resources and information on the
22 legislative process available to the Native Hawaiian community
23 will increase community engagement; and

25 WHEREAS, increasing civic engagement and understanding of
26 the legislative process empowers Native Hawaiians to advocate
27 for their interests effectively; and

29 WHEREAS, the Office of Hawaiian Affairs serves as a vital
30 institution dedicated to improving the well-being of Native
31 Hawaiians through advocacy, research, and community support; and

1 WHEREAS, the Office of Hawaiian Affairs has the resources
2 and capacity to facilitate educational initiatives that promote
3 greater awareness and participation in the legislative process;

6 WHEREAS, legislative engagement forums will provide
7 valuable opportunities for Native Hawaiians to learn about bill
8 drafting, testimony submission, committee hearings, and other
9 aspects of civic engagement; and

11 WHEREAS, legislative engagement forums may be conducted
12 through in-person workshops, virtual seminars, and outreach
13 efforts in various communities across the State; now, therefore,
14

15 BE IT RESOLVED by the Senate of the Thirty-third
16 Legislature of the State of Hawaii, Regular Session of 2025,
17 that the Office of Hawaiian Affairs is requested to establish
18 and provide legislative engagement forums to educate and empower
19 the Native Hawaiian community regarding the legislative process;
20 and

22 BE IT FURTHER RESOLVED that the Office of Hawaiian Affairs
23 is encouraged to collaborate with community organizations,
24 educational institutions, and legislative bodies to ensure the
25 accessibility and effectiveness of these forums; and

27 BE IT FURTHER RESOLVED that these legislative engagement
28 forums should include educational materials, workshops, and
29 mentorship opportunities that enable Native Hawaiians to
30 effectively navigate the legislative process; and

32 BE IT FURTHER RESOLVED that the Office of Hawaiian Affairs
33 is urged to provide an annual report to the Legislature
34 summarizing the activities, participation, and impact of these
35 forums, as well as recommendations for further improvement; and

37 BE IT FURTHER RESOLVED that the Office of Hawaiian Affairs
38 is requested to provide an annual report to the Legislature
39 concerning its activities, as it pertains to educational and
40 communal engagement opportunities regarding legislative
41 processes; and

1 BE IT FURTHER RESOLVED that the Office of Hawaiian Affairs
2 is urged to consider establishing an advisory group composed of
3 Native Hawaiian leaders, educators, and policy experts to guide
4 and enhance the effectiveness of these efforts; and

6 BE IT FURTHER RESOLVED that certified copies of this
7 Resolution be transmitted to the Chairperson of the Board of
8 Trustees of the Office of Hawaiian Affairs and Chief Executive
9 Officer of the Office of Hawaiian Affairs.
