begs leave to report as follows:


The purpose of this measure is to:

- (1) Repeal the requirement that a public or private entity that provides a parking space for persons with disabilities comply with laws governing parking for disabled persons, including any penalties; and
- (2) Authorize each county to adopt ordinances to enforce the accessible parking space requirements for parking spaces reserved for persons with disabilities and electric vehicles.

Your Committee received testimony in support of this measure from the Disability and Communication Access Board; one member of the Maui County Council; Oahu Metropolitan Planning Organization; and four individuals. Your Committee received testimony in opposition to this measure from the Retail Merchants of Hawaii and one individual.
