"A BILL FOR AN ACT RELATING TO INSURANCE PROCEEDS,"

The purpose of this measure is to specify procedures regarding the disbursement of insurance proceeds by a mortgage servicer to a borrower for residential real estate that has been damaged or destroyed.

Your Committee received testimony in opposition to this measure from the Mortgage Bankers Association of Hawaii and Hawaii Financial Services Association. Your Committee received comments on this measure from the Department of Commerce and Consumer Affairs; Lāhainā Strong; Native Hawaiian Legal Corporation; and Hawaii Credit Union League.
