Madame:

Your Committee on Finance, to which was referred S.B. No. 224, S.D. 1, H.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO IDENTIFICATION,"

begs leave to report as follows:

The purpose of this measure is to require the Department of Corrections and Rehabilitation to:

- (1) In collaboration with various agencies and upon request of the inmates, assist inmates in obtaining their civil identification card, birth certificate, social security card, and other relevant identification necessary for successful reentry into society, as soon as practicable, but no later than one year before the inmate's parole or release date; and
- (2) Initiate the process of obtaining identification documents for inmates released to work furlough, extended furlough, or community placement programs, by providing the forms necessary for the inmate to obtain civil identification cards and other identification documents to the inmate as soon as practicable, but no later than ninety days before the inmate's release date.
