Your Committee on Agriculture and Environment, to which was referred S.C.R. No. 139 entitled:

"SENATE CONCURRENT RESOLUTION REQUESTING THE DEPARTMENT OF AGRICULTURE TO DESIGNATE KUNIA, LEILEHUA PLATEAU, AND POAMOHO AS THE CENTRAL OAHU AGRICULTURAL CORRIDOR AND TO ESTABLISH A LIST PRIORITIZING POTENTIAL AGRICULTURAL INFRASTRUCTURE IMPROVEMENT PROJECTS THAT WOULD PROVIDE THE MOST VALUE TO THE STATE, "

begs leave to report as follows:

The purpose and intent of this measure is to:

- Request the Department of Agriculture to designate Kunia, Leilehua Plateau, and Poamoho as the Central Oahu Agricultural Corridor;
- (2) Request the Department of Transportation to plan, design, and implement certain traffic signage;
- (3) Request the Department of Agriculture to establish a list prioritizing potential agricultural infrastructure improvement projects that would provide the most value to the State; and
- (4) Request the Department of Agriculture to submit a report to the Legislature prior to the Regular Session of 2026.
