Serve as the Program Administrator for the University of Hawaii Surgical Residency Program, Orthopaedic Residency Program and the Surgical Critical Care Fellowship.

Position Responsibilities Included:

Provision of oversight and management of residency/fellowship program functions according to requirements of the Accreditation Council for Graduate Medical Education (ACGME). Maintain working knowledge of program-specific and institutional (JABSOM) requirements and collaborate with residency/fellowship Program Directors to ensure that programs attain and remain in an accredited status (meeting all ACGME requirements for surgical/orthopaedics and surgical critical care specialty training of residents and fellows). Oversee and manage program administrative staff in the implementation of duties related to resident recruitment, curriculum and education, clinical training,

scholarly activity and human resources matters including but not limited to ongoing evaluation of competence of residents in training. On behalf of and with oversight by Program Directors, monitor individual and specific resident training required for successful navigation of residency training leading to medical specialty board certification. Domains of residency training are patient care and procedural skills, medical knowledge, professionalism, interpersonal and communications, systems-based practice and practice-based learning and improvement.

Serve as the Media Services/Information Technology manager for Hawaii Residency Programs, Inc. (HRP) and select clinical departments (Internal Medicine, Psychiatry, Surgery and Orthopaedic Surgery) of the John A. Burns School of Medicine.
