<u>HB1171</u>	RELATING TO THE UNIVERSITY OF HAWAII RELIEF FUNDING. Amends the University of Hawaii Tuition and Fees Special Fund by allowing the Board of Regents to dedicate funding for student aid in direct response to an emergency or disaster, as declared by the governor.	HED, FIN
<u>HB1172</u>	RELATING TO DEPARTMENTAL DATA SHARING. Adds the Department of Taxation to the list of state agencies sharing data through the statewide longitudinal data system. Allows the Department of Taxation to provide the University of Hawaii and other state agencies certain wage data.	HED, LAB, FIN
<u>HB1173</u>	RELATING TO TAX LIENS. Requires the Department of Taxation to: (1) State the assessment date on certificates of tax lien; and (2) Issue certificates of discharge when the tax liability on which a lien is based has become unenforceable by lapse of time.	FIN

HB1175	RELATING TO THE PROCEDURE FOR TAX APPEALS. Removes language specifying that an appeal from the Tax Appeal Court be filed with the Tax Appeal Court. Allows an appeal from the Tax Appeal Court to be filed within thirty days of entry of a final judgment.	JHA
HB1176	RELATING TO THE HAWAII TECHNOLOGY DEVELOPMENT CORPORATION. Establishes the Hawaii Economic Diversification Grant Program under the Hawaii Technology Development Corporation to provide grants to qualified high technology businesses engaging in qualified research activities. HB1177	RELATING TO TRANSPORTATION. Requires the Department of Transportation to establish and implement a five-year Interisland Transportation Fee Reimbursement Pilot Program, to be funded by revenues received from the rental motor vehicle surcharge. Extends the increase of the rental motor vehicle surcharge by \$0.50 each year from 12/31/2027 to 12/31/2031. Appropriates funds.	TRN, FIN

<u>HB1181</u>	RELATING TO COASTAL ZONE MANAGEMENT. Narrows the scope of the definition of the term "development" in coastal zone management law by excluding reconstruction of certain lawfully constructed structures impacted by certain events.	WAL, JHA
<u>HB1182</u>	RELATING TO RENEWABLE ENERGY. Grants the Public Utilities Commission the ability to authorize preferential rates for the purchase of renewable energy from facilities that meet certain prevailing wage requirements. <u>HB1183</u>	RELATING TO ALLOWANCE ON SERVICE RETIREMENTS. Includes certain law enforcement administrators and employees of the Department of Law Enforcement as class A members of the pension and retirement systems and provides guidance for the computation of retirement benefits similar to police officers. <u>HB1184</u>	RELATING TO CONTROLLED-ENVIRONMENT AGRICULTURE. Authorizes the issuance of general obligation bonds and appropriates funds for the development of a controlled-environment agriculture research and demonstration facility at the Magoon research and teaching site in Manoa, Oahu.	HED, FIN
<u>HB1185</u>	RELATING TO AGRICULTURE. Establishes a Plant-based Building Materials Working Group to study and report on how best to grow plants and develop plant-based building materials in Hawaii. Appropriates funds.	HED, FIN

Grants prescriptive authority to licensed midwives practicing as certified midwives and amends the list of approved legend drugs that may be administered. <u>HB1226</u>	<p>RELATING TO TRANSPORTATION.</p> <p>Categorizes electric bicycles into three classes based on speed and operation. Requires electric bicycle manufacturers and distributors to apply a label to each electric bicycle. Authorizes county police to confiscate bicycles for certain offenses. Increases penalty fee paid upon redemption. Imposes a requirement that counties inform individuals of the applicable traffic code, safety information, and penalties for violations at the time of registering a bicycle.</p>	TRN, CPC, JHA
<u>HB1227</u>	<p>RELATING TO FAMILY LEAVE.</p> <p>Establishes a paid family leave program for state and county employees. <u>HB1229</u>	<p>RELATING TO FOSTER CARE.</p> <p>Prohibits the Department of Human Services from using any social security income payments, including supplemental income payments it receives on behalf of a child under foster custody of the Department to cover the cost of foster care services. Requires the Department of Human Services to deposit all social security income payments received on behalf of a child under foster custody of the Department into a savings account that shall be made accessible to the child when the child leaves foster care custody.</p>	HSH, FIN
<u>HB1230</u>	<p>RELATING TO UNDERGROUND STORAGE TANKS.</p> <p>Clarifies the level of environmental restoration that owners and operators of underground storage tanks or tank systems must satisfy in the event of a confirmed release of jet fuel. Specifies the restoration condition and quality acceptable by the Department of Health shall include the complete removal of all jet fuel, including jet fuel additives and all compounds resulting from the degradation of jet fuel or jet fuel additives, or the reaction of jet fuel or jet fuel additives with water or other chemicals. Establishes a rebuttable presumption that any detection of these contaminants in the vicinity of an underground storage tank or a tank system after a confirmed release is a result of the confirmed release.</p>	EEP, WAL, JHA

No later than 9/1/2025, requires hospitals to create hospital registered nurse staffing committees. Beginning 7/1/2026, requires hospitals to implement registered nurse staffing plans. <u>HB1245</u>	<p>RELATING TO ADAPTATION PATHWAYS PLANNING.</p> <p>Expands the authority of the State and counties to develop adaptation pathways plans to modify and relocate infrastructure away from critically threatened areas to locations outside sea level rise and coastal flooding exposure areas. <u>HB1246</u>	<p>RELATING TO CANNABIS.</p> <p>Establishes the Hawaii Cannabis and Hemp Office within the Department of Commerce and Consumer Affairs to regulate all aspects of the cannabis plant. Beginning 1/1/2026, legalizes the personal adult use of cannabis. Establishes taxes on the retail sale of adult-use cannabis and the sale of medical cannabis. Adds new traffic offenses relating to the consumption or possession of marijuana or marijuana concentrate. Makes conforming amendments related to the legalization of personal adult use of cannabis. Beginning 1/1/2026, decriminalizes certain drug offenses related to marijuana and marijuana concentrate.
