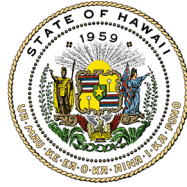

Aloha Chair Bellati, Vice-Chair Iwamoto, and Members of the Committee:

Thank you for the opportunity to submit a testimony to **OPPOSE** House Bill 883.

We **oppose** this legislation that mandates the Hawaii Emergency Management Agency to inventory all designated emergency shelters statewide. We understand the importance of having accurate and accessible information about emergency shelters. According to 127A-19, sheltering is a county mission. HIEMA will continue to coordinate with counties on the validation of their shelters. Mandating HIEMA to take on this responsibility could lead to unnecessary duplication of efforts and divert resources away from critical state-level initiatives.

We acknowledge the value of collaboration and coordination in emergency management. HIEMA plays a vital role in supporting county efforts with the retrofit program of shelters.

We urge the committee to consider the implications of this bill and to allow counties to maintain their critical role in shelter management while HIEMA supports them through coordination and resource sharing.

Thank you for considering our perspective on this important issue.

Bill Title: HB 0883 RELATING TO EMERGENCY MANAGEMENT.

Purpose of Bill: Requires the Hawaii emergency management agency to inventory all designated emergency shelters and their ability to withstand a category one hurricane or higher. Requires Hawaii emergency management agency to publish a publicly available list of shelters and their respective hurricane ratings. Appropriates funds for a hurricane shelter retrofit program and director.

Department's Position:

The Hawaii State Department of Education (Department) appreciates the opportunity to provide testimony on HB 883.

The Department agrees that Hawaii faces increasing risk of experiencing extreme weather events and only a few public buildings meet minimum requirements for hurricane shelters while demand for public evacuation shelter space is likely to exceed available inventory. The Department supports the Hawaii Emergency Management Agency in developing their program.

The Department would appreciate clarification of Section 4 (f) of the proposed bill as it references new language to Section 127A-19 of the Hawaii Revised Statutes by stating "and any public building constructed after January 2026 that meets the requirements of section 107-27(e)." There is no content in the Hawaii Revised Statutes for subsection (e).
