Chair Lee and members of the Committee, the State Foundation on Culture and the Arts (SFCA), is pleased to offer **COMMENTS** on S.B.1011 which **establishes the Hawaii leadership award program** to honor individuals who have made considerable and outstanding contributions to Hawaii and serve as inspirations to others.

The State Foundation on Culture and the Arts has a long history of recognizing outstanding individuals in Hawaii with awards. From 1970 to 2019, the SFCA issued 118 awards in the categories of State of Hawai`i Order of Distinction for Cultural Leadership, Governor's Award for Distinguished Achievement in Culture, Arts and Humanities, Hawai`i Award for Literature, Individual Artist Fellowships and the Hawaiian Architectural Award. Many of the awards included funding.

In 2009, State funding to the SFCA to support the staff coordinator position and the awards was abolished. In 2019, one-time special legislative funds were appropriated for the Individual Artist Fellowship awards. The 2019 funding enabled recognition of some of Hawaii's most accomplished and experienced teaching artists who were also known for their artistry.

In 2022, the State Legislature appropriated \$200,000 in Coronavirus State Fiscal Recovery Relief Funds to the SFCA for artist fellowships. In response, the SFCA developed a call for cultural fellowships, but put the project on hold when the bill was vetoed.

#### The SFCA makes the following recommendations in support of SB1011:

- Establish a position within the foundation to coordinate the Hawaii Leadership Awards Program.
- Follow the SFCA process identified in Chapter 9 HRS for creating selection panels based on area of expertise.
- Appropriate funding to award the recipients

Consistent support from the legislature including an appropriation of general funds and a designated position are necessary for a program such as S.B. 1011 proposes in support of the recognizing leadership in our community. When we celebrate Hawaii's achievements, we invest in the economic stability of Hawai`i.

Thank you for the opportunity to provide testimony on this measure.
