Chair Elefante and Members of the Committee:

The Department of the Attorney General (Department) provides the following comments.

The purpose of this bill is to require reporting by the Department of all reported possible hate crimes to appropriate authorities. The bill defines a "reported hate crime" to mean "any reported incident, regardless of whether it results in criminal charges, where there is evidence or indication that bias or prejudice may have been a motivating factor." It also requires training of law enforcement officers and agencies that have primary investigative, action or program responsibility for adult or juvenile offenses to ensure the consistent documentation and analysis of the reported incidents by the Department.

The Department has been working to transition the statistical crime reporting in the State of Hawaii from the Federal Bureau of Investigation's (FBI) nationwide Uniform Crime Reporting (UCR) program's traditional Summary Reporting System, which allows the State to collect limited data, to the National Incident-Based Reporting System (NIBRS) program, which is a more robust system that includes hate crime data and has the ability to collect and provide circumstances and context for crimes, such as location, time of day, and whether the reported incident was attempted or completed. The Department is dedicated to expanding and improving the State's UCR program's capacity to collect and report NIBRS data. Much of the recent and planned work is

focused on additional development of the state NIBRS data repository and statistical dashboards, as well as assisting and certifying local reporting law enforcement agencies for NIBRS. NIBRS includes "reported incidents" for all offense codes captured under NIBRS.

While the Department supports the intent of the bill, with the current ongoing transition to NIBRS, the requested hate crime data collection in this bill may not be necessary, as it would duplicate procedures already in place. The Department administers the State UCR/NIBRS program, and all four county police departments have been reporting FBI-style hate crime data to the Department using the FBI's NIBRS format. Additionally, the Department is developing a user-friendly, public dashboard that should be completed by September 30, 2025, and will provide more transparency and accessibility to hate crimes data. NIBRS hate crime reporting is expected to eventually supersede Hawaii's current prosecutor-level reporting program and is evolving to provide the most accurate and accessible hate crime data. In short, the Department has been and continues to take proactive steps in reporting accurate and comprehensive hate crime data.

Lastly, the Department is concerned regarding the proposed addition of section 846-53(b), HRS, on page 4, line 13-16, which mandates training for all law enforcement officers. Currently, NIBRS training is provided by the FBI several times per year in two-day online courses and is coordinated and documented by state UCR program staff. The training is open to all police personnel with key responsibilities for crime reporting, including support staff such as the records and information technology personnel who generate, review, revise, verify, and report NIBRS data. The FBI also coordinates with the state UCR program to audit the police department's crime reporting data and procedures on a tri-annual basis. Beyond that, each police department has unique capabilities, resources, needs, policies and procedures to address hate crime training for all officers. The Department does not believe that this bill provides the specificity or the potential funding needed to accomplish its purpose, and believes that current policies and procedures regarding hate crime training are sufficient at this time.

#### RE: S.B. 1149; RELATING TO HATE CRIMES.

Chair Elefante, Vice-Chair Wakai, and members of the Senate Committee on Public Safety and Military Affairs, the Department of the Prosecuting Attorney for the City and County of Honolulu submits the following testimony in **support** of S.B. 1149.

Hate crimes not only harm the victim, but also spread fear among everyone belonging to the targeted community. Hawai'i law currently provides extended sentencing for hate crime offenders. This requires proof that the defendant intentionally selected the victim or property based on hostility towards particular protected characteristics, such as race, religion, or gender. That often requires evidence of motive, which is not available in all cases. Thus, not all crimes motivated by bias can be prosecuted as hate crimes.

The Department supports efforts to obtain reliable data on the incidence of hate crimes in Hawai'i. We recommend adopting clear, consistent reporting standards to permit year-to-year comparisons and improve law enforcement strategies to combat hate crimes.

Aloha Chair Elefante, Vice-Chair Wakai and fellow committee members,

I am writing in strong support of Senate Bill 1149 on behalf of the Hawai'i State Lesbian, Gay, Bisexual, Transgender, Queer Plus. (LGBTQ+) Commission, which was established by the 2022 Hawai'i State Legislature with the following purpose:

"...to improve the State's interface with members of the lesbian, gay, bisexual, transgender, queer, plus community; identify the short- and long-range needs of its members; and ensure that there is an effective means of researching, planning, and advocating for the equity of this population in all aspects of state government."

SB 1149, establishes the definition for "reported hate crime" and requires reporting of all possible reported hate crimes to appropriate authorities, including consistent documentation and analysis of such incidents. Requires law enforcement officers to receive annual training to identify, investigate, and document hate crimes and possible hate crimes. Requires the Attorney General to establish or update guidelines, protocols, and training materials for the reporting and investigation of hate crimes and possible hate crimes.

Hate crimes are not just attacks on individuals; they are deliberate attempts to intimidate and divide entire communities. They send a chilling message meant to instill fear, erode trust, and marginalize already vulnerable groups. In Hawai'i, where diversity and inclusion are core values, we must take decisive action to protect racial, religious, sexual orientation, gender, gender identity and/or expression, and other protected classes from bias-motivated violence. Ensuring safety and justice requires more than just condemning these acts—it demands real accountability, transparency, and proactive solutions.

#### The Urgent Need for Comprehensive Hate Crime Data

Currently, hate crimes remain vastly underreported and under-documented in Hawai'i. This is often due to a lack of clear reporting protocols, insufficient law enforcement training, and the fear of retaliation experienced by victims. Without accurate, standardized data collection, the full scope of hate-motivated violence remains obscured, preventing an effective response and eroding public trust in our justice system.

#### HI State LGBTQ+ Commission Testimony in Strong Support of SB 1149

SB 1149 directly addresses these gaps by requiring the comprehensive collection, documentation, and analysis of all reported hate crimes—even when they do not result in criminal charges. This distinction is critical, as many acts of hate—such as threats, harassment, and vandalism—may not always lead to prosecution but nonetheless inflict deep and lasting harm on the targeted communities. Without data on these incidents, we cannot fully grasp the prevalence of hate-based violence, let alone combat it effectively.

#### **Building Public Trust Through Transparency and Accountability**

Transparency is a cornerstone of public trust. By mandating that law enforcement agencies report hate crime data to the Attorney General's Office and requiring annual training for officers, SB 1149 ensures that these crimes are not only tracked but also taken seriously. A well-trained law enforcement workforce will be better equipped to recognize, investigate, and address biasmotivated violence, ensuring that victims receive the support and justice they deserve.

Additionally, the bill's directive for the Attorney General to establish uniform guidelines within 90 days of enactment will create much-needed consistency across all law enforcement agencies. A standardized approach to hate crime documentation will reduce discrepancies, improve accuracy, and allow for a more comprehensive understanding of hate crimes in our state.

#### A Commitment to Safety, Justice, and Inclusion

By passing SB 1149, Hawai'i will make a clear and powerful statement: Hate has no place in our communities. We will not allow fear and division to take root. We will protect our most vulnerable residents, demand accountability, and uphold the principles of justice and equality for all who call these islands home.

On behalf of the Hawai'i State LGBTQ+ Commission, I urge this committee to support this critical legislation. The safety, dignity, and fundamental rights of our communities depend on it.

We are an officially recognized constituency group of the AFL-CIO that organizes mutual support between the organized Labor Movement and the LGBTQIA+ Community to further social and economic justice.

On behalf of Pride at Work - Hawai'i, I write in strong support of Senate Bill 1149, which seeks to strengthen Hawai'i's Hate Crime statute by introducing the definition of a "reported hate crime" and implementing vital measures to ensure transparency, accountability, and training regarding hate crimes in our state.

As an organization dedicated to advocating for LGBTQIA+ workers and their families, we recognize the devastating impact that hate crimes have on marginalized communities. Hate-motivated violence and intimidation not only harm individual victims but also instill fear across entire communities.

Unfortunately, many hate crimes go unreported or they are not accurately documented due to inconsistencies in reporting mechanisms and the lack of comprehensive training for law enforcement officers.

Hawai'i's Hate Crime statute, which was signed into law in 2001 by then Lt. Governor Mazie Hirono, has it that a crime in Hawai'i is only reported as a hate crime when the perpetrator is caught, then the case goes to trial, and finally the enhanced sentencing provision is used. If the culprit is never caught or the case is pleaded out then it is not reported as a hate crime. SB 1149 is a crucial step toward addressing these shortcomings and fostering a safer, more inclusive Hawai'i.

#### Specifically, SB 1149:

- Establishes a clear definition for "reported hate crime," ensuring that incidents perceived as motivated by bias are properly recognized and investigated.
- Requires law enforcement agencies to document and report all possible hate crimes to appropriate authorities for further analysis.
- Implements mandatory annual training for law enforcement officers to improve their ability to identify, investigate, and document hate crimes effectively.
- Directs the Attorney General to develop or update guidelines, protocols, and training materials to standardize hate crime reporting and investigation practices statewide.

These measures will provide a more accurate and comprehensive understanding of hate crimes in Hawai'i, allowing policymakers and community organizations to implement targeted interventions and resources for affected communities. Additionally, ensuring that law enforcement personnel are adequately

trained will promote greater trust between officers and the communities they serve, leading to increased reporting and better outcomes for victims.

Hate and discrimination have no place in Hawai'i, and we must take proactive steps to ensure that those targeted for their race, religion, sexual orientation, gender identity, or other protected characteristics receive the justice and protection they deserve. SB 1149 is a necessary and timely effort to uphold these principles.

According to **Department of Justice's own website**:

"Reporting suspected hate crimes is vital to support victims and send a clear message that such actions are unacceptable. Law enforcement can also use this information to prevent future incidents.

For these reasons, Pride at Work - Hawai'i urges the committee to pass SB 1149. Mahalo for your time and consideration of this important measure.

### SENATE BILL 1149, RELATING TO HATE CRIMES

FEBRUARY 3, 2025 · PSM HEARING

**POSITION:** Support.

**RATIONALE:** The Democratic Party of Hawai'i Education Caucus <u>supports</u> 1149, relating to hate crimes, which defines "reported hate crime"; requires reporting of all possible reported hate crimes to appropriate authorities, including consistent documentation and analysis of such incidents; requires law enforcement officers to receive annual training to identify, investigate, and document hate crimes and possible hate crimes; requires the Attorney General to establish or update guidelines, protocols, and training materials for the reporting and investigation of hate crimes and possible hate crimes.

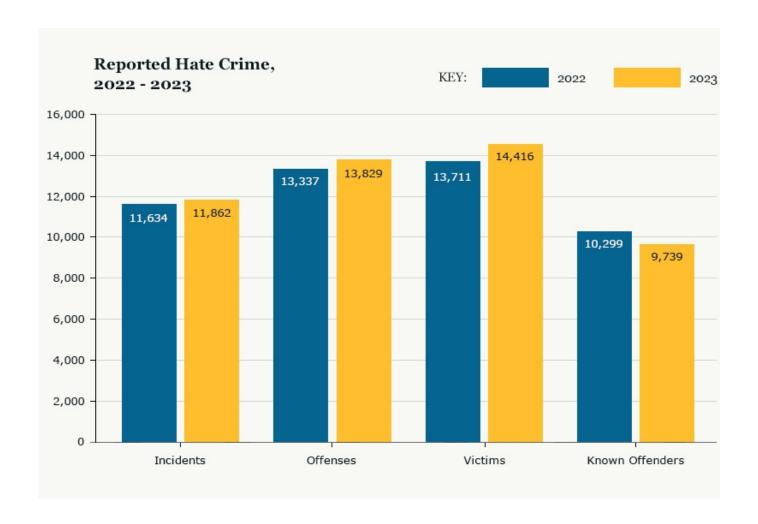
According to a 2018 report published by the data clearinghouse Statista, 64 percent of teenagers in the U.S. have encountered hate speech on social media. At the same time, incidents of political violence have been escalating. The Washington Post reported in 2021 that right-wing extremists have been involved in 267 plots or attacks in the U.S. since 2015, resulting in 91 fatalities.

Furthermore, over half of the deaths caused by right-wing confrontations were committed by people who voiced support for white supremacy. Many of those outbursts were organized virtually amidst the shadows of social media. Washington Post's investigation found that from 2015 to 2020, the use of websites and social media by right-wing extremists rose in five of the six years that the news outlet studied, leading Georgetown professor George Hoffman to call social media a "propellant" for the spread of violent extremism.

We have witnessed a resurgence in hate-related extremism in recent years, which has been spurred in part by the rise of Donald Trump to the presidency on a campaign of xenophobia, white supremacy, and fear. The Trump administration is currently attempting to roll back diversity, equity, and inclusion initiatives (DEI programs) across the country in an effort to undermine the advancement of racial justice in schools, colleges, businesses, and the public sector.

At the same time, Trump officials have issued multiple executive orders eliminating the rights of LGBTQ+ individuals, including orders banning transgender service members, moving transgender women back into men's prisons, denying passports with gender markers, defunding gender-affirming care for transgender youth, and blocking schools from requiring teachers and other school staff to use names and pronouns that align with transgender students' preferred gender identify rather than the sex they were assigned at birth.

Per data from the U.S. Department of Justice, hate crimes are rising throughout the nation. In 2023, the DOJ recorded 13,829 reported hate offenses involving 14,416 victims. Those numbers are up from 2022, which saw 13,337 reported incidents and 13,711 victims, an increase of roughly 500 offenses and 700 victims.



Hatred has no place in our society or on our shares. In an era in which extremism quickly goes viral, we must take steps to prevent hate crimes from spreading throughout our community.

Chair, Vice Chair, and Members of the Committee,

My name is Dr. Sandy Harjo Livingston, and I serve as a Commissioner on the Hawai'i State Commission on LGBTQ+ Affairs. I submit this testimony in strong support of S.B. 1149, which mandates the reporting and analysis of all possible hate crimes in Hawai'i. This bill represents a crucial step toward protecting vulnerable communities, increasing transparency, and ensuring that the public remains informed about the prevalence and nature of hate crimes in our state.

While hate crimes are often attacks on individuals, they are also attacks on entire communities with the intention of instilling fear and division amongst the people in our communities. In Hawai'i, where we pride ourselves on diversity and inclusion, it is essential that we take active steps to protect racial, religious, 2SLGBTQ+, and other minority groups from bias-motivated violence. Without comprehensive and transparent data collection, we neither can effectively combat these crimes nor can we reassure affected communities that their government takes their safety seriously.

Currently, hate crimes remain underreported and under-documented in our state; and this is often due to a lack of clear reporting protocols, insufficient training or fear of retaliation by victims. S.B. 1149 directly addresses this issue by requiring the collection, documentation and analysis of all reported hate crimes, even when they do not result in criminal charges. This is a necessary change because many incidents rooted in hate, like threats, harassment, and vandalism, may not always lead to prosecution but still have a profound impact on the communities that have been targeted.

Furthermore, transparency is key to fostering public trust and ensuring accountability. By requiring law enforcement agencies to report hate crime data to the Attorney General's Office and mandating annual law enforcement training, this bill ensures that incidents are consistently tracked and investigated and that officers are well-equipped to recognize and address bias-motivated violence. The public must have access to clear, reliable data on the frequency and nature of hate crimes in Hawai'i. This empowers advocacy groups, policymakers, and community organizations to respond with targeted solutions that include improved victim support services and community education initiatives.

Additionally, the bill's requirement that the Attorney General establish uniform guidelines and protocols within 90 days of enactment will help ensure that reporting remains consistent across all law enforcement agencies. A standardized approach to hate crime documentation will reduce discrepancies, improve accuracy, and allow for a more comprehensive understanding of hate crimes in Hawai'i.

By passing S.B. 1149, Hawai'i can send a powerful message: We will not allow hate to fester in our communities. We will protect our vulnerable populations. We will demand accountability and transparency in addressing these crimes.

I urge this committee to support this critical legislation and take a stand for the safety, dignity, and rights of all who call Hawai'i home.

The increased focus on hate crime data collection and reporting could create an atmosphere of suspicion and distrust. It is essential to foster positive and cooperative relationships between law enforcement and communities to effectively address hate crimes and other public safety issues.
- 5. Ineffectiveness in Addressing Root Causes: While data collection and reporting are essential components of addressing hate crimes, SB1149 does not address the root causes of hate and bias. Efforts should be directed towards comprehensive education, community outreach, and prevention programs that promote understanding, tolerance, and respect for diversity. Merely collecting data without addressing underlying issues will not lead to meaningful change.

In conclusion, while the goal of addressing hate crimes is laudable, I believe that SB1149 is not the right approach. The bill's overreach, administrative burden, potential for misuse, impact on community relations, and lack of focus on root causes make it an ineffective and potentially harmful piece of legislation. I urge you to consider alternative measures that more effectively address hate crimes without compromising privacy, resources, and community trust.
