# RELATING TO A STATE BREAST MILK BANK

The Department of Budget and Finance (B&F) offers comments on this bill.

Senate Bill (S.B.) No. 1211: 1) establishes a State Breast Milk Bank (SBMB) under the Department of Health to accept and provide breast milk to assist parents and guardians in providing breast milk to their infant children; 2) establishes the SBMB Special Fund (SBMBSF); 3) appropriates an undetermined amount of general funds for FY 26 to be deposited into the SBMBSF; and 4) appropriates an undetermined amount of special funds out of the SBMBSF for FY 26 and FY 27 for the operation of the SBMB.

As a matter of general policy, B&F does not support the creation of any special fund, which does not meet the requirements of Section 37-52.3, HRS. Special funds should: 1) serve a need as demonstrated by the purpose, scope of work and an explanation why the program cannot be implemented successfully under the general fund appropriation process; 2) reflect a clear nexus between the benefits sought and charges made upon the users or beneficiaries or a clear link between the program and the sources of revenue; 3) provide an appropriate means of financing for the program or activity; and

4) demonstrate the capacity to be financially self-sustaining. Regarding S.B. No. 1211, it is difficult to determine whether the proposed SBMBSF will be self-sustaining.

My name is Lori Barrett and I am submitting testimony in **strong support** of [Bill Number], which seeks to establish a breast milk bank to provide safe, donated human milk to infants in need. This initiative is critical for ensuring that all babies have access to the healthiest start in life regardless of their mother's circumstances.

# The Health Benefits of Breast Milk

Breast milk is uniquely designed to meet the nutritional needs of infants, providing essential antibodies, enzymes, and hormones that support immune system development and overall health. According to the American Academy of Pediatrics (AAP) and the World Health Organization (WHO), human milk is the optimal source of nutrition for newborns. For preterm or medically fragile infants, donor breast milk has been shown to lower the risk of life-threatening conditions. This bill supports equitable nutrition for all infants, particularly those from underserved communities by ensuring access to safe, pasteurized donor milk.

## **Economic and Healthcare Savings**

Investing in a breast milk bank is a moral imperative and a **financially sound decision** for the state. Studies have shown that increased breastfeeding rates lead to **lower healthcare costs** by reducing the incidence of childhood illnesses such as respiratory infections, gastroenteritis, and diabetes. Access to donor milk can also reduce hospital stays for premature infants, **saving taxpayer dollars** in Medicaid and healthcare expenses.

## Conclusion

By passing [Bill Number], the legislature can **support families, improve infant health, and reduce long-term healthcare costs**. Establishing a breast milk bank ensures that all infants—regardless of their family's financial status or a mother's ability to breastfeed—can receive the nutrition they need for a strong, healthy start in life. I respectfully urge you to vote **strongly in support** of this bill.
